1) WELCOME

The meeting was opened and members were welcomed.

2) MINUTES AND MATTERS ARISING

Minutes from the Dublin City LCDC Meeting of the 23rd February 2022 were proposed by Lee Dillon and seconded by Paul Rogers. There were no matters arising.

3) LCDC BUSINESS MATTERS – VERBAL UPDATE

(a) LCDC Funding Schemes

i. Community Activities Fund (CAF) 2022

The Chief Officer (CO) provided an update on the Community Activities Fund. A total of 157 complete applications were received. An additional 64 draft and incomplete applications were also received. The total sum of funds available is €427,358. The CO advised that the CEP Sub-Committee will be convened to undertake the finalisation of the assessment process. A list of eligible applications that are recommended by the CEP Sub-Committee will be presented to the LCDC for approval at its June meeting. A shortlist of eligible applications, recommended for approval under any forthcoming second round of funding will also be drawn up and presented for approval.

Agreed Action:-

1) CEP Sub-committee meeting to take place on 24th May (TBC) and an update on the CAF fund will be given at the next LCDC meeting.

(b) DCC Sláintecare Healthy Communities Programme (SHCP)

i. Programme Update

The CO confirmed that four Local Development Officers (LDOs) have been recruited and all are due be appointed to their new positions by the end of June. While working as a team, each LDO will also be assigned to one of the four SHCP programme area. Their responsibilities include oversight for expenditure of approximately €250,000 per area under the SHCP Community Enhancement Fund. A key priority for the LDOs is to ensure there is no duplication or repetition of existing structures and programmes and instead to bring an emphasis on complementary and consolidating activities as well as developing new proposals for consideration and agreement by the DCC SHCP Implementation Team. The CO confirmed that LCDC members they will have a governance and oversight role of the SHCP and similarly over related Healthy Ireland Round 4 programme for Dublin city (forthcoming), the WHO Partnership for Healthy Cities (PHC) programme and all health related aspects of the DCC Age Friendly programme. To ensure this is effective, the LCDC sub-committee on health and wellbeing will be reconvened with an expression of interest for new members. A minimum of 5 members will be required and will include HSE and DCC staff as well as elected representatives from DCC. The CO suggested the committee be renamed LCDC Healthy Dublin Subcommittee.

Agreed Action:-

- 1) LCDC Healthy Dublin Subcommittee expression of interest to issue to all LCDC members
- 2) Update on membership and on overall governance and reporting structures will be provided at the next LCDC meeting.

(c) Age Friendly Dublin

- i. Programme Update: the CO informed members that Croke Park has been formally recognised as the first Age Friendly Stadium by the World Health Organisation, Global Network of Age Friendly Cities and Communities and Age Friendly Ireland. The members of LCDC noted with thanks the work of DCC AF staff in bringing this achievement forward.
- ii. The CO noted that a national recruitment campaign for new regional Age Friendly posts was underway and that a Dublin city specific post will be appointed in the coming months.

Agreed Action:

1) Update will be provided at the next LCDC meeting.

4) UKRAINE REFUGEE CRISIS - DCC COMMUNITY FORUM

The CO informed members that Dublin City Council has re-established a Community Forum to respond to the Ukraine Refugee crisis. The CO wanted members to be aware that the Community Forum is in place as they will have an update into it at a future date.

Agreed Action:

1) Any member who would like more information on the Community Forum or would like to share information should contact the CO directly. An update will be provided at the next LCDC meeting.

5) LECP ADVISORY GROUP AND LECP 2022 WORK PROGRAMME UPDATE

The CO gave a presentation on the work underway to date to review, revise and develop the new LECP for Dublin City and noted the following:

6) 'CLIMATE ACTIONS AND PROOFING FOR DUBLIN'S NEXT LECP'

Dr Sabrina Dekker, DCC Climate Action Co-ordinator gave a presentation that outlined how the DCC Climate Action Plan 2021 is relevant to the consideration of priority issues for inclusion in the forthcoming DCC Local Economic and Community Plan (LECP). LCDC members noted the significance of the challenge to undertake the actions required to prevent climate change and halt global warming and consequent environmental, social and economic disruption and destruction.
