
All applicants are advised that a connection to the surface water network will only be permitted when all the requirements of the Dublin city Council, including any conditions in a grant of planning permission, are fully complied with In particular, applicants should note the following:

It will be the responsibility of the applicant to carry out all works associated with the construction of this connection. These works must comply with all the requirements of both the Dublin city council


An inspector from Drainage Division will also visit the site to ensure the drainage work is being completed to the required standard. The cost of these visits will be charged to the developer.

Drainage Division require that the applicant lodge a sum of money as a surety to ensure successful completion of the works. This money – minus all supervision fees relating to the inspector's visits – will be refunded on successful completion of the work.

- 1. Connections to the public sewers will not be granted under any circumstances until the internal drainage layout has been constructed in accordance with the appropriate Planning Permission conditions and has been inspected and approved by Drainage Division's Planning and Development Control Inspector, who can be contacted in our Bannow Road Depot on 01-222 8510 / 222 8516
- 2. Two copies of <u>approved</u> detailed drainage drawing for the site, two copies of a site location map and one copy of a compliance letter/email from the Drainage Division approving the drainage drawings must be submitted with the completed application form.
- 3. Drainage layouts for developments that contain public sewers must be constructed in accordance with Drainage Division requirements as set out in "Greater Dublin regional Code of Practice for Development Works Drainage", which is available on our on our website www.dublincity.ie
- **4.** Payment by Bank draft or cash is preferable to payment by cheque, as all cheques must be cleared before the application can be processed. The applicant is reminded that any monies owing for the development, including any planning levies and special drainage levies, if applicable, must be paid before a connection can be granted.
- **5.** Only when the relevant drainage inspector has signed off on all the drainage works will a refund be authorised. Please Note: all refunds are now made by electronic fund transfer direct to bank accounts, no cheques are issued, a fully completed *EFT* form (attached) should be sent to the address shown as soon as it's convenient.
