Administrative/Biographical History	<p>Margaret Gowen & Co. Ltd., Rath House, Ferndale Road, Rathmichael, Co. Dublin, is a professional archaeological company founded in the early 1980s. The company has carried out numbers of archaeological excavations and development-led investigations arising from the requirements of development control and planning process, in line with legal provisions of the Planning and Development Acts (2000) and the National Monuments Acts (1930-2004) and Amendments Acts. The Fumbally Lane, Dublin 8 collection is one of many site archives that has been generated through this development-led excavations.</p> <p>The excavation on this site was undertake in compliance with condition 8 of the planning permission granted for the site on the 16th January 2002. The excavation was undertaken in two phases. The first phase consisting of the southern half of the site was carried out between the 11th January 2006 and the 27th March 2006. The excavation of the second phase was carried out between the 17th July 2006 and 16th October 2006. Prior to the full excavation of the site an archaeological test excavation was carried out by Georgina Scally in May 2000.</p> <p>The site is located between New Street and Blackpitts area of Dublin. While New Street is one of the oldest thoroughfares into Dublin, Fumbally Lane itself was not laid out in its current form until 1712 by Jacob Poole, a Dublin brewer with property interests in the Blackpitts area.</p> <p>This archaeological excavation sought to identify and record the principal phases of settlement, occupation and development at the site. The principal structures on the site were post-medieval in date (1700-1900).</p>
