APPLICATION FOR OLDER PERSONS HOUSING UNDER THE FINANCIAL CONTRIBUTION SCHEME.



The Financial Contribution Scheme was introduced by Dublin City Council some years ago in recognition of the fact that there are persons of 55 years and over living in the City, who find their existing dwellings too large for their needs and who wish to be considered for housing by Dublin City Council, as tenants, in Older Persons accommodation. The following conditions apply:-

- The applicants must offer their house for sale to the City Council in the first instance.
- The applicants must reside within the administrative area of Dublin City Council.
- Dublin City Council cannot purchase any house worth in excess of the price limit set out by the Department of the Environment and Local Government. An application will not be accepted from an applicant who the City Council considers is financially in a position to rehouse themselves from the proceeds of the sale of their house. Dublin City Council must ensure at all times that Older Persons on our Housing List, Transfer List or Homeless List are not disadvantaged by the Financial Contribution Scheme.
- All applicants being rehoused are required to pay a financial contribution on the following basis:

Age:

55 - 69 years
70 - 79 years
80 years & over

Financial Contribution:

1/3 of nett proceeds of sale
1/4 of nett proceeds of sale
1/5 of nett proceeds of sale



- If the City Council agrees to purchase your house you will be permitted to reside there until a suitable vacancy arises. If, for whatever reason, the City Council does not purchase your house and you wish to proceed with the Financial Contribution Scheme you should arrange to sell your house privately and contact this Section when the sale has been agreed. Please be advised that the City Council cannot guarantee your Older Persons accommodation being available before you have to vacate your house in the event of you selling it privately.

PLEASE READ THIS APPLICATION CAREFULLY:

I/We wish to apply for Older Persons accommodation from Dublin City Council. **I/We agree to offer my/our house for sale to Dublin City Council in the first instance** and if they are not interested in purchasing I/we understand I/we may sell it privately. If my/our house is sold I/we will then make the appropriate contribution of the nett proceeds of the sale to the City Council in return for rehousing as weekly tenants in Older Persons accommodation.

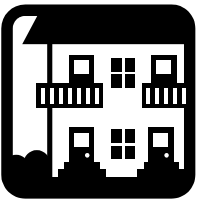
