#### NOTES

1. **Section 4(11) of the Casual Trading Act, 1995, provides that the local authority concerned shall notify the Minister for Social Welfare of the name and address of a person to whom a casual trading licence was granted and the conditions of the licence and Section 4(2A) of the Casual Trading Act, 1995 (inserted by Section 141 of the Finance Act, 1996(No.9 of 1996) provides that the local authority concerned shall notify the Revenue Commissioners of the name, address and tax reference number of a person to whom a casual trading licence was granted and the conditions of the licence. Section 13 of the Casual Trading Act, 1995 also provides that a local authority may establish and maintain the Register of Casual Trading Licences on computer. In such circumstances, personal data kept in the register is subject to the requirements of the Data Protection Act, 1988(No. 25 of 1988) including an individuals right of access to and verification of data, where appropriate.**
2. **A licence holder shall furnish to Dublin City Council the names, addresses and photographs of persons acting as their servant/agent.**
3. **Two photographs of the applicant and one photograph of the Servant/Agent are required. It will be necessary to submit photographs every two years.**

The purpose of these Regulations is to prescribe the form of application for a casual trading licence in accordance with Section 4 of the Casual Trading Act, 1995.
