Application No.: 2776/07

Applicant: Linders of Smithfield Ltd

Demolition of 1-6, Haymarket & 56-58 Smithfield including Smithfield Chambers (total gross floor of the buildings to be demolished c.5575sqm) and the construction of a new 9 storey mixed use building. The ground floor will accommodate an office entrance lobby together with commercial space (562sqm), 6 floors of office accommodation together with a two storey rooftop restaurant/bar (1147sqm) accessed from an independent lobby on Haymarket are also provided. Screened plant will be provided at restaurant roof level. A landscaped roof terrace is provided at seventh floor level and additional terrace areas are also provided within the restaurant volume overlooking Smithfield. Access to a double basement will be provided via 2 No. car lifts from Burgess Lane. The basement will accommodate 21 No. car parking spaces, bicycle parking, refuse areas, plant space and associated services. The total gross floor area of the proposed building is 10642sqm (excluding basement car park but including basement storage).

Application No.: 1745/07

Applicant: Stateford Limited

Location: The Bakery, Cross Guns Bridge, Phibsborough Road, Dublin 7

Proposal: Development of a mixed use scheme on a site of 0.75 hectares, approximately. The site is bounded by the Royal Canal to the North, the Phibsborough Road and a Protected Structure (ref: 6853) to the east, a laneway to the rear of residential properties (Leinster Street North) to the south and residential development (Shandon Mill) to the west. The development will consist of; the demolition of the existing buildings on site and the construction of a mixed use scheme which is predominantly residential in nature containing 4 no. buildings with a total gross floor area of 21, 588 sqm approx. The principal buildings in the development are 2 no. primarily residential buildings on the

northern site boundary spanning from west to east. The 2 no. buildings (Building 1&2) range from 6 to 9 storeys with a 13 storey element and roof gardens over two shared basement levels. Building 1 comprises: 2 no. linked blocks (referred to as Block A & B) comprising 90 no. units in total. Block A ranges from 6 to 8 storeys and consists of 44 no. units (8 no. 1 bedroom apartments, 4 no. 1 bedroom Work/Live units, 20 no. 2 bedroom apartments and 12 no. 3 bedroom family sized apartments). Block B ranges from 6 to 13 storeys and consists of 46 no. units (4 no. 1 bedroom apartments, 3 no. 1 bedroom Work/Live units, 15 no. 2 bedroom apartments, 1 no. 2 bedroom Work/Live Unit and 23 no. 3 bedroom family sized to apartments) and a laundry (gross floor space 34sqm) at ground floor level. Building 2 comprises: 3 no. linked blocks (referred to as Blocks C, D and E) comprising 117 no. units in total. Block C ranges from 6 to 9 storeys and consists of 41 no. units (5 no. 1 bedroom apartments, 4 no. 1 bedroom work/live units, 18 no. 2 bedroom apartments and 14 no. 3 bedroom family sized apartments) and a community centre (Gross floor space 49sqm) at ground floor level. Block D ranges from 6 to 8 storeys and consists of 40 no. units (4 No 1 bedroom apartments, 3 no. 1 bedroom Work/Live Units 20 no 2 bedroom apartments, 1 no 2 bedroom work/live units and 12 no. 3 bedroom family sized apartments) and a neighbourhood shop (Gross Floor space 46sqm) at ground floor level. Block E ranges from 6 to 7 storeys and consists of 36 no. units (4 no. 1 bedroom apartments, 4 No 1 bedroom Work/Live Units, 18 no. 2 bedroom apartments and 10 No 3 bedroom family sized apartments) and a juice Bar/Solarium (Gross Floor space 140sqm) at ground floor level. The 2 no. basement levels (9772sqm in total) principally comprise: 281 no. car parking spaces (118 no spaces on upper level, 163 no spaces on lower level); 226 no cycle spaces, plant rooms and a gym (375sqm) on the Upper basement level. Vehicular access to the basement levels will be provided from the site access road off Phibsborough Road. The development also comprises; 6 no. terraced 2 storey townhouses (Building 3)(486sqm); a childcare facility (Building 4)(240sqm); 2 no. new pedestrian access points from Cross Gun Quay; changes in level; boundary treatments; all hard and soft landscaping; balconies and terraces; internal roads and pathways; pedestrian linkages; site services and all other associated site development works above and below ground.

Q1 Councillor Christy Burke

To ask the City Manager if he would outline what funding is available and how much is the shortfall regarding CCTV cameras at (details supplied).

Reply

The Residents of the area(details supplied) made an application for CCTV funding to the Dept. of Justice, Equality & Law Reform. They had a feasibility study carried out and the proposed works were costed in this study. The overall cost of the project was costed at €120,449.20 excl. vat @ 13.5%. The residents ,as is stated in the guidelines below were to provide 15% or €20,506.47 vat incl. Once this was done, then Dublin City Council were in a position to match this 15% and then the DJELR would make up the remaining 70% in a grant. The figure mentioned above ie €20,506.47 vat incl. remains the shortfall for the residents in the area (details supplied).

The following is a snapshot from the Pobal guidelines

What is the maximum grant awardable under the Scheme?

- The maximum grant awardable by the Department of Justice, Equality and Law Reform, in any circumstances, is €100,000. Within this limit, grants of up to 70% of the total capital costs of the system may be awarded.
- In order to qualify for the maximum capital grant (i.e. 70% of capital costs of the system), applicants are required to raise a minimum of 15% of the capital cost of the system, from *non-public funds. Proof of the local funding contribution must be submitted with the application. The remaining 15% may be raised from public and other funding sources.
- If a group is unable to source funding which does not originate from a Government Department or Local Authority, or a body wholly funded from such sources, it is not prevented from submitting an application under this Scheme. Where applicants are unable to raise 15% of the capital cost, from non-public funds, then the maximum capital grant awardable by the Department of Justice, Equality and Law Reform is 50% of the capital costs of the system (subject to the maximum award limit of €100,000).
- The Department of Community, Rural and Gaeltacht Affairs will match funding allocated by the Department of Justice, Equality and Law Reform to successful applications from **RAPID** areas that are endorsed by the RAPID AIT, subject to the total grant aid from both Departments not exceeding €200,000 or 100% of the capital costs of the project, whichever is the lesser.

** For the purposes of this Scheme, "non-public funding" means funding which does not originate from a Government Department or Local Authority, or a body wholly funded from such sources.*

Q2 Councillor Christy Burke

To ask the City Manager that a report be made available to this Committee in relation to the delays at (details supplied) development by an Bord Gáis and that if the City Manager would arrange alternative accommodation for the coming winter months for the residents of (details supplied).

Reply

A delay arose in the construction of the new units as a result of the need to divert a mains gas pipeline, which traverses the site which work was the responsibility of Bord Gais. Diversion works were completed during week ending 24th March 2007 and works recommenced on site on Monday 2nd April.

It is intended to convene a further meeting with residents in the coming weeks to discuss a number of options in relation to their living accommodation.

Q3 Councillor Christy Burke

To ask the City Manager as to what steps Dublin City Council are taking with the Department of the Environment in relation to the increase in adult shops in the (details supplied).

Reply

Dublin City Council Development Plan 2005-2011 states the following;
"it is the policy of DCC to seek to prohibit adult shops in proximity to residential areas" S7 p. 60 ' .
This is currently interpreted as lands zoned "Residential" Z1 or Z2, lands zoned Z3 "Local neighbourhood shops" and lands zoned Z4 "District Centres".

Further controls may be specified in Areas of Special Planning Control such as O'Connell Street.

Q4 Councillor Christy Burke

To ask the City Manager when the tenants chosen for (details supplied) will be allocated their housing units.

Reply

I am advised by the Housing & Residential Services Department that the completion of the purchase of the apartments at this location is imminent.

When the purchase is completed will then be determined what the timescale for the allocation of the units is.

Q5 Councillor Christy Burke

To ask the City Manager if Dublin City Council Waste Management Section would concentrate on street sweeping in the (details supplied) areas.

Reply

Waste Management Services have (details supplied) scheduled to be cleaned five days a week, Monday to Friday. This area is also included in our weekend cleaning schedule. We will continue to do all we can to ensure that this area is kept as clean as possible.

Q6 Councillor Christy Burke

To ask the City Manager if he would arrange to have the shores cleaned out and public lighting inspections at (details supplied)

Reply

The gullies at (details supplied) were cleaned during July and August of 2006 whereby we cleaned 57 of the 62 gullies throughout the six roads that comprise the (details supplied).

Drainage Division endeavour to clean every gully in the city at least once every 12 to 18 months but if there is a specific gully that is causing a problem in the (details supplied) it can be addressed.

Upgrading of the lighting in the (details supplied) will be considered, in the context of finances available, for inclusion in our 2008 programme of improvement works.

Q7 **Councillor Emer Costello**

To ask the City Manager to conduct a wheelchair accessibility audit of all footpaths in the Central Area with specific reference to junctions, to state what if any works are proposed to make more footpaths wheelchair accessible in 2007 and to widen the footpath at (details supplied) to ensure safety for wheelchair users in the area.

Reply

In order to comply with the requirements of the Disability Act 2005 and the Sectoral Plan of the Department of Environment, Heritage and Local Government, Dublin City Council is currently assessing proposals from consultants to carry out accessibility audits around the city to identify access hazards within the roads and streets network and to examine the feasibility of removing such hazards by provision of remedial action. Initial auditing efforts will be concentrated on the city centre area, roughly bounded by the canals, with the remainder of the city to follow afterwards.

The Traffic Department will carry out a survey of lane width and footway widths on south of (details supplied) approaching (details supplied) in the coming weeks with a view to widening the footway at the location.

Q8 **Councillor Nicky Kehoe**

To ask the City Manager to contact the OPW to find out what are the proposed upgrading plan for (details supplied) and what role the City Council has in this upgrading.

Reply

I have written to the Commissioner of the OPW and asked them for a reply. I will contact the Councillor directly when the reply is issued.

Q9 **Councillor Nicky Kehoe**

To ask the City Manager due to the dangerous state of a number of roads in (details supplied) that extra funding be made available to the Roads Department to remedy the situation.

Reply

Generally the roads in the (details supplied) are in reasonable condition. This year Road Maintenance propose to carry out works on the following roads: (details supplied)

The annual works programme for Roads Maintenance is prepared following the adoption of the revenue budget. The preparation of the programme is undertaken following consultation with Area Managers and taking consideration of the condition of footpaths/carriageways in order to prioritise works in each of the areas. An additional allocation of €2.8M was allocated to Roads Maintenance in Y2006 in excess of the annual revenue budget allocation in order to expedite repairs and investment in the infrastructure. This prioritisation of investment in the roads and footways was continued in the Y2007 budget, given the additional investment of €3.2M in excess of the Y2006 budget base. It is not expected that any additional resources will be available to Roads Maintenance in the current year.

Q10 **Councillor Nicky Kehoe**

To ask the City Manager that a Framework or Local Area Plan be made for the area (details supplied) and the waste ground that runs along (details supplied).

Reply

The Planning and Development Department is currently examining the scope for intensification on existing and planned transportation corridors and underused lands zoned Z6 in the Dublin City Development Plan.

The lands at both sides of the Royal Canal including the lands at (details supplied) are included in this scoping exercise. On completion of this exercise, it is intended to prepare framework plans for the more strategic of these sites.

Q11 Councillor Nicky Kehoe

To ask the City Manager that a process be put in place to support and construct a small community building at (details supplied)

Reply

The proposal is being further examined and the Parks Division and shall issue report a Councillor Kehoe in due course with our findings.

Q12 Councillor Nicky Kehoe

To ask the City Manager when (details supplied) will be available for letting.

Reply

The property known as (details supplied) has not been acquired yet so it is impossible to give a timescale for letting.

The property at (details supplied) should be ready for letting within the next 3 weeks.

Q13 Councillor Nicky Kehoe

To ask the City Manager following contact from a number of residents at (details supplied) about on going anti-social activities there that the City Council contact the owners of the property (details supplied) with a view of asking them to erect a pallaside fence to stop access from their property which is causing great problems for the residents of (details supplied).

Reply

The Assistant Area Manager will make the necessary arrangement. However this is fundamentally a private matter between the residents and the (details supplied).

Q14 Councillor Emer Costello

To ask the manager what action has been taken against oxygen for their failure to collect green bags from (details supplied), what assurances he now has that this will not be repeated, if he will ensure that a letter is sent to each of the houses in the area explaining when the green and black bag collections are made along with the multi-lingual leaflet already devised by Dublin City Council explaining householders responsibilities, if he will confirm that all green bags put out on non-collection days will be treated in the same way as black bags put out on non collection days if he will state how often the streets are swept and if he will ensure that all of the streets in the area are swept on a regular basis

Reply

1) The matter has been raised at a Senior Level with Oxigen Ltd and they have been instructed to rectify the situation as a matter of urgency.

The City Council is currently considering its options under the terms of the contract with Oxigen in order to determine the appropriate actions to be taken.

The member will be kept informed on progress in this regard.

2) The letter explaining green and black bag collections and the multi-lingual leaflet re householders responsibilities will be delivered to each address on details supplied in the coming weeks.

3) Waste Management Services have (details supplied) scheduled to be swept every Monday after the refuse collection has taken place there. We will ensure that this cleaning schedule for this area is strictly adhered to.

Q15 Councillor Emer Costello

To ask the manager to provide details of the snagging at (details supplied), to state why the builder was allowed leave the site in this unfinished state, what if any penalties have been applied to the builder as a result of unfinished work, and state when all of the snags will have been attended to.

Reply

Work to rectify the snags on the list compiled at handover of these dwellings was completed at the end of last month. The contractors generally performed well and as the snags were the normal ones that occur on all schemes and as they were attended to by the contractor it is not appropriate to apply any penalties. The contractor also rectified some defects caused by vandalism after the dwellings were handed over to the Council.

The completed dwellings were officially handed over on the 08th December 2006. The builder is responsible for rectifying all defects that become apparent within a period of one year from that date and which are, in the opinion of the architect, the responsibility of the contractor. This is standard practice in contracts of this type. At the end of the defects liability period an inspection will be carried out and a list of snags compiled. It is only when the defects found are rectified to our satisfaction that the final retention monies withheld are released to the contractor.

Q16 Councillor Emer Costello

To ask the Area Manager to start the procedure for a local area plan for (details supplied) in view of the large number of developments taking place in the immediate vicinity

Reply

Like very many parts of the city, the (details supplied) is experiencing development pressure which is being handled in the normal manner i.e. in accordance with the Dublin City Development Plan. This growth which is typical for most of the city results in a very significant demand for local plans in both the inner and outer city. Given these demands, the current pressure to prepare the Local Area Plan for (details supplied) in consultation with the local community and the limited resources available, it is not possible at this time to initiate a plan for the (details supplied).

Q17 Councillor Emer Costello

To ask the Area Manager what proposals he is considering for the regeneration of (details supplied) if he would state how often the estate is swept, if he would consider appointing a caretaker to maintain the estate and ensure that the area is kept clean and if he would remove the railings and erect a wall at details supplied and if he would erect a fence to the rear of (details supplied).

Reply

An internal feasibility study has recently been completed for this estate. It is intended to embark on a public consultation process within the next 2 weeks with the community at (details supplied).

We do not assign caretakers to Housing Estates, this service only applies to Flat Complexes. Normal Dublin City Council Cleansing Services do apply to this estate and our Area Housing Manager will liaise with Officials from that operation.

However, we will arrange to have our Housing Maintenance Section to carry out a once-off cleansing "blitz" of the Estate and we will examine the situation pertaining to the railings etc. and report back to the Councillor.

Q18 Councillor Emer Costello

That Dublin City Council erect a secure fence at details supplied

Reply

The City Council's Project Manager for the (details supplied) has had discussions with local residents on this issue. Residents are requesting that fencing be erected on the private boundary wall between (details supplied) and (details supplied). The Council has in the past made contributions towards the costs of similar works at the rear of NCR properties and, in this context, is currently awaiting a costing for the erection of fencing at this location. Contact will be made with the residents concerned when these figures are available, with a view to reaching an agreement.

Q19 Councillor Brendan Carr

To ask the Manager to ask (details supplied) to have the fence at details supplied repaired and the potholes at (details supplied) filled in

Reply

- a) Following a site inspection no fence was identified at the specified location. The Assistant Area Manager, Cabra Area Office will meet the Councillor on site to clarify the details.
- b) The potholes referred to will be reinstated within the next 2/3 weeks.

Q20 Councillor Brendan Carr

To ask the manager to have the laneways at (details supplied) cleaned out and the ensure that it is cleaned out on a regular basis

Reply

The laneways in question will be cleaned out by the Environmental Response Crew within the next fortnight. As a matter of course laneways are not prioritised by waste management for cleaning as resources do not permit this however we will endeavour to clean these locations on a regular basis.

Q21 Councillor Brendan Carr

That the Manager

- 1) investigates the dumping of building rubble at details supplied and
- 2) that the planning enforcement report on the demolition of details supplied,
- 3) that the pest control be asked to examine the area for rats
- 4) that details supplied be put on the register of derelict sites and
- 5) that Dublin Bus be asked to upgrade its bus stop at details supplied

Reply

- 1. A file on this matter has been referred to the Enforcement Officer for the Area for investigation. A full report will issue to the Councillor with regard to this matter when the Planning Enforcement Officer has concluded his investigation.
- 2. The Planning Enforcement Officer for the area carried out a recent inspection at this property on the 23/02/2007. There was no evidence at that time that the property was being demolished. He will however carry out further investigations. A full report will issue to the Councillor with regard to this matter when the Planning Enforcement Officer has concluded his investigation.
- 3. This has been referred to the Health Service Executive.

4. This site was inspected by the Derelict Sites Section and it not considered to be a derelict site within the meaning of the Derelict Sites Act, 1990.
5. These properties were inspected by the Derelict Sites Section and they are not considered to be derelict within the meaning of the Derelict Sites Act, 1990. However, the grounds opposite these cottages are overgrown. I have requested the Title and Research Section of the Law Department to carry out a reference of ownership and when received the owners will be written to and requested to cut back and remove all overgrowth. This has been referred to
6. This has been referred to Dublin Bus.

Q22 Councillor Brendan Carr

That the Manager report on how he proposed to address the traffic problems at (details supplied)

Reply

There are no plans to change the current traffic arrangements on (details supplied). Any traffic restrictions at the junctions of (details supplied) with (details supplied) or (details supplied) will also apply to residents and thus are not recommended at this time due to possible inconvenience for residents.

Traffic calming currently exists on (details supplied). Speed surveys indicate that the speed ramps have reduced speeds to an acceptable level.

Q23 Councillor Brendan Carr

To ask the Manager to respond to the following issues raised by residents in relation to details supplied

- a) Details of planned work in 2006 by the Parks Department?
- b) Removal of graffiti on paths
- c) Repair of fire-damage to football/basketball court
- d) Fire damaged trees close to court – steps should be taken to prevent more of the same
- e) Removal of dumped bags/general litter from (i) beside lane at back of (details supplied) (ii) area next to site of old main fence breach site adjoining (details supplied)
- f) Repair breach of fence with lane at back of (details supplied)
- g) The (motorcycle?) tyre tracks all over grass underlines need for a proper DCC staff presence in the park. The Parks Department should reconsider this issue.
- h) Install a children's playground in the park

Reply

a) Proposal to install 1) 2 new access/aggress gates and repair to existing surface railing frontage at (details supplied). 2) One French boule-playing surface subject to funding 3) Stand alone junior play units subject to local consultation and confirmation of funding

b) Our Graffiti Removal Officer, Mr. Martin Daly, Telephone 2224254, has listed the removal of graffiti from the paths in this area with our contractors. This work will be completed before the end of April 2007.

c) Work is ongoing

d) Affected vegetation removed and plantation opened up

e) Waste Management Services had the lane at the back of (details supplied) cleaned on the 29th March 2007. We also had the dumped bags removed from the area next to the site adjoining the (details supplied) on the 29th March 2007.

f) breeches in park boundary to be repaired over the coming weeks

g) The access/egress gates shall restrict the unauthorised activity

h) see a above

Q24 Councillor Brendan Carr

To ask the Manager to put ramps on (details supplied) and to have the telephone box from details supplied removed and to repair the footpath outside details supplied

Reply

1) Provision of traffic calming on (details supplied) will be examined by the Traffic Advisory Group and a report will be prepared for a future Central Area Committee.

2) The footpath outside (details supplied) was inspected and no telephone box was located.

3) The footpath outside no. (details supplied) is concrete, however the original grass margin was replaced with Macadam over the years. This macadam has sunk down a little, currently this location is not dangerous and no works are proposed to be carried out there this year.

Q25 Councillor Mick Rafferty

To ask the Area Manager to list the options available to the residents of the (details supplied) in any future redevelopment proposal and to outline the manner in which residents will be consulted on the options.

Reply

A public meeting has been arranged to discuss proposals for the future redevelopment of the (details supplied). A survey of the estate will be completed by 11th April, and all residents surveyed. The residents of (details supplied) will be informed of and invited to attend the meeting. Method of communication will be both door to door and by a full leaflet drop.

Q26 Councillor Mick Rafferty

To ask the Area Manager to list the progress made on the various items raised by residents of (details supplied) at local meetings and any work due in this regard.

Reply

The matters raised by the residents group are the subject of ongoing investigation and the Councillors will be advised of progress in due course. The Assistant Area Manager is meeting the residents group shortly and will continue to maintain this contact over the coming months.

Q27 Councillor Mick Rafferty

To ask the Area Manager if arrangements will be made to put a new nameplate (details supplied) on the small pocket Park at (details supplied) as agreed some time ago by Dublin City Council.

Reply

This Division has erected a commemorative plot to the late (details supplied) within the pocket park at (details supplied). The plot is in a satisfactory condition and easily mowed from within and without.

Q28 Councillor Mick Rafferty

To ask the Area Manager if Central Heating will be installed and repairs carried out to the Shower/Drainage at (details supplied) for the new

tenant who has been requesting this for over a year.

Reply

A request to install Central Heating in this dwelling was received in February 2007 and was surveyed for the installation in March 2007. The gas central heating system will be installed within the next two weeks.

A new shower will be installed within the next three weeks.

Q29 Councillor Mick Rafferty

To ask the Area Manager if a Household Junk Collection can be arranged for the (details supplied) this year as there was no recent collection made in this area – the (details supplied) being the area between the (details supplied) and (details supplied) and (details supplied) and the (details supplied).

Reply

Waste Management Services plan to have a household junk collection in the (details supplied) area in and around May 2007. It is quite difficult to give exact dates as the progress of this collection depends on the volume of junk presented. Residents will be notified a few days in advance of this collection taking place on their road.

Q30 Councillor Mick Rafferty

To ask the Area Manager when a rear shed door can be provided at (details supplied) as agreed by the local maintenance Inspector.

Reply

A new shed door will be supplied and fitted at this dwelling within the next two weeks.

Q31 Councillor Mary Fitzpatrick

Will the manager please advise on (details supplied). Is the manager aware that cycle lanes in (details supplied) are permanently unavailable due to vehicular parking on the lanes? what is the status of bicycle lanes on (details supplied), are they mandatory or non-mandatory lanes? Will the Manager advise what action Dublin City Council has taken over the last 12 months to address the problem of parking in the lanes and why does Dublin City Council waste tax payers money installing cycle lanes if they are never available for use? Will the Manager take action to address the issue?

Reply

The cycle track (outbound) on (details supplied) is a 24-hour non-mandatory track with clearway between 07:00 – 10:00 and 12:00 – 19:00, Monday to Saturday. The section of the cycle track adjoining the shops at (details supplied) is a Loading Bay between 10:00 – 12:00, Monday to Saturday.

This location has been inspected and it appears that most of the vehicles stopping on this stretch of cycle track are short-stay shop suppliers and customers and in the circumstances, effective enforcement by the Council's parking enforcement contractor is problematic. However, the contractor has been requested to give particular attention to this location in the coming weeks in an effort to discourage illegal parking in the cycle track.

In the period 1st April 2006 to 31st March 2007, a total of 62 vehicles were clamped for various parking offences while they were parked illegally in Stoneybatter and Manor Street. In the period 1st November 2006 to 31st March 2007, 8 vehicles were clamped for parking on the clearway (cycle track) in (details supplied) and 4 vehicles were clamped for parking on the bus lane (located opposite the cycle track).

Q32 Councillor Mary Fitzpatrick

Will the manager please advise on (details supplied). Are when will the lane to the rear of (details supplied) be resurfaced?

Reply

There is provision in the Works Programme 2007 for some resurfacing work at this location. It is anticipated that the works will be completed by the end of May 2007.

Q33 Councillor Mary Fitzpatrick

Will the manager please advise on details attached. Details are when were the footpaths on (details supplied) last repaired? Is the manager aware that the footpaths are in a deplorable condition from the vehicular entrance to the rear of (details supplied) along (details supplied) towards (details supplied). Elderly residents on the road have tripped and hurt themselves and others with restricted mobility have been advised by medical staff not to walk on the footpaths due to the poor condition of same. Will the manager arrange to have the footpaths repaired and made safe?

Reply

The concrete footpath between (details supplied) and the (details supplied) is in reasonable condition, however it should be noted that along this section of path there are 11 no. trees. Over the years the tree roots have lifted the original concrete path and this broken concrete has been replaced with a macadam material. This is standard practise as this material is flexible and when the roots push up they tend to lift the macadam which will move upwards unlike the concrete which will simply crack and break up.

Trees in question are mature London Plant approximately 70 years old, are in a satisfactory condition, have been pruned in the last 5 years and provide an important visual amenity to the area.

Due to the age/size/species of the trees and the narrow width of the footpaths and absence of a grass verge margin there is likely to be on going problems associated with tree root activity and this is something that will continue to be monitored.

Q34 Councillor Mary Fitzpatrick

Will the manager advise on (details supplied). Details did Dublin City Council receive requests to have trees planted on (details supplied), if so when? Will the Manager arrange to have trees planted on (details supplied) and on (details supplied) to (details supplied)? If so, when?

Reply

This Division is not aware of the above proposals. We have planted street trees on (details supplied), on the section that approaches the National Botanic Gardens in the recent past. We will arrange to undertake a survey of the section of (details supplied) to (details supplied). For suitability to street tree planting and shall inform the Councillor of our findings in due course.

Q35 Councillor Mary Fitzpatrick

Will the manager please advise on (details supplied). Is the Manager aware of the significant traffic volumes on (details supplied)? Will the manager please advise what possible actions can be taken to reduce the traffic volumes and what process needs to be followed to implement same.

Reply

The Traffic Department recently met with a number of residents on (details supplied) and outlined a number of possible options for the road to reduce the amount of through traffic, including the possibility of a road closure. The Traffic Department are currently awaiting feedback from a recently held residents meeting.

Q36 Councillor Aodhan O' Riordain

To ask the manager as to the progress of (details supplied). Does the Manager have a timetable for the completion of the entire process? What plans are being undertaken for consultation with the tenants and indeed with the surrounding community.

Reply

The procurement process to enter into a contract with a Private Partner to deliver this project is at the end of the first stage with the short list of bidders expected to be decided by the end of this month. The second stage of the process will then commence and it would be envisaged that the contract should be signed by early 2008. The redevelopment will be carried out in at least two stages to minimise disruption to the existing tenants. This should take approximate three years as a result the expected completion date would be mid 2011. A development committee has been established consisting of existing residents and Dublin City Council meets regularly with this committee. A Community Charter has been negotiated and agreed and it is hoped to take this Charter to the surrounding community in the near future.

Q37 Councillor Aodhan O' Riordain

Re: Royal Canal Phibsboro – Cross Guns Bridge to Shandon

Canal enhancement projects at Cross Guns Bridge, Portland Place etc have been successfully implemented by Dublin City Council with co operation and limited funding from Waterways Ireland

Dublin City Council invited Waterways Ireland , the body responsible for the city canals to work on a canal enhancement project between Cross Guns Bridge and Shandon in 2005.

In the course of preparing the enhancement proposals it became clear that much work needs to be done on repairing the stone work beside Cross Guns Bridge, along the canal path, and at the old bridge abutments at the bakery, all of which are Waterways Ireland property. This did not arise to such an extent in the previous canal project. The repairs would have to be carried out before work could be carried out on the paths.

Waterways Ireland undertook to have their conservation experts examine the stone and make proposals. As no progress was made on this over the past months it was decided to proceed with consultation on the overall works, in April 2007.

In the meantime work has started on a framework plan for Phibsboro, including the canals. It would be premature to put plans on display for the path network and street furniture, without having regard to the overall plan. The plan will generate proposals for the lands adjoining the canal, which may result in changes to the original works proposed for the canal.

A further report will be submitted to the Committee in September 2007.

**With reference to the proposed grant of a lease of a site to the rere of Nos. 4 – 10 Tolka Road,
Dublin 3 to Orchard United Football Club.**

In 1961 the Council approved the grant of a temporary convenience letting of a site at the rere of Nos.4 – 10 Tolka Road to Orchard United Football Club, subject to terms and conditions. The football club erected a building at the north eastern corner of the site for use as a changing room. It is also used by a youth club and other local groups. The site is shown on the attached map.

It is now proposed to grant a lease of this site to Orchard United Football Club subject to the following terms and conditions: -

1. The lease shall be for a period of 99 years.
2. The commencement date of the lease is to be agreed.
3. The rent in respect of the premises shall be the full commercial rent as determined by Dublin City Council's Chief Valuer with 5 yearly rent reviews at the full open market rent or the passing rent, whichever is the greater. Notwithstanding the rent so reserved the rent payable shall be abated to €127.00 per annum provided the property is used for sporting purposes. Rent reviews will be based on the movement of the consumer price index but shall not be fixed at less than the passing rent at any review date.
4. The Club shall be responsible for fully insuring the premises and shall indemnify Dublin City Council against any and all claims arising from its use of the premises.
5. The Club shall not assign, sublet or part with possession of the site or part thereof without obtaining the written consent of the City Council.
6. The Club will be responsible for the maintenance and upkeep of the leased site to include security and secure boundary treatment.
7. The Club will be responsible for ensuring that the access points to the site are secured appropriately.
8. All outgoings, including rates, taxes, insurance etc. shall be the responsibility of the Club.
9. The Club shall not carry out any alterations to the site without the prior consent of the City Council.
10. The Club will facilitate other groups who have made use of the facility over a number of years or groups waiting to obtain their own premises.
11. A right of way will be reserved for the residents of Nos. 4–10 and No. 18 Tolka Road for access to their back gardens.
12. Each party shall be responsible for its own legal costs in this matter.
13. The lease will be subject to any other terms and conditions deemed appropriate by the Council's Law Agent.

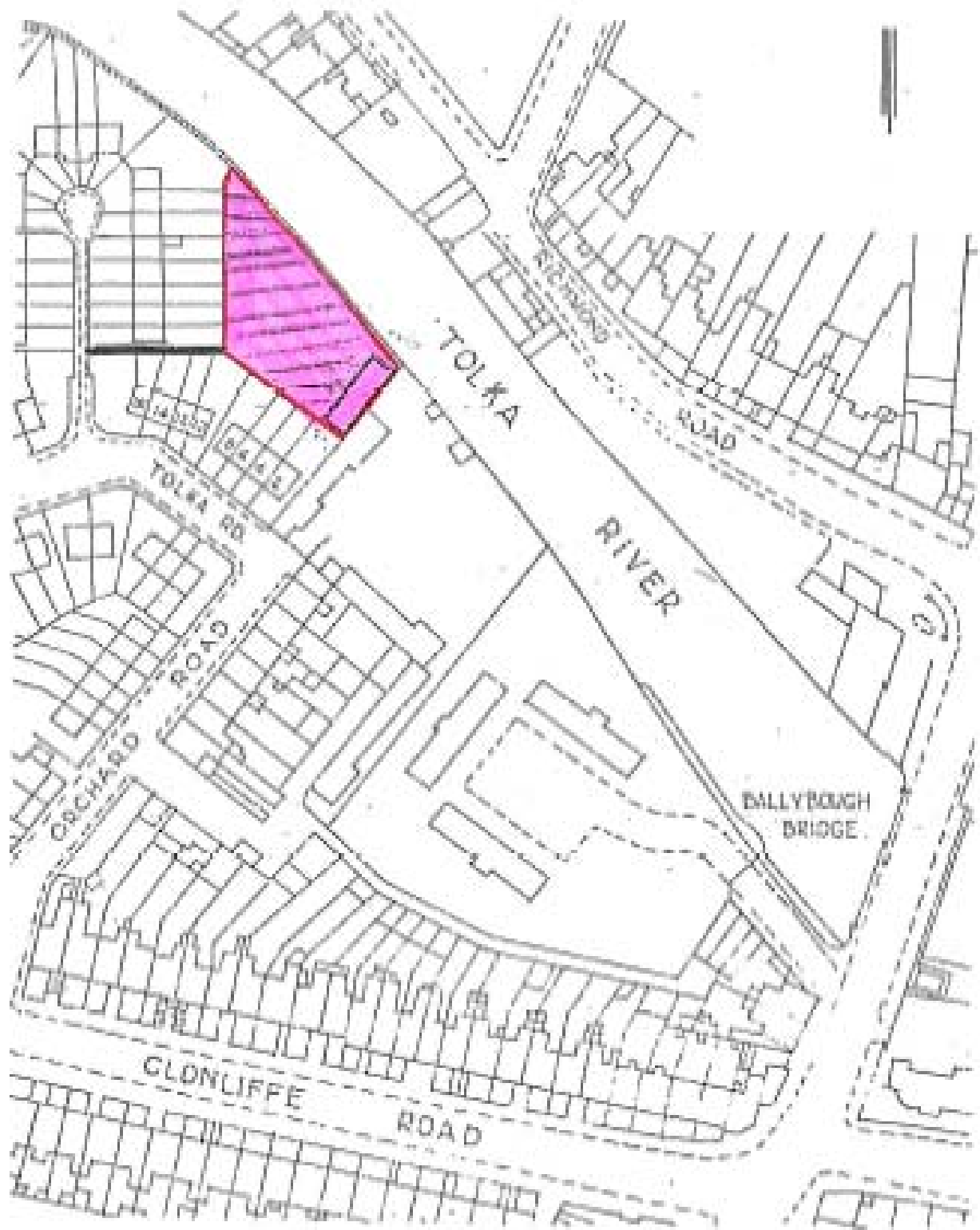
14. Should the premises cease to be used for community sporting facilities it will revert free of charge to Dublin City Council.

The disposal shall be subject to such conditions as to title to be furnished as the Law Agent in his discretion shall stipulate.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

An application has been received from Mr. Peter Taaffe to acquire an area of the footpath adjoining his premises at No. 9 Bellmans Walk. The footpath is shown outlined black and coloured pink on the attached Map Index No. PD 2006-0102 (for identification purposes only).

It is proposed to dispose of the footpath to Mr. Peter Taaffe subject to the following terms and conditions: -

1. That the applicant shall be granted a lease in the above land for a term of 99 years at an initial rent of €1 (one euro) per annum (if demanded) with rent reviews every five years linked to changes in the Consumer Price Index.
2. That the Council shall retain a wayleave to services that exist in the above land.
3. That the lessee shall only use the above land for gardening purposes.
4. That each party are responsible for their own professional fees.
5. That the land shall not be included in any planning application.

The disposal shall be subject to such conditions as to title to be furnished, as the Law Agent in his discretion shall stipulate.

The dates for the performances of any of the requirements of the proposed agreement may be amended at the absolute discretion of the Executive Manager.

No agreement enforceable at law is created or intended to be created until an exchange of contracts has taken place.

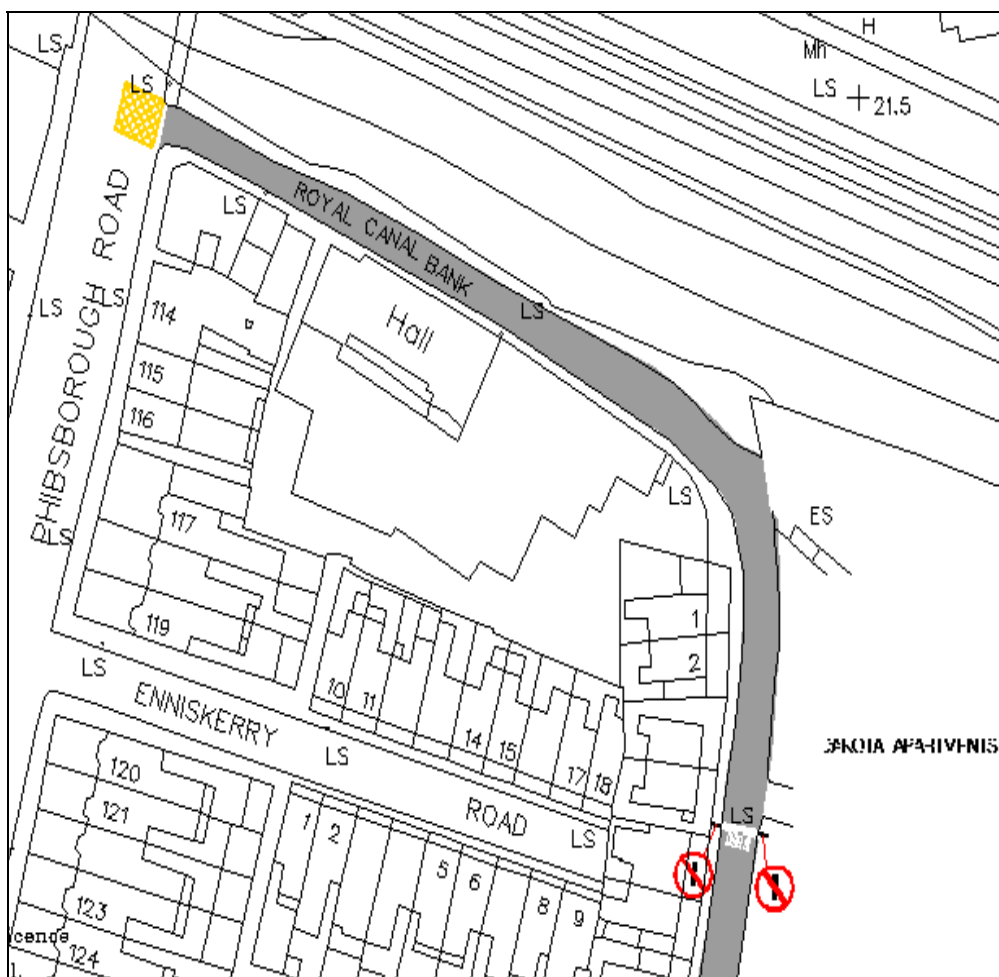

With reference to a proposal to initiate the procedure for the Extinguishment of the Public Right of Way over a section of pathway to the side of No. 26 Portland Square, Drumcondra, Dublin 9.

Proposal

A request to have the public right of way extinguished on a section of pathway beside No. 26 Portland Square, Drumcondra, Dublin 9 was received from a resident in this area. The reason for this extinguishment is to extend parking facilities in the area. The extent of this proposed extinguishment is shown on the attached Drawing RM20604.

Service Checks

A service check will be undertaken to establish what (if) any are located on these areas. Suitable arrangements will be put in place prior to completion of this proposal.

Statutory Requirement

The statutory procedure involves giving public notice of the proposal in one or more newspapers circulating in the City and the affixing of that notice at each end of the right of way for a period of not less than 14 days. Any objections or representations made and not withdrawn shall be considered. The extinguishment of a public right of way is a function reserved to the elected members of the City Council.

Recommendation

I recommend that procedures be initiated under Section 73 of the Roads Act 1993 to extinguish the public right of way over the area indicated on attached Drawing.

DORSET STREET URBAN RENEWAL

Section 1 – Clonliffe Road to Binns Bridge

- Work on the median is now complete with trees planted and uplighters now operating.
- Apart from a few minor snags this entire section is fully complete

Section 2 – Binns Bridge to Frederick Street North

Phase 1 – Binns Bridge to North Circular Road (East side, West side and Median)

Construction of median complete, trees planted and street furniture installed. This phase is now substantially complete.

Phase 2 – North Circular Road to Synnot Place (West side only)

This phase is now complete.

Phase 3 – Synnot Place to Eccles Place (East side, West side and Median)

Construction of median complete, trees planted and street furniture installed. This phase is now substantially complete.

Phase 4 – North Circular Road to Gardiner Street (East side and Median)

Construction of median complete, trees planted and street furniture installed. This phase is now substantially complete.

Phase 5 – Eccles Place to Frederick Street median and east side.

Design phase complete – currently in negotiations with property owners – construction phase dependant on funding – application made to Department of Environment and Local Government.

Phase 6 – Eccles place to Granby Row

Tender accepted – contractor on site March 2007.

Phase 7 – Binns Bridge east and west.

Requires funding

Canal

Work on the Canal from Binns Bridge to Russell Street is now complete apart from the installation of one section of new railings. Work to the gas installation at Binns Bridge and the realignment of the lighting columns is complete. A collapse of a 20 meter section of the canalbank over the Christmas period has now been repaired by Waterways Ireland. A handrail and a "kissing gate" is to be installed at the Binns Bridge end in order to prevent rat running by motorbikes. This work is due for completion end May 2007.

In order to remind residents of collects times and prevent residents leaving out bags on the incorrect days we have circulated a leaflet and a copy of the Oxigen calendar for the area to Phibsborough Avenue and to Castle terrace in Phibsborough.
There was also a multilingual leaflet drop on Innisfallen parade and surrounding area to inform any non-English reading residents of their obligation regarding littering and bin collection under the waste management act.

Trailers

Regarding the trailer situation in Castleforbes, Eastwall, Dublin 3
12 trailers have been removed to a holding area.
At present six trailers have been reclaimed by their rightful owners.
Fines of six hundred euro have been paid per trailer

NORTH EAST INNER CITY INTEGRATED AREA PLAN

New Primary School and Pre-School at Gloucester Place

On 5th December 2005 a decision to grant planning permission was made in respect of a development consisting of a 9-classroom Primary School and 7-classroom Pre-School. The structure is four storeys to Sean MacDermott Street and Gloucester Park, part three storeys with roof top covered play area enclosed with canopy to Gloucester Diamond and Gloucester Place, and part four-storey to Gloucester Place. The development has a total floor area of 3114 sq. m. The Department of Education commenced on site on 22nd January 2007 and construction works are continuing.

Civic Centre

The Convent Lands Civic Centre and Mixed Use Redevelopment is currently at preferred bidder status. No. 77 Sean MacDermott Street was acquired in December 2006 and the extinguishment of the Public Right of Way over Gloucester Lane was resolved by the City Council. Negotiations are ongoing with a Preferred Bidder with a view to signing a project agreement shortly. Planning application will be made as soon as practicable after Project Agreement is signed.

Liberty Park Crèche

Kids Inc will run the Liberty Corner facility, on behalf of Dublin City Council, as a traditional crèche and Montessori facility. It will cater for children from 3 months to 5 years. Priority will be given to residents from the NEIC RAPID area. At this stage, it is planned that full time places will cost in the region of €125 per child per week. Dublin City Council will be subventing the cost of childcare places for local parents. The facility will cater for approximately 35 children. There is fit out required for which, we have successfully applied for funding from the National Childcare Investment Programme. We intend that the facility will open after Easter. An information leaflet was circulated to local residents in late March. The official opening is due to take place on 10th May 2007. The attached invitation was distributed on Thursday 26th April 2007.

Buckingham Street Family Resource Centre

Dublin City Council and the HSE are negotiating with Barnardos who plan to run a family resource centre from this facility. The exact mix of services was determined following local consultation. This service will focus on children in need from 0-12 years and their families. The post of Manager of this facility was advertised on the 27th January 2007. Interviews took place and an offer of employment has been made. A lease is being prepared for the building. The Housing Services Executive, Dublin City Council and Barnardos will jointly fund the facility. The facility is expected to open in June.

Liberty Corner Retail Units

Works were carried out to fit out one of the retail units as a show unit and also the installation of toilets for each unit. The units are on the market for sale. Offers were made in respect of units no. 2 & 8 at the asking price and it was agreed at March's Area Committee meeting to accept these offers. Offers were made for units 3, 4, 6 and 7 and it was agreed at April's Area Committee meeting to accept these offers.

DanceHouse, Liberty Corner

DanceHouse were granted a licence for the building and the building is now open.

Development at 110-115 Amiens Street/1, 2 and 3 Halpin's Row

Planning permission was granted for a five-storey office/retail development over basement car parking beside Connolly Station and a First Stage Certificate under the Urban Renewal Tax Incentive Scheme was applied for. The development has been constructed and works continue on the interior.

Development at Portland Row/Duke Row/Buckingham St Upper (St Joseph's Convent)

Work is continuing on site. Dublin City Council has facilitated a number of meetings with the Portland Row Residents Association and the developer to discuss community concerns with regard to the development e.g. noise, dirt and dust. The Portland Row Residents have met with the Council's Architect to discuss community facility requirements and an outline feasibility report has been prepared by the City Architects Department. A consultant architect will be appointed shortly to progress the project.

Development at Five Lamps, Amiens Street/Killarney Street

Construction is underway on a five-storey development comprising offices, enterprise centre, medical and related consultants, media recording and general media uses, electricity sub-station and basement car park. The development is now constructed and internal works continue.

Retail Units at Killarney Court

Expressions of interest from community groups, operating in the North East Inner City area, who are seeking accommodation for office headquarters will be advertised shortly.

Poplar Row

The project architect reports that works are continuing on completing the outstanding snagging issues. The first five houses were handed over on the 1st May 2007. The remaining units are being handed over on a phased basis. Community Centre site meetings are ongoing between Builder, DCC and Residents Reps and will continue for the duration of the project.

Croke Villas

The complex is being detenanted at present to allow for the redevelopment. Consultation meetings with Tenants reps are ongoing. Community Charter now agreed with residents committee and presented to Area Committee. The charter was presented to residents on 6th December 2006; it was well received by all residents in attendance. Trial hole digs have been carried out in the complex.

Tom Clarke House/Orchard Road Depot

A feasibility study has been completed on the above two sites. It is hoped to commence the consultation shortly.

Ballybough House

Works have been complete on the erection of new fencing and netting on the football pitch in the complex. The residents association held their AGM in February and a newly elected association is now in place. A meeting took place between the new residents association and Estate Manager at the end of February 2007. Meetings will continue through out the year.

Two CCTV cameras have been installed in the complex and are now operational.
