#### CONDITIONS OF STREET PERFORMANCE PERMIT

1. The Permit Holder must adhere to the Street Performers Bye-Laws 2015 at all times.
2. Anyone performing in a public place must hold a current Dublin City Council Street Performance Permit. The permit must be displayed in a prominent, highly visible position at the performance location at all times.
3. A separate Street Performers Amplification Permit must be obtained for any Street Performer wishing to use amplification.
4. Street Performers must keep the location they use clean while they are performing and ensure that it is left in the condition that it was found. Pavement artists and performers using props must ensure that the location is not stained with any chemical, material or residue.
5. Any street performance act should not disturb customers or staff of nearby businesses, or local residents.
6. Under no circumstances should any posters or advertisements of any nature be placed on Dublin City Council property.
7. A Street Performer shall not perform in a public place after 11pm and before 9am on any day SAVE AND EXCEPT on Henry Street and Grafton Street where a person shall not perform before 11am . Performers are limited to a maximum time of 2 hours per day on any one street. This includes setup, breaks and pack-down.
8. Street performers may give audiences an opportunity to provide voluntary donations by placing a container on their pitch. Street performers may not approach individuals requesting money or solicit funds in a way that is likely to cause any discomfort to members of the public.
9. Liability for any injury loss or damage caused as a result of a performance will rest solely with the permit holder and Dublin City Council accepts no liability in such circumstance.
10. Street performers must take all practicable steps to ensure their performances cause no harm to themselves or members of the public. Potentially dangerous acts must hold public liability insurance to the value of €6.4 million and indemnify Dublin City Council.
11. The Permit holder must obey all lawful requests of an Authorised Officer or a member of An Garda Síochána.
12. Any person who contravenes the conditions of this permit may have the permit revoked and shall be guilty of an offence and shall be liable, on summary conviction to a fine not exceeding €1500.
13. A nominal fee will apply for replacing lost or stolen permits.
14. Street Performance is not permitted in the vicinity of the GPO and part of Temple Bar as shown on the maps attached to the Bye-Laws.
