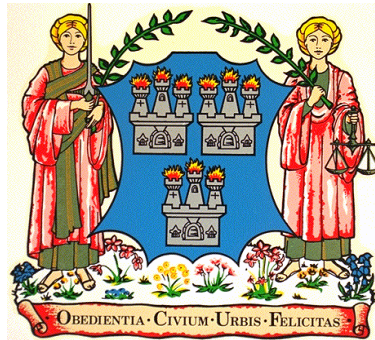

1. The Lord Mayor opened the meeting and immediately agreed to a proposal by Councillor R McGinley and seconded by Councillor D Lacey that the meeting be adjourned for a time. This was agreed by the City Council. The Lord Mayor requested Members to return to the Chamber at 6.15pm. When the meeting re-commenced, the Lord Mayor offered sincere sympathy on his own behalf and on behalf of the City Council to the family of Gerry Conlon who died on Sunday, 22nd June.

He then called on all parties involved in the Greyhound dispute to start talks in an effort to resolve this dispute. He also asked that the Dublin City Chief Executive put measures in place to deal with extra litter problems that may arise from the dispute.

The Lord Mayor then informed the Members that he had met with senior staff from the Housing Department and had made progress in relation to the homeless situation in the city, stating that there would be 80 additional beds provided, outreach services enhanced and a greater emphasis placed on the turnaround of voids. He then asked that Members agree to the earlier time of 5.30pm for the start of the July Monthly City Council meeting and that the matter be referred to the Protocol Committee for further consideration and agreement on a starting time for meetings from September onwards. This was agreed by the City Council.

The Lord Mayor then announced the titles of the 7 Strategic Policy Committees as follows :

- Economic Development & Enterprise
- Housing
- Arts, Culture, Leisure & Community
- Finance & Emergency Services
- Environment
- Planning & International Relations
- Transportation

This was agreed by the City Council.

2. Submitted Letter dated 14th May 2014 from South Dublin City Council calling on the Minister to introduce as a matter of priority Mandatory Oxygen Saturation screening with the use of Pulse Oximeters in every maternity hospital in the state as part of the general post-natal assessment of babies. It was moved by Councillor R Mc Adam and seconded by Councillor C Ni Dhalaigh "That Dublin City Council notes the contents of this letter". The motion was put and carried.
3. The minutes of the Meeting of the City Council held on the 12th May 2014, having been printed, certified by the Meetings Administrator, circulated to the Members and taken as read, were signed by the Lord Mayor.
4. Submitted Report No. 205/2014 of the Chief Executive (*O. Keegan*) - Report on Revised Area Structure 2014 – 2019. It was proposed by Councillor R McGinley and seconded by Councillor D Heney "That Dublin City Council notes the contents of Report No 205/2014 and hereby approves the Area Structure as set out in the report". The motion was put and carried. Councillors R McAdam and C Perry wished their opposition to the adoption of this report to be noted on the basis of their opposition to a proposal to close an area office. Following discussion, the Chief Executive agreed to bring the Review of the Area Offices currently under way, to the City Council before he made any decision in relation to the future of any of the offices.
5. Submitted Report No 206/2014 of the Chief Executive (*O. Keegan*) – Establishment of new Strategic Policy Committees and the drafting of new Strategic Policy Committee Scheme 2014 – 2019 – this item had been dealt with under Lord Mayor's business and the name and number of Strategic Policy Committee agreed, therefore the report was not taken.
6. Selection of Chairs Designate of the proposed Strategic Policy Committees – the following Members were proposed by Councillor D Lacey and seconded by Councillor

7. To fix a date for the holding of an Annual Meeting in the month of June for the years 2015 to 2018 – the City Council agreed to fix the date of the Annual Meeting for the years 2015 to 2018, inclusive, as the last Monday in June each year as proposed by Councillor S McGrattan and seconded by Councillor L O'Toole.

Some Members expressed concern over the non-availability of hard copy agenda and documentation for the meeting. The issue is to be considered further by the Protocol Committee. Reference was made to proposals to further enhance I.T. Systems and modernise the Council's approach to meetings' management.
