Minister for Health and Children announces immediate criminal ban on list of head shop products

11 May 2010

The Minister for Health & Children, Mary Harney, T.D., announced today (Tuesday, 11 May 2010) that the Government has made an Order declaring a number of substances, commonly referred to as so-called 'legal highs', to be controlled drugs under the Misuse of Drugs Act 1977, with immediate effect. This follows approval by the relevant EU authorities.

"These substances are dangerous and their sale and promotion have caused huge anxiety to families and communities throughout the country." said the Minister.

"Their possession and supply are now illegal and subject to criminal sanction of:

- *up to 7 years imprisonment and/or a fine for unlawful possession, and,*
- *on indictment, up to a maximum period of life imprisonment for unlawful supply.*

"This means that the reckless, irresponsible people who have sold and promoted them must safely dispose of every product containing even one of the substances immediately. Otherwise they could face criminal prosecution. They cannot sell, supply, possess or distribute this stock, with effect from the start of today, 11th May.

"I am publishing the full list now in this press release and simultaneously on the Department of Health and Children's [website](#)

"The main categories of substances involved have been published on our [website](#) since 3rd March.

"I am confident that An Garda Síochána will enforce this law rigorously.

"There have been ample reports in Ireland of persons suffering serious illnesses attributed to using some of these substances, and deaths have been reported in other countries, particularly where some of these substances were taken with alcohol or other substances."

The list of the substances by common name is:

- synthetic cannabinoids (contained in SPICE products)
- benzylpiperazine (BZP) and piperazine derivatives
- mephedrone, methylone methedrone, butylone, flephedrone, and MDPV
- GBL and 1,4 BD

GBL and 1,4BD are legitimately used in a number of industries including in chemicals and pharmaceuticals. It will now be an offence to import, export, produce, supply or possess these substances where they are to be used for the purpose of human ingestion (other than as a flavouring in food).

The full list of the “legal high” substances in the Government Order is attached as an Appendix to this press release.

In March 2010, the draft Government Order was notified to the EU Commission under the Technical Standards Directives. This imposed a 3 month consultation period. However, due to increasing concern about the health risks associated with the use of “legal highs”, the Minister decided that an application should be made to the EU Commission to use an urgency procedure and introduce the legislation as quickly as possible. Yesterday (10 May) the EU Commission advised the Government that the legislation could be implemented without the need to await the expiration of the 3 month consultation period.

The Government Order also controls a number of other substances that are not “legal highs” but which have the potential to be misused. These include certain narcotic and psychotropic substances which Ireland is obliged to bring under control in order to comply with the UN Single Convention on Narcotic Drugs and the UN Convention on Psychotropic Substances.

Government Go-Ahead for Head-shop Sanctions

The Minister for Justice, Equality and Law Reform, Mr Dermot Ahern, T.D., today announced that the Government has approved new legislation which will crackdown on the operation and activities of head-shops.

The Government today approved the drafting of the Criminal Law (Psychoactive Substances) Bill 2010. This will provide sanctions against proprietors of head shops engaged in the sale of drug-like products and criminalise the sale and supply of substances sold from them.

Under the new legislation, the sale or supply of substances which may not be specifically proscribed under the Misuse of Drugs Act, but which have psychoactive effects, for human consumption will be a criminal offence. It is also proposed to give appropriate powers to the Gardaí and to the courts to intervene quickly to prevent these outlets from selling these products by way of appropriate prohibition orders.

Minister Ahern said: **"The safety of the community is being put at major risk by the operation of so-called head shops. The operators of these shops are exploiting for large profits the availability of potentially dangerous products by selling them for human use. Such activity clearly seeks to undermine the legal framework for the control of drugs in this country.**

"I am not prepared to allow this to continue. The Government today approved my proposals to ensure that the criminal law and the Gardaí can deal quickly and effectively with those who sell psychoactive substances for human consumption. I look forward to early publication and enactment of the proposed Bill."

Note for Editors:

The Minister's proposals are intended to operate in conjunction with a number of other avenues which are being pursued, including the regulations introduced today by the Minister for Health and Children to prohibit the sale of mainstream head shop products. The activities of head shops are being closely monitored on an ongoing basis by An Garda Síochána and Revenue's Customs Service, with a view to ensuring that no substances that are currently illegal are being sold.

As part of the multi-pronged approach, relevant Government agencies are reviewing existing legislative provisions to establish if head shops are liable for prosecution under a range of legislation. The HSE, in association with partner agencies under the Drugs Strategy, is finalising a national drugs awareness campaign that will focus on the dangers of psychoactive substances available through head shops.

The National Advisory Committee on Drugs has been asked to carry out some targeted research in this area.

Joint Policing Committee

Monday 31st May 2010

Report of Assistant Garda Commissioner Michael Feehan

At this third meeting of the Joint Policing Committee for 2010 I intend to concentrate on the developments in regard to the crime and traffic statistics for 2010, Headshops and the sale of tablets on the street. I will also outline the outcome of analysis in respect of Public Order trends and Assaults since the introduction of Intoxicating Liquor Act 2008.

CRIME

Since my last report in March 2010 Crimes against the Person have continued to decrease primarily with a reduction in Assaults.

Incidents of Burglaries continue to show a decrease with March and April being the lowest period since September 2008

Robbery from the Person has increased across the Dublin Region and is more prevalent in the City Centre.

Having identified this increasing trend I have put in place a City Centre operation to target these incidents and early indications suggest that the number of incidents is on the decrease.

In particular we have had a number of successes in identifying and bringing before the courts a number of persons for who were primarily responsible for these crimes.

The initiatives across the city to target organised crime continue and I am happy to report that the initiatives which are intelligence driven continue to be seen locally as having an effect on the activities of persons involved in organised crime.

TRAFFIC

The number of people killed on the roads for the first four months of 2010 is 5, a reduction of three (3) compared to the figures for 2009. As indicated previously this is an area which I am monitoring continually. Each of my Divisional Officers has developed a Divisional Roads Policing Plans, which is being coordinated by my Regional Traffic Unit.

Presentation by Mr. Enda Martyn, Centra, Dame Street, Dublin 2

Following the presentation from Mr. Enda Martyn I was requested to report on the impact if any associated with the changes to the opening hours of Off-Licences, in terms of the effect on the number of public order and associated offences. Arising from this request I sought an examination of levels of Public Order Offences and Assaults (Minor and Serious) in the Dublin Metropolitan Region prior to, and following the introduction of the Intoxicating Act 2008.

As you will be aware the Minister for Justice, Equality and Law Reform established the Government Alcohol Advisory Group in January 2008 to examine aspects of the law governing the sale and consumption of alcohol with particular reference to public order issues.

On the 30th July 2008 the Intoxicating Liquor Act 2008 came into force. One of the main provisions of the Act was to restrict off-sales of alcohol to between the period 10.30am and 10.00pm (or 12.30pm and 10.00pm on Sundays and St. Patrick's Day).

The analysis carried out shows that Public Order Offences fell by 14% and Minor Assaults by 3% from 2008 to 2009. Assaults Causing Harm also decreased in 2009 by 1%. It is important to highlight that a number of factors should be considered when examining the decrease in Public Order Offences and Assaults during this period. Ireland entered a downturn in Quarter 4 of 2008, soon after the Intoxicating Liquor Act 2008 was introduced, which resulted in reduced employment, consumer spending and alcohol consumption.

One cannot make a direct casual link between the introduction of the Intoxicating Liquor Act 2008 and the reduction in Public Order Offences and Assaults in the Dublin Metropolitan Region. However this reduction has taken place since the introduction of the legislation in conjunction with the economic downturn and its resultant effect on alcohol consumption.

Selling of Street Tablets

This matter was the subject of an investigation during 3rd Quarter 2009 where persons were arrested on suspicion of selling controlled substances in contravention of the Misuse of Drugs Act 1977/84. During the investigation it transpired that the individuals were in fact selling tablets which were not controlled substances.

A file was subsequently submitted to the Director of Public Prosecutions who directed that no prosecution could be initiated due to the fact that the suspects were not on breach of the Medical Products Legislation / Regulations or under the Pharmacy Acts 1875-1977.

The direction also indicated a prosecution under the Casual Trading Act should not be initiated as a licence could not have been obtained to sell the items in the first instance.

Headshops

On the 11th May 2010 the Misuse of Drugs Act 1977 (Controlled Drugs) (Declaration) Order 2010, Misuse of Drugs (Amendment) Regulations 2010, Misuse of Drugs (Designation) (Amendment) Order 2010 and the Misuse of Drugs (Exemption) Amendment) Order 2010 came into operation. The purpose of this legislation is to amend the Misuse of Drugs Regulations 1988 and include a range of substances currently on sale in the jurisdiction as controlled drugs. Subsequent to these orders coming into operation I collated and prepared statistical information for the information of the Joint Policing Committee in respect of Headshops in Dublin City. The situation with respect of Headshops is being monitored closely with a specific strategy put in place. Their present status can be considered as being fluid since the 11th May 2010, with some Headshops closing. I can advise that in a significant number of cases the owners of these shops have handed over the controlled substances to the Gardai.
