

### **CASUAL TRADING (FEES) BYE LAWS**

made under

THE CASUAL TRADING ACT, 1995

Bye Laws made by Dublin City Council on the 4<sup>th</sup> March 2013

**LONG TITLE:** "The Lord Mayor and Members of Dublin City Council (hereinafter referred to as "The Council") in exercise of the powers vested in them by the provisions of The Casual Trading Act, 1995 as amended and all other enabling statutory powers hereby make the following Bye-Laws for the fees relating to Casual Trading in the administrative area of Dublin City Council"

### **PRELIMINARY**

- NO. I SHORT TITLE: These Bye-Laws may be cited as the Dublin City Council Casual Trading (Fees) Bye-Laws 2013.
- NO. 2 AREA OF APPLICATION: These Bye-Laws apply to the administrative area of Dublin City Council.
- NO. 3 COMMENCEMENT DATE: These Bye-Laws shall come into effect on the 4<sup>th</sup> day of March 2013.
- **NO. 4 REVOCATION:** The Dublin City Council Casual Trading (Fees) Bye-Laws 2012 made by the Council on the 5th day of March 2012 are hereby revoked as and from the commencement date of the 4<sup>th</sup> day of March 2013.
