1)	<b>COUNCILLOR GARY GANNON</b>	<b>Received: 26/04/2017</b> <b>Amended: 22/08/2018</b>
<p>Following the repeated recommendations of the United Nations Committee Against Torture (UNCAT) that the Irish State should undertake a thorough and impartial investigation into ill-treatment of girls and women at the Magdalene Laundries, promote greater access to archival information regarding the Magdalene Laundries and fully implement the outstanding recommendations of Mr Justice Quirke, including services for survivors and memorialisation, the elected members of Dublin City Council (DCC) consider it entirely inappropriate that DCC is currently offering the Magdalene Laundry site at Sean McDermott Street for sale to private developers. The elected members of DCC are also concerned that, despite it being the first recommendation of Mr Justice Ryan's Commission to Inquire into Child Abuse, a memorial to those abused in residential schools has never been created.</p> <p>We hereby request a halt to the sale of the Magdalene Laundry site at Sean McDermott Street. We welcome the creation of the Lord Mayor's Commission and look forward to receiving its recommendations regarding the appropriate use of the site.</p>

The proposal/recommendations include the following:</p> <p>That the Irish language as First Language of the State should have prominence as was the case in 1919.</p> <p>The Centenary Year should feature Debate/Discussions on “the Dáil then - the Dáil today” , on leading figures of the time and to include discussion on the role of the 1916 women in the suffrage movement, the 1918 General Election and the First Dáil.</p> <p>The Centenary Programme should include a photographic record, film archive display and exhibition of copy historic documents such as The Declaration of Independence, Message to the Free Nations of The World and The Democratic Programme of The First Dáil.</p> <p>A large photo of the members of The First Dáil should be displayed outside The Mansion House and Leinster House during Centenary Year.</p> <p>Recognising that the national broadcaster, RTE, will have a central role to play it is recommended that TV and Radio Programmes should be centred on three themes: Election 1918, The First Dáil and the commencement of the War of independence.</p> <p>The significance of the First Dáil should be brought to schools nationwide in a similar way in which the 1916 Easter Rising became a focal point for schoolchildren. A presentation to schools of copies of the historic documents of the time (i.e. The Declaration of Independence, Message to the Free Nations of The World and The Democratic Programme of The First Dáil) should be considered.</p> <p>Finally, the importance of this occasion warrants the announcement of a National holiday, ‘Independence Day’ on 21<sup>st</sup> January 2019 to appropriately mark the Centenary of the sitting of the First Dáil, as recently proposed in Seanad Éireann.</p>	<p><b>Received: 19/09/2017</b> <b>Replaced: 22/03/2018</b></p>

The level of institutional abuse child rape and torture which took place in Artane Industrial School itself and, in particular, within the Artane Boys Band has been widely documented in State inquiries. Indeed, it was in the former band room that many suffered their trauma.</p> <p data-bbox="207 492 1468 660">It is not appropriate that the office of the Lord Mayor would be associated with a Band that carries such a legacy with such a history with it. Symbolism is important and this association is one which brings Dublin City Council and the office of Lord Mayor into disrepute. For many who are still alive and their families, the Artane Band in all its manifestations including the Artane School of Music, its symbols and uniform signify terror and trigger deep trauma to this very day.</p> <p data-bbox="207 694 1468 862">With campaigns such as #metoo now in existence and with attempts being made to heighten awareness of child abuse and child protection, there is no reason why Dublin City Council or the office of the Lord Mayor should give official sanction to what is still deeply hurtful and painful for the many children who suffered sexual, emotional, spiritual and physical abuse at the hands of the Christian Brothers and others in the residential institutions that they managed.</p> <p data-bbox="207 896 1468 1030">We who went through this, have to deal with it on a daily basis. After all the reports and the apologies, it is deeply hurtful for us to see the Artane uniform, the Artane symbols and the Artane Band which is still under the control of the Christian brothers, rolled out on National Media without any regard for our feelings.</p> <p data-bbox="207 1064 638 1097">This is wrong and needs to stop.</p> <p data-bbox="207 1131 1468 1265">Dublin city council itself under its former title of Dublin Corporation was complicit and involved in the incarceration of thousands of children in residential institutions such as Artane, Letterfrack, Daingean under the guise of the non attendance of school act. 32)	<p><b>COUNCILLOR ÉILIS RYAN</b> <span style="float: right;"><b>Received: 22/08/2018</b></span></p> <p>Dublin City Council notes with concern the rise in Ireland over the past number of years, of diseases which are preventable through vaccination, including mumps, measles and whooping cough.</p> <p>The City Council further notes the dangerous spread of misinformation overstating and at times inventing risks associated with vaccinations, and associated campaigns encouraging parents not to vaccinate their children. We recognise that achieving 'herd immunity,' in which anybody who can be vaccinated is vaccinated, is essential to stopping the spread of dangerous infectious diseases.</p> <p>As part of Dublin City Council's involvement with the <i>Healthy Cities</i> initiative, the City Council commits to the following actions to combat this trend:</p> <p>The instigation of a public information campaign, aimed at publicising the HSE's existing policies of encouraging vaccination of children, in DCC workplaces, childcare facilities, community and sports' centres, and through public advertising, billboards and meetings</p> <p>The establishment of a working group comprising the City of Dublin Youth Services Board, the Dublin City Childcare Committee and Dublin City Council and a representative from the HSE, to agree a joint policy on requiring evidence of vaccination against MMR and Whooping Cough, for children accessing childcare, daycare, sports or recreational activities carried out by those bodies, with medical exceptions only</p> <p>Dublin City Council furthermore calls on the Minister of Health to adopt a similar approach nationwide, in particular requiring that all children accessing shared childcare or education spaces be required to produce a vaccination certificate for MMR and Whooping Cough.</p>
