Introduction

The Duchess of Marlborough Relief Fund was founded in December 1879 for the relief of distress in Ireland. This distress had been caused by the successive failures of the harvests of 1877 - 1879, and by 1880 it had developed into the Little Famine.

The Duchess of Marlborough was born in 1822 as the second child of Charles William Vane, 3rd Marquess of Londonderry and Lady Frances Anne Emily Vane-Tempest. In 1843 she married Sir_John Winston Spencer-Churchill, 7th Duke of Marlborough, who became Lord Lieutenant of Ireland in 1876. As a result of her marriage, Lady Frances Anne Emily Vane was styled as Marchioness of Blandford on 12 July 1843 and her name became Spencer-Churchill. During her marriage she had eleven children. In 1857 she became Duchess of Marlborough. She died on 16 April 1899 at age 77 at Blenheim Palace, Woodstock, Oxfordshire, England.

The Duchess was "deeply moved by the famines in Ireland and deems it imperative that private charity should step into supplement the ordinary system of poor relief and so she makes an appeal to the generosity of the British public."

Because of the great Famine in 1845 till 1849 there was a great willingness to help among the population of the United Kingdom. So the Duchess of Marlborough found many donors who supported her to establish the Fund. In April 1880 she referred the responsibilities of the Administration to Trustees. In July 1880 it became clear, that there would be a good harvest in Autumn. Therefore the work of the Fund wasn't needed anymore and it was wound up at the end of the year.

The collection of the Fund consists of two boxes of documents relating to the administration of the Fund and distribution of relief in the Poor Law Union of Castlebar, Co. Mayo. Includes dockets authorizing issue of Indian Meal to named individuals. It is likely that the records were in the keeping of Sir Benjamin Whitney, who served as Clerk of the Crown in Co. Mayo from 1869, possibly because he served in an official capacity on the local committee. De-accessioned by National Archives of Ireland and deposit with Dublin City Archives. Received in March 2005. The second deposit was received from National Archives of Ireland in June 2008.

The collection covers the period from January till September 2008 and the documents have been numbered in straight successive sequence from Ch/08/01 to Ch/08/38 by descending importance.

The Great and the Little Famine were both very formative events in Irish History. To preserve the records of this Fund, which supported the Irish people, who suffered from hunger in 1880, is important for the next generations.
