NOTE 1: Applications must be accompanied by a copy of the notification submitted to the Garda Superintendent of the Regional Traffic Division, Dublin Castle and the Superintendent, Garda National Traffic Bureau, Garda Headquarters, Phoenix Park. An Abnormal Load permit cannot be issued by the Council unless the Council is satisfied that the appropriate notification has been given to the Garda authorities.
