Application for entry on the Supplement to the Postal Voters List

Persons who cannot vote in person at the Dublin Bay South bye-election on 8 July, 2021 for a public health reason relating to Covid-19

- 1. The purpose of this form is to facilitate voters who cannot vote in person in the constituency of Dublin Bay South on 8 July 2021 at the polling station they would otherwise be entitled to vote because of a public health reason relating to Covid-19 and wish to be included in the supplement to the postal voters list. A 'public health reason' means being required (a) by law to quarantine or (b) if an elector is self-isolating or restricting his or her movements on foot of advice from the Health Service Executive or a registered medical practitioner.
- 2. The form should be completed and returned to Dublin City Council as soon as possible but not later than 2 July, 2021. The form may be posted to Franchise Section, Dublin City Council, Block 4, Floor 4, Civic Offices, Wood Quay, Dublin DO8 RF3F or sent by email to franchise@dublincity.ie
- 3. To be included in the supplement to the postal voters list for the reasons set out in paragraph 1, you must already be on the register for the constituency of Dublin Bay South.

4. Eircode

Eircode is the national postcode system for Ireland and comprises a unique 7-digit postcode which has been allocated to every address in Ireland.

- 5. Your contact details are being sought in case the registration authority needs to contact you to clarify any details of the application. Electoral law provides that the registration authority may for the purposes of their duties in relation to the preparation of a register of electors require a person to give any information in their possession which the registration authority may require.
- 6. It is an offence to fail to give the registration authority any information required for the purpose of their duties or to knowingly give false information.
