Millennium Walkway is located on Jervis Street, Dublin 1 and is based in the heart of the City Centre. It is close to all local amenities including schools, shops and Bus & Luas services.

Expressions of interest are now being invited for these 1, 2 & 3 bed units which will be available for letting in June 2022. Applicants should note that there is lift access to all units. There is no parking.

Only applicants whose requirements are for a 1 or 2 or 3 bedroom accommodation under the Allocations Scheme of Lettings will be considered for this Choice Based Lettings competition.

3. Applications accepted on official forms (paper/online) only.
4. Applicants are invited to register their interest with Dublin City Council. Properties that become available for re-let in this area will be advertised in **Housing Projects, Ashley House, 182-184 Parnell Street, Dublin 1**, and the Dublin City Council website.
5. There will be a 10 day timeframe for applicants to register their interest.
6. This application form must be returned to the centre of your choice mentioned in section 4 above or email to [tommy.wilson@dublincity.ie](mailto:tommy.wilson@dublincity.ie)
7. If a number of applicants express an interest in the same property, the final offer will be made to the applicant with the highest position on list.
8. Under the Choice Based Letting Scheme only the successful candidates will be notified.
9. A successful candidate who refuses a Choice Based Letting will not be eligible for consideration for another Choice Based Letting unit for a period of 1 year.
