Dear Resident/Business Owner, This leaflet provides information on the Dodder Greenway Project - Herbert Park to Donnybrook Road

The Dodder Greenway Project - Herbert Park to 460m Donnybrook Road, is part of the Dublin City Council (DCC) core active travel network. It is funded by the National Transport Authority (NTA). It will provide high quality walking and cycling facilities along the banks of the River Dodder for a distance of 460m. The greenway extends from Eglinton Terrace, beside entrance to Herbert Park, to Donnybrook Road, beside Anglesey Bridge. It is a primary route in the NTA Greater Dublin Area Cycle Network Plan. The project includes signalized pedestrian crossings, extensive upgrades to landscaping including tree planting and other greening measures.



Construction works are scheduled to start in October 2022. In order to deliver this complex but very worthwhile project for the city, there will be some unavoidable temporary disruption to the area. DCC in collaboration with our contractor will endeavour to minimise this as much as possible.

1 PROJECT OVERVIEW

The Dodder Greenway (Herbert Park to Donnybrook Road) Project will:

- Provide high quality, continuous, safe and accessible protected cycling facilities to cater for all ages and abilities to meet existing and future demand;
- Provide high quality greenway for walking, wheeling & cycling along the west bank of the River Dodder.
- Provide a section of the Dodder Greenway from Anglesey Bridge to Eglinton Terrace, beside Herbert Park entrance.
- Deliver improved pedestrian facilities by upgrading footpaths and installing a pedestrian crossings at Donnybrook Road.
- Contribute to a reduction in transport emissions in line with the objectives
 of the Climate Action Plan by encouraging a modal shift to active travel and
 public transport use;

TRAFFIC DIVERSIONS DURING CONSTRUCTION WORKS

The contractor for the project is required to prepare a works programme, which will include a detailed temporary traffic management plan to facilitate the construction works.

The majority of works will take place on the river bank. Where the works intersect with public roads, traffic management arrangements will be put in place. The majority of work will take place in the footpath which will typically result in a traffic lane being temporarily closed and repurposed as a temporary footpath. This means that for some periods during the works, inbound/outbound general traffic may be diverted around the works. When these diversions are in place, inbound and outbound routes for buses, taxis, cyclists and footpath users will be maintained through the area, and local access will be facilitated at all times.
