LIFE Programme Grants

On 1 June 2018, the European Commission proposed a regulation establishing a new <u>LIFE programme</u> <u>for 2021-2027</u> aiming to:

- contribute to the shift towards a clean, circular, energy-efficient, low-carbon and climateresilient economy, including through the transition to clean energy
- protect and improve the quality of the environment
- halt and reverse biodiversity loss, thereby contributing to sustainable development.

The Commission proposes €5.45 billion in current prices to be earmarked to the new programme containing two main portfolios, Environment and Climate Action, and covering four sub-programmes:

- 1. Nature and Biodiversity
- 2. Circular Economy and Quality of Life
- 3. Climate Change Mitigation and Adaptation
- 4. Clean Energy Transition.

This is 60% more than the previous period. \leq 3.5 billion will go to environmental projects and the remaining \leq 1.9 billion will be allocated to those on climate action.

The European Commission is increasing LIFE programme funding by almost 60% for the next period. LIFE will also expand into four new sub-programmes: nature and biodiversity, circular economy and quality of life, climate change mitigation and adaptation, and clean energy transition.

Nature and biodiversity – there will be more LIFE projects to help protect Europe's nature, thereby contributing to sustainable development. New 'Strategic Nature Projects' are also foreseen. These will help mainstream nature and biodiversity policies into other areas like agriculture and rural development. This sub-programme supports the implementation of the EU's Birds and Habitats Directives as well as the EU's Biodiversity strategy for 2030. It will also help develop the Natura 2000 network and contribute to the Invasive Alien Species (IAS) Regulation.

Climate change mitigation and adaptation – cutting greenhouse gas emissions, increasing climate change resilience and boosting awareness of climate change mitigation will remain a top priority. This sub-programme helps to make the shift towards a sustainable, energy-efficient, renewable energy-based, climate-neutral and resilient economy. To this end, LIFE projects will support the Commission's Climate Target Plan and its climate neutrality ambitions.

Circular economy and quality of life – LIFE projects will develop technologies and solutions to enhance the circular economy. Projects include the recovery of resources from waste, and others on water, air,

noise, soil and chemical management as well as environmental governance. These support the EU's Circular Economy Action Plan. Also, this sub-programme aims at protecting, restoring and improving the quality of the environment, either through direct interventions or via other policies. And it will continue to implement, monitor and evaluate EU environmental policy and law through Strategic Integrated Projects (SIPs).

Clean energy transition – this new addition will fund LIFE projects devoted to energy efficiency and small-scale renewables to support the Clean energy for all Europeans package. It will ease the transition towards an energy-efficient, renewable energy-based, climate-neutral and resilient economy. And it aims to remove the market barriers that can hamper the socio-economic transition to sustainable energy.

The Arts Council is the national agency for funding, developing and promoting the arts in Ireland. The Council recognises that the arts have a central and distinctive contribution to make to society.

The purpose of Partnership Funding is to invest in and support the essential infrastructure required to sustain and develop the arts in Ireland.

Recipients of Partnership Funding must play a critical part in delivering the policy priorities of Making Great Art Work, the Arts Council's ten-year strategy.

In offering Partnership Funding, the Arts Council wishes to ensure:

- The delivery of excellent art and/or excellent arts activities, events and services
- A supportive environment for the development of the arts
- Excellent professional-development opportunities for practising artists and/or arts professionals

Rethink Ireland - Urban Uplift Fund

The Urban Uplift Fund is a €662,821 two-year fund created by Rethink Ireland in partnership with JP Morgan Chase and the Department of Rural and Community Development via the Dormant Accounts Fund. The objective of the Fund is to back innovative projects working towards youth employment and/or youth employability in Dublin's most disadvantaged areas.

Following the last economic recession, Ireland had made great progress in reducing unemployment rates and barriers preventing people from entering the labour market. However, this progress has not benefited everyone in society on an equal basis and with the onset and impact of the Covid-19 pandemic, these inequalities have only increased.

The Urban Uplift Fund aims to address these barriers and enable young adults (aged 18-30) to reach their full potential by supporting innovative projects in Dublin which aim to secure employment and/or apprenticeships for young adults at risk of permanent exclusion and enhancing their full participation in society.

The Fund will aim to empower up to 120 young adults into jobs, apprenticeships or work experience programmes in the green and/or digital economy. In addition, it will aim to enable up to 75 young adults to complete certified training and up to 80 to progress on to further education.

Each session will entail a short presentation followed by an open Q&A session, offering you an opportunity to bring any questions you may have regarding the application process to the Fund team.

How Does the Fund Work?

There will be up to 4 awards available in total, and each Awardee will receive a cash grant (to a maximum of €55,000 each year across two years), mentoring support and placement on Rethink Ireland's capacity building programme programme.

Eligibility & Criteria

This fund is open to organisations that have a not-for-profit legal form, e.g. charity, social enterprise and other voluntary organisations.

Projects must meet both Rethink Ireland's criteria and the specific criteria for The Urban Uplift Fund, as set out below:

Rethink Ireland Criteria

- The project must address a critical social issue
- The project proposed must be innovative in an Irish context
- The project must be based on the island of Ireland and must make its impact in Dublin
- The project must have potential and a desire to scale or replicate in Ireland (it may also have potential internationally, but this is not a requirement)
- The project must provide evidence that it is up and running, or has been tested at least in a minimal way
- Applicants must come from an entity that has a not-for-profit legal form, eg:
 - A company limited by guarantee
 - A co-operative
 - Charity
 - And other not for profit legal forms.

The Urban Uplift Fund Criteria

The Urban Uplift Fund Criteria Applicants to the Urban Uplift Fund must be operating and make their impact in Dublin City. Projects should also meet the criteria below.

Projects/Organisations will:

- Focus on young adults aged 18-30 experiencing socio-economic disadvantage
- Provide a holistic wrap-around response to addressing the range of internal and external factors relevant to bringing young people closer to the labour market
- Support young people aged 18-30 into quality employment and/or apprenticeship programmes and/or full-time & paid work placements for young adults aged 18 – 30 through accredited and/or non-accredited training
- Projects and/or organisations that actively engage with young adults experiencing disadvantage in the design of their programmes.
- Projects and/or organisations whose are focused on the Green Transition/ Economy;
- Projects and/or organisations whose activities address the digital divide and the impact of inequality of access to technology.

The Urban Uplift Advantageous Criteria

Projects and/or organisations that are led by a member of their end-beneficiary community.

What does the fund offer?

- Cash grants up to €55,000 each year across 2 years

The Community Foundation for Ireland - Community Biodiversity Grant

With the support of the Department of Housing, Local Government, and Heritage, this fund has been devised to enhance biodiversity in communities throughout the country by combining the expertise of qualified ecologists with the skills, experience and enthusiasm of local community groups.

There are currently two grant rounds open to applications:

- 1. Developing Community Biodiversity Action Plan and Projects (CBAPPs)
- 2. Implementing recommendations from a previous CBAPP

Organisations can apply once to one of the grant rounds above.

All applications must meet the criteria for the Fund, any organisation or project that does not meet the eligibility criteria will not be successful in this grant round.

We recommend that organisations read through each criteria document before making a decision about applying.

Developing Community Biodiversity Action Plan and Projects (CBAPPs):

A grant to engage an ecologist and develop a Community Biodiversity Action Plan and Projects (CBAPP) for their local area. Within the scheme, three levels of grant funding will be offered:

Strand 1: Grants of up to €5,000 for community groups to work with an ecologist to classify their local habitats, assess their condition and extent, map them, and define a suite of actions to enhance biodiversity.

Strand 2: Grants of up to €7,500 for community groups who carry out the work outlined in Strand 1 in collaboration with one or two land managers/owners and particularly farmers, to classify habitats at landscape scale with a focus on field boundaries (hedgerows, treelines and stone walls), assess their condition and extent, map them and define a suite of actions to enhance biodiversity.

Strand 3: Grants of up to €10,000 for community groups who carry out the work outlined in Strand 1 in collaboration with three to five land managers/owners and particularly farmers, to classify habitats at landscape scale with a focus on field boundaries (hedgerows, treelines and stone walls), assess their condition and extent, map them and define a suite of actions to enhance biodiversity.

Implementing recommendations from a previous CBAPP:

This year, any organisation with a Community Biodiversity Action Plan is invited to apply for grants of between €1,000 and €5,000 to implement recommendations emerging from their Community Biodiversity Action Plans (CBAPs).

These grants will only be available to those groups who have submitted their full Community Biodiversity Action Plans and their full data set to the National Biodiversity Data Centre.

The Hospital Saturday Fund Charity

The Hospital Saturday Fund was founded in 1873, at a time when poverty, overcrowding and ill-health were prevalent and little help was available for those needing costly hospital care.

Eligibility

Which organisations may apply?

The Hospital Saturday Fund will consider giving grants to registered medical health charities within the United Kingdom and Republic of Ireland.

The Hospital Saturday Fund has two grant categories: - Standard grants of up to £2,000 or €3,000 OR -Large grants to up to £10,000 or €13,500 (please note this is the maximum sum that HSF will grant). Large grant applications should be towards specific projects, research or equipment rather than running costs. Organisations may make one application for a meeting and can apply for a standard or a large grant. The Grant Making Committee (GMC) meets quarterly.

What Support is Available?

For medically related charities, hospitals, hospices and medical clinics:

The Hospital Saturday Fund will consider giving grants towards medical capital projects, medical care or research and in support of medical training. The Hospital Saturday Fund will also consider grants for running costs.

For Individuals:

The Hospital Saturday Fund will consider giving partial or full grants to individuals for the following:

- Specialised mobility equipment, wheelchairs, mobility scooters, car adaptions, medical appliances and aids, hearing aids, nebulisers, specialised vision aids, specialised computer equipment, therapeutic equipment/treatment, orthopaedic beds, mattresses or pillows, riser /recliners chairs, lift hoist/aids.
- Physiotherapy, Hydrotherapy, Acupuncture, Speech Therapy, Osteopathy, Chiropractic treatment, Reflexology, Massage Therapy and Aromatherapy.
- Home adaptations, walk in showers, accessibility adaptations to bathrooms, access ramps, nonslip flooring, stair lifts.
- Respite breaks at a therapeutic centre.

We do not accept applications directly from members of the public. The Hospital Saturday Fund will only correspond with the supporter organisation and not the individual. If you are an individual in need, please approach a suitable organisation to make the application on your behalf. We are unable to take

calls from the individual applicant or potential applicant. Applications for individuals can be submitted at any time.

European Year of Youth - Micro Grants

The European Union has designated 2022 the European Year of Youth. This year will bring many exciting opportunities for young people and those who work with them across a variety of sectors.

There are four key priorities set out for the year, summarised below. You can see the full text in Article Two of the '<u>Decision (EU) 2021/2316 of the European Parliament and of the Council of 22 December</u> 2021 on a European Year of Youth 2022'.

- 1. Supporting young people, especially young people with fewer opportunities, to acquire a better understanding of opportunities available to them
- 2. Actively promoting the various opportunities available to young people at local, regional and European level
- 3. Supporting young people's personal, social, economic and professional development including through Youth Work
- 4. Celebrating young people and renewing the positive perspectives for young people, with a particular focus on the negative effects the COVID-19 pandemic had on them
- 5. Highlighting how the green and digital transitions and other Union policies offer opportunities for young people and for society at large
- 6. Ensuring a youth perspective is brought into policy-making at all levels.

About the European Year of Youth Micro Grant Scheme

To celebrate European Year of Youth 2022, we want to fund activities and events that:

a. shine a light on the great work that is already happening around the country during European Year of Youth

Or

b. support you to take this opportunity to try out something completely new in partnership with the young people in your organisation or community

And

c. Meet the priorities above.

What type of activities or events could be funded?

Any activity taking place within the Republic of Ireland before 31 December 2022 that support young people's engagement with any of the priorities listed above. This could be a

conference, consultation, workshop, a music event, an art exhibition, a photo competition, a mini festival, thematic meetings, a combination of events and online campaigns, information session, and so on.

Eligibility

A youth organization, school, club or other organised group or entity will need to be the named applicant for a grant. We welcome ideas from informal groups of young people or individuals working with young people; however, the financial responsibility and reporting obligation must remain within an organised group or entity.* If you are an informal group with no capacity to link in with an organisation to act on your behalf, get in touch with us at <u>eyy@leargas.ie</u>.

How much funding is available?

The grant you receive depends on the scale of your idea. You will indicate in your application the estimated cost of your project. There are three bands:

Small: €500-€1,500

Medium: €1,501-€3,000

Large: €3,001-€5,000

You will need to give more detail about your activities if you apply for a larger band of funding.

You will receive 80% of the grant upfront. You will receive the final 20% when you:

- complete your project
- submit a satisfactory final report and documentary evidence to Léargas.

What is a final report and what do you mean by 'documentary evidence'?

A final report is a written report explaining your activities and outcomes. It will have a similar format and level of detail as the application form.

Documentary evidence can be provided in the following formats: blog posts, videos, photographs, social media posts showing the results of your event/project, and so on.

Rethink Ireland - Social Enterprise Step Up Fund 2023-2024

The Social Enterprise Step Up Fund 2023-24 is a €700,000 two-year Fund created by Rethink Ireland in partnership with Tomar Trust and the Department of Rural and Community Development via the Dormant Accounts Fund. The key criteria that applicants will need to demonstrate are:

- That the social enterprise addresses a critical social issue
- That the social enterprise is innovative in an Irish context
- That the social enterprise is based on the island of Ireland and is making its main impact in the Republic of Ireland
- How the social enterprise is a sustainable business, generating traded income from goods or services

- How the social enterprise is mid-sized and at the right stage of development for this Fund, rather than at start-up or mature stage
- That the social enterprise has the ambition to further explore their business model with a view to scaling out or up after the programme
- That applicants come from an entity that has a not-for-profit legal form, eg:
 - A company limited by guarantee
 - A co-operative
 - o Charity
 - And other not for profit legal forms

The applications will also be assessed on how well they demonstrate their social enterprise:

• Has the potential to create additional jobs

Advantageous Criteria:

- Social Enterprises based within the Munster region
- Social Enterprises with a well developed, Board approved, 3-5 year strategic plan supported by financial projections that outline plans for scale
- Social Enterprises with the involvement of minority and/or beneficiary groups in leadership roles.

What is a Social Enterprise?

A social enterprise is a business that works primarily to improve the lives of people. Its business is social good.

Social enterprises are organisations whose mission is to have a positive effect on society. Social Enterprises are at the heart of facing the greatest social challenges in Ireland. They are professional and experienced, and use business skills and clever thinking to bridge the gaps in our society. The money they make from their work is used to grow what they do so that they can reach all the people in society who need their help.

Social enterprises are innovating every day by inventing and developing solutions to Ireland's most pressing social issues. They are creating meaningful jobs, tackling inequalities and supporting community development. We believe there is a need to foster and invest in these social enterprises to allow them to grow and spread their solutions.

What does the Fund offer?

The fund offers (up to) 6 Awardees an Awards package of up to €133,750:

Cash grants for up to 6 Awardees of €118,750

A Business Support budget worth €15,000

A place on the Accelerator Programme

Cash Grants

Up to 6 Social Enterprises will receive a package of supports worth a maximum of €133,750 each in total. This will include cash grants of €118,750, paid in four instalments upon delivery of agreed milestones.

Business Support Budget

In addition, Awardees will receive a budget for business supports worth €15,000 each. Business supports will be tailored to the specific needs of each project and carried out by approved consultants, focusing on creating social impact in line with their Theory of Change and strategic plan.

Accelerator Programme

All successful applicants will win a place on Ireland's first National Accelerator Programme specifically designed for social enterprises. The Accelerator Programme will equip social enterprises with the skills they need to scale and deepen their social impact.

The intensive and practical 2-year Programme provides training from best-in-class experts in the private, nonprofit and public sector on key functions such as Strategic Planning, Impact Measurement, Financial Management, Governance, Business Modelling, Pitching, Storytelling and more.

This scheme also targets the Irish language social networks, the general public and the arts sector on an all-island and international basis.

The Major Arts Events Scheme will be open to appropriate professional groups to allow them to develop major arts events or aspects of major arts events that are run and implemented through the medium of Irish or in which the arts language - based Irish as an integral part of them.

BAI - Sound & Vision 4

Sound & Vision 4 is a funding scheme for television and radio programmes, funded through the television licence fee.

Scheme basics

The Scheme is financed from the Broadcast Fund which comprises 7% of the annual net receipts from television license fees.

The BAI has been assigned the responsibility of administering this fund. The BAI Archiving Scheme is also financed from the Broadcast Fund.

The BAI will generally allocate funding using a funding rounds system.

For each round, the BAI determines the closing time and date; the types of applications that can be submitted and the amount of funding available.

Scheme objectives:

- Develop high quality programmes based on Irish culture, heritage and experience;
- Develop these programmes in the Irish language;
- Increase the availability of programmes referred to above to audiences in the State;
- Represent the diversity of Irish culture and heritage;
- Record oral Irish heritage and aspects of Irish heritage which are disappearing, under threat, or have not been previously recorded, and;
- Develop local and community broadcasting.

To achieve these objectives, the Scheme offers grant funding to new television and radio programmes which deal with the themes of:

- Irish culture, heritage and experience;
- Improving adult or media literacy;
- Raising public awareness and understanding of global issues impacting on the State and countries other than the State; and/or
- Any of the above in the Irish language.

Grassroots Sports Programmes and Infrastructure Innovation

A Preparatory Action - normally the successor of a successful pilot project on the same matter - is designed to prepare new actions like EU policies, legislation, programmes etc. with funding for not more than three years.

CALL OVERVIEW

This action intends to conceive and test innovative solutions to make supply and demand of sports meet.

CALL DETAILS

Grassroots sports is a traditional and slowly evolving area. Society in general and individuals' needs and preferences regarding sports, however, change more rapidly. Indeed, participation figures highlight a growing mismatch between the provision of opportunities for sports via traditional sports organisations and the demand for sports from individuals. The way in which sports associations and clubs are organised and their lack of innovation prevents them from bridging this gap. This project will challenge parties outside the traditional sports structure to propose innovative solutions to bring sports supply into line with individuals' demand at all levels, and provide a sports innovation ecosystem to make it possible for new ways of playing sports to be offered to the general public faster.

In order to produce a working innovative ecosystem for grassroots sports organisations, two things are needed: new, soft programmes offering sports in new ways, and a flexible sports infrastructure able to host different sports at a single location.

This preparatory action aims to identify and test multiple promising innovations in both categories. To achieve this, innovation challenges will be organised that select and reward promising innovations by any interested party (institution, company, start-up, individual(s) or other parties), which can be introduced and tested over a substantial period (minimum six months). The funding will be invested in soft programmes and new (small) sports infrastructure.

ACTIVITIES

Actions will promote new forms of practicing sport, such as (non-exhaustive list):

- adaptation of the existing infrastructure and development of light sport facilities, which directly complement the expected results;
- organisation of new forms of physical activities and integration with traditional activities to offer sport activities;
- innovative approaches to training programmes;
- intergenerational activities and outreach to young people to increase their participation;

• use of digital technology and social media.

ELIGIBILITY

In order to be eligible, the applicants (beneficiaries and affiliated entities) must:

- Be legal entities (public or private bodies)
- Be established in one of the eligible countries, i.e.: EU Member States (including overseas countries and territories (OCTs))

ACTIVITIES

Actions must promote the increased and active role of sport in sustainability and environmental transformation. The activities shall plan and implement methods aimed at making sport the role model industry in environmental transformation, especially for young generations.

Mohamed bin Zayed - Species Conservation Fund

The Fund will consider grants for the conservation of any threatened or poorly known animal, plant or fungus species.

Its focus is global and eligibility for grants will extend to all plant, animal and fungi species conservation efforts, without discrimination on the basis of region or selected species.

The Fund intends to be as flexible and accommodating as possible when reviewing applications, and to take into account as many different factors as is reasonable when assessing the merit of a suggested project. To support this and to try to streamline the application process, the review process is kept comparatively simple.

Grants will be awarded based on their ability to meet criteria pre-determined by the Species Fund, and are for maximum of \$25,000 for each project.

Criteria

Conservation status: The Fund was established to support species conservation work, and so if your project is not about an endangered species it is probably not worth your while submitting an application.

The Fund will use the IUCN Redlist (<u>www.iucnredlist.org</u>) as the primary guide to the conservation status of a given species, although documented variations for sub-species, distinct populations and subpopulations will be taken into account. For those species not assessed through the IUCN Redlist we welcome other methods of assessment and the submission of quantitative data to confirm a species status. Generally, the Fund gives priority to those species facing a high threat of extinction (with an emphasis on Endangered and Critically Endangered species), as well as those which are listed as Data Deficient or unlisted but are suspected as highly threatened. Please ensure that the conservation status mentioned in the application is correct and cross-referenced to a website or publication. It might be of use to consult with the relevant IUCN/SSC Specialist Group if you are in doubt or would like some guidance.

Please note that applications with clearly incorrect conservation status and no justification will NOT be considered for funding.

Content: Text provided in an application should be kept concise and clear, with clearly stated quantative goals, aims and methods. When writing an application, please bear in mind that there is only so much text which the Advisory Board and the Fund's board of directors are capable of reading. Priority will be given to those projects that support the professional development of young conservationists.

In situ conservation: Generally, the Fund is primarily interested in providing support to in situ conservation work in the field (such as survey work and data gathering, direct action, recovery
management, training and the like), focusing on the species in its natural habitat. However, the importance of ex situ work (genetic analysis, workshops, ex situ populations etc) is also recognised, and so a few grants may be given to projects which focus on ex situ conservation work in certain circumstances.

Core costs: The Fund will not contribute to the core running costs of an organisation or administrative overheads, and yet does recognise that sometimes support salaries, stipends, per diems and project related living costs can be a vital part of in situ conservation work.

Species: Generally, the Fund would prefer to support projects which focus on a single species, but it also recognises that in some geographic and taxonomic circumstances it makes more sense to group a number of species.

Grants for continuation: The Fund is happy to provide continuation support for a project which had previously been supported, which is now completed and for which the Fund has received all required reporting by the time of the respective submission deadline.

External review: In some cases the Advisory Board and/or the Fund's board of directors may ask for an application to be passed on for additional review, which may add to the response time.

Energy for Generations Fund

As a leading Irish organisation with deep roots in the community dating back to 1927, we are committed to playing a role in addressing some of the key social issues facing Ireland today.

Corporate Responsibility (CR) is at the heart of this vision. Through our Energy for Generations Fund, we have three main pillars of focus:

- 1. Suicide
- 2. Homelessness
- 3. Education Access and Support

Criteria

ESB's Energy for Generations Fund sees €1m per year disbursed through a quarterly fund to charities working in the areas of suicide prevention, homelessness and education access and support.

ESB has been supporting initiatives in the areas of suicide prevention and homelessness since 2005. The Energy for Generations Fund introduced a new focus on education in 2014, which recognises the need for educational supports at all levels to ensure that Ireland has the skills it needs to compete effectively.

Aim of the Energy for Generations Fund

Our aim with the Energy for Generations Fund is to maximise the impact of our investment by taking a more strategic approach to effect change. Funding is only part of the jigsaw – we also want to leverage the skills and knowledge we have within the company to bring about more sustainable and positive outcomes.

The guideline application amount is c. €15,000. This is neither a minimum nor a maximum, rather an indication of the scale of the resources available. Average funding awards in recent years have been c. €8,000 - €12,000.

Support for Staff Volunteering

The Energy for Generations Fund provides support to ESB staff who volunteer within their own communities. Staff who volunteer at least 20 hours of their own time per year will be invited to apply for funding of up to €250 for their chosen registered charity.

Many of our staff are involved in volunteering activities in their spare time, but we have never had any formal structure to support or encourage this in the past. Through this funding, our aim is to demonstrate our support for the work our staff do within their own.

How Does the Fund Work?

Charities working in the areas of suicide prevention, homelessness and education access and support can apply to the Fund for project specific funding.

Every quarter ESB allocates an amount from the Fund for disbursement. The amount may vary because of the volume of applications received or seasonal considerations - wintertime and Christmas may require more funding than summer.

Applications submitted during each quarter are appraised at the end of the quarter and funding allocated accordingly.

ASSESSMENT PROCESS

All applications must be submitted online no later than 12 noon on Monday 7th November 2022.

No applications will be accepted later than this date and time.

Your application will be processed by members of the Arts Office Administrative team. Any applications that clearly fall outside the eligibility guidelines and criteria may be eliminated at this point. Dublin City Council reserves the right to redirect applications for consideration to appropriate categories other than those applied for, should it be deemed beneficial to the applicant to so do.

All applications will be considered by the Arts Officer Team reporting to the City Arts Officer. Independent Assessors (with relevant experience and expertise) support the Art Officer Team who will make recommendations on all eligible applications.

Assessment of Neighbourhood, Voluntary & Community Mentoring Applications will be supported by the Area Offices of Dublin City Council through their Community Development section. All applications will then be assessed by a sub-committee of Elected Members of Dublin City Council from the Strategic Policy Committee.

An external assessor reviews the application process before the applications are submitted to the Elected Members. When approved by the sub-committe of Elected Members, final approval is sought from full meetings of the Elected Members of Dublin City Council.

TERMS & CONDITIONS

Revenue Grants 2023 are for Arts organisations that contribute to the realisation of the priorities and goals of Dublin City Council in a strategic way, and can act as effective advocates and promoters of the arts to the public, to partners in other agencies and public bodies. A Grant of €10k is guaranteed to each successful applicant.

Any increase on €10K will only apply to an application that has excellent content, with an emphasis on diversity, social inclusion and equality of opportunity. Applicants in this section may apply to other categories but if successful in Revenue will only be offered a Revenue Grant. Previous Revenue Grant recipients should not presume repeated levels of grant aid.

DEAR - Raising public awareness of development issues and promoting development education in the European Union

Funding programme

The EU Development Education and Awareness Raising (DEAR) programme promotes and enables active engagement of EU citizens, especially young people, in development issues and addressing global challenges at local and global levels

Call overview

The global objective of the DEAR programme and of this call for proposals is to achieve a more inclusive society with a developed sense of co-responsibility for local and global sustainable challenges (notably global inequalities and ecological crises). This call also aims to support the implementation of the Sustainable Development Goals.

Background

Global challenges (such as the triple planetary crisis - climate change, biodiversity loss and pollution -, inequality, irregular migration and others) have become more pressing in the last few years, some of them further exacerbated by the COVID-19 pandemic. This opens a wider door to overly simplistic solutions to complex problems, and potentially resulting in declining solidarity and increasing nationalistic tendencies. At the same time, the COVID-19 pandemic and the war in Ukraine provide momentum for our societies to become more aware of the global interdependence and the need to act in accordance with European values.

While young people are one of the groups most affected by these global challenges, the potential of their role and the impact of their actions are currently limited for various societal and structural reasons. Encouragingly, there have been, however, outstanding examples of youth movements, such as "Fridays for Future", which have a huge impact on the public discourse and showcase the important role young EU citizens want and can play in our societies at all levels.

Objectives

The specific objectives of this call for proposals are:

- More EU citizens, including youth, have a critical understanding of the interdependent world as well as of their own role in it and have the interest to act for sustainable development;
- More EU citizens, including youth, are actively engaged in sustainable development on local and global level
- Global Citizenship Education is better integrated into formal and non-formal education in EU Member States.

Priorities

This call for proposals will have five lots. For all lots, all actions, including financial support to third parties, if any, must contribute to:

- the global objective, and
- one or several specific objectives as defined in section 1.2., and
- one or several priorities as defined in section 1.2.

For lots 1 to 4, the lead applicant needs to be a Civil Society Organisation, for lot 5 the lead applicant needs to be a Local Authority. For all lots, lead applicants need to be established in a EU Member State.

Creative Europe - Perform EU

Creative Europe is the EU's funding programme for providing support to the culture and audiovisual sectors.

Call overview

This call aims to support cross-border touring and digital distribution of performing arts works, in a sustainable, inclusive, fair and innovative way.

Expected impact

This call for proposals will select one single project which will support a minimum of 35 projects over max. 36 months from all performing arts sectors, sub-sectors and disciplines (excluding live music performances). At least 70% of the grant amount should be spent in implementing the support to the projects selected through the open call(s).

Objectives

Applications have to address the following objective:

- To support cross-border touring and digital distribution of performing arts works, in a sustainable, inclusive, fair and innovative way.
- To achieve this, applications need to demonstrate that they are building on the pilot project implemented between December 2020 and June 2021, by providing touring opportunities for artists and companies as well as festivals and venues in diversifying and internationalising their programmes.

Applications will also need to address the challenges and the needs in the performing arts sectors (excluding live music performances) and strive to reduce inequalities and imbalances in cross-border touring and digital distribution of performing arts works.

Themes and priorities

Applications must address the following two cross-cutting issues (please refer to section 1 of the Call document):

- Inclusion, diversity, and gender equality.
- Environment and the fight against climate change.

Additionally, applications must show how the activities (work-packages) take into account the following dimensions:

- contributing to the creation of conditions that help the sector to 'grow' in a social, human, artistic, economic and environmental sense, with a long-term perspective.
- incorporating activities that proactively reach out to people, both performing arts professionals and audiences, from different geographical and socio-economic backgrounds, in order to ensure their equal access to distribution opportunities and a diverse artistic offer.
- incorporating specific support to Ukrainian artists, cultural professionals and organisations working in the performing arts sector. (See section 1 of the Call document - Background – Policy Framework).
- working towards a solid framework with an equal representation of various players in the performing arts ecosystem: the sub-sectors, the artistic disciplines, the size and type of the organisations, the balance between emerging and established artists, gender balance, and geographic location, the balance between urban and rural touring destinations.

Activities that can be funded

Applications must present a programme of activities that will develop, implement and maintain sustainable models for cross-border touring and digital distribution in the performing arts sector.

In line with the Call document Section 6 Eligibility, Consortium composition (below), the application must be submitted by a single applicant organisation or a consortium of partner organisations. This applicant (single organisation or consortium) may work with other organisations to implement the work programme, and these arrangements must be described in detail in the relevant sections of the application form (i.e. outside resources, subcontracting, associated partners and / or affiliated entities).

This call for proposals is open to a wide variety of activities, but applications must include the 5 following types of activities:

1. The design, implementation and management of open call(s) to select and grant (cascading grants) at least 35 projects to support cross-border touring and digital distribution of performing arts works. These cascading grant projects will be managed under the provisions of "financial support to third parties" (see Call document section 6 - Eligible activities) and implemented in the countries participating in the Creative Europe programme (see Call document section 6 – Eligible applicants). At least 70% of the total EU grant awarded to the successful applicant must be devoted to these cascading grants.

2. The development of a programme of support and assistance to the grant recipients including training, mentorship and capacity building

3. The maintenance and the development of the Perform Europe digital platform in order to:

collect data, explore, map and analyse how performing arts works are presented across borders

foster networking and matchmaking and bring visibility to performing and distribution opportunities

4. The development and the implementation of a communication, dissemination and branding strategy.

5. The management and the coordination of the overall project.

Eligibility & consortium composition

Proposals must be submitted either by a single applicant organisation or by a consortium of partner organisations which complies with the following conditions:

must be legal entities (public or private bodies)

established and officially registered in a country participating in the Creative Europe Programme (EU Member States - including overseas countries and territories (OCTs) - and non-EU countries : EEA countries and countries associated to the Creative Europe Programme or countries which are in ongoing negotiations for an association agreement and where the agreement enters into force before grant signature cf. <u>list of participating countries</u>).

must have had a legal existence for at least 2 years on the date of the deadline for submission of applications.

must register in the <u>Participant Register</u> — before submitting the proposal — and will have to be validated by the Central Validation Service (REA Validation). For the validation, they will be requested to upload documents showing legal status and origin.

Available budget

The available call budget is EUR 3 000 000. The grant will be a budget-based (actual costs, with unit cost and flat-rate elements). The costs will be reimbursed at the funding rate fixed in the Grant Agreement (max. 90% of eligible costs).

PPPA - Preparatory Action Writing European

Pilot projects (PP) and Preparatory Actions (PA) introduce new initiatives that might turn into standing EU funding programmes.

Call overview

This call aims to respond to the need for European storytelling suitable for co-production and that can travel across borders.

Scope

Increased global competition in the audiovisual sector makes international cooperation in scriptwriting ever more crucial. Such cooperation is particularly necessary at European level to allow European players to scale up and face the increasing risk of 'brain-drain' of European audiovisual professionals towards third countries.

The objective of the proposed scheme is to respond to the need for European storytelling suitable for co-production and that can travel across borders.

In addition, in order to bring out stories that reflect our European culture, both the one that we have in common and the one specific to our respective countries, we must encourage the emergence of strong teams of creators (e.g. screenwriters, showrunners, other authors, etc.) from several Member States.

Themes and priorities

The purpose of this preparatory action "Writing European" is to help the European audiovisual industry to develop excellence in creating and writing high-quality drama content and foster innovative storytelling. It aims to promote co-writing practices, thereby also enlarging the experience of creative talents working on fiction series.

Applicants are invited to setup creative hubs that can achieve the above objectives as well as the following priorities:

- Improve the knowledge and capacity of creative talents in the creation of fiction series and foster the emergence of strong teams/hubs of European creative talents (e.g. scriptwriters, editors, showrunners, producers) coming from diverse backgrounds and nationalities;
- Facilitate collaborations that follow a learning-by-doing approach, enabling creative talents to work on a set of different projects in parallel;
- Identify and implement working methods for co-writing, from the conceptualisation and early stage of storytelling, to matchmaking with potential buyers;

- Ensure contacts with industry leaders, producers or commissioners of audiovisual works (e.g. distributors, buyers, platforms, broadcasters) to enhance the talents' understanding of the market trends and dynamics;
- Scout and select talents, for instance through open calls or prizes;

Enhance the use of:

- innovative technologies and market intelligence that can affect the creative process (e.g. cognitive neuroscience, data analytics, artificial intelligence);
- intellectual property rights management as it secures creative autonomy and fair remuneration of creators.

Proposals should contribute to the green transition, embody European principles and values, such as equal treatment, diversity and gender balance, as well as fair remuneration of creators in line with market conditions and prices.

Activities that can be funded

Support will be given to projects that facilitate creative hubs, e.g. writing rooms or other collaborative settings, aimed at the co-creation of European audiovisual works. Such hubs will act as accelerators or incubators of talents, by proposing innovative methods to select and guide talented writers from pre-writing/conceptualisation to the actual writing of fiction series projects and potential matchmaking with buyers.

The projects should involve European talents as directly as possible. The objective of the action being enhancing and enabling creativity, talents across the EU should be empowered to intensify their cooperation. Authors should be working within ad hoc creative labs or writing rooms that have as primary goal the improvement of the creative process. At the same time, through exchanges with audiovisual professionals, authors should become more aware of the potential of their creative input, in artistic as well as in exploitation and dissemination terms.

Potential applicants and beneficiaries include production companies, film funding agencies, networks or groupings of audiovisual creatives or entities supporting creative talent, such as creative labs, training organisations, broadcasters, video on demand (VOD) platforms and international markets.

The following types of activities are eligible under this call for proposals:

 activities related to co-writing/concept development/pre-writing/conceptualisation for the creation of high-level European fiction series content (including through support to third parties such as scriptwriters, authors, showrunners, producers or other members of the creative team);

- activities of the collaborative hub/writers-room, in particular organising the process of cocreating European fiction series, including coordination tasks, mentoring activities, governance or management, activities of match-making with potential buyers;
- advertising or promotion, in particular to scout for new talents or organise a competition to ensure excellence and diverse participation in the project;
- activities aimed at the creation and dissemination of replicable innovative models and methodologies for writing high-end European audiovisual content;
- data studies, research, including the use of digital technologies that can affect the creative process (e.g. cognitive neuroscience or artificial intelligence tools) or market intelligence and audience measurements directly related to the needs of the project;
- dissemination activities and promotion of the project's results.

Projects that are already eligible in the framework of the Creative Europe Programme, are not eligible, such as:

- projects submitted by individual/a group of writers, scriptwriters, authors or producers aiming at the development of a pre-defined (slate of) audiovisual work(s);
- projects primarily focusing on training activities.

Expected impact

The project should involve creative talents throughout Europe. It should stimulate exchanges at European level and foster participation of creatives from different backgrounds in order to come up with stories that reflect the diversity of European societies. Ultimately, this will be a vector to reach out to new transnational audiences.

It is expected to catalyse innovation in the audiovisual creative process to encompass all mediums of expression.

Furthermore, it should ensure coherence between high-quality storytelling and high-quality audiovisual content, as well as enhance cross-border collaboration among European talents.

Eligibility

In order to be eligible, the applicants (beneficiaries and affiliated entities) must:

- be legal entities (in particular non-profit organisations, public or private bodies, educational institutions and research centres)
- be established in one of the eligible countries, i.e.: EU Member States (including overseas countries and territories(OCTs))

This call aims to develop knowledge on the use of online gaming culture and structure by violent extremists as well as their modus operandi through video game chatrooms, used as their recruitment tools.

Call details

Projects' results are expected to contribute to some or all of the following outcomes:

- Enhanced knowledge on the use of online gaming culture and structure by violent extremists as well as their modus operandi through video game chatrooms, used as their recruitment tools;
- European Police Authorities benefit from better, innovative and validated tools and training curricula (which take into account legal and ethical rules of operation, as well as fundamental rights such as privacy and protection of personal data) to tackle violent radicalisation through online gaming culture;
- Increased awareness of citizens about online radicalisation through gaming culture;
- Enhanced protection of youth in the gaming environment against recruitment into violent radicalisation;
- Improved shared understanding and cooperation between different actors involved, including security practitioners, gaming industry, social media, video game hosting services and civil society;
- Improved shaping and tuning by security policy-makers of regulation on preventing abuse of online gaming culture by violent extremists.

Activities to be funded

Research is needed to analyse the use of online gaming culture and structure by violent extremists as well as their modus operandi through video game chatrooms and forums. Regarding video games themselves, an in-depth analysis is needed on how the type of the video game, of its theme, design, aesthetics etc. plays a role in the choice of the chatroom to be used as a recruitment area. As far as video game chatrooms, including social media platforms discussing video games, are concerned,

dissemination strategies of violent extremists through them as well as their ways of grooming should be analysed.

Based on the results of these analyses, innovative (societal) means of fighting this type of crime, both online and offline, should be developed. The role of Police Authorities in this respect should be analysed. Possibilities of detecting and investigating this type of crime should be discussed as well, with a focus on legal and ethical aspects. Modern and effective awareness raising campaigns should be developed, that would target young people, parents, school teachers, video-gaming industry and wide communities, and that take into account the European multicultural dimension. Methods for evaluating proposed solutions should be developed as well. Suggestions to gaming industry on which traps to avoid when designing and upgrading a video game should be provided too

Proposed activities should take into account the evolving nature of this type of crime and of technology, and be performed while respecting the applicable legislation and fundamental rights, such as privacy and protection of personal data. Societal dimension should be in the core of proposed activities, with a support of technologies. The consortia should consist in Police Authorities, representatives of gaming industry, gaming experts, IT specialists, (cyber) psychologists and sociologists. This topic requires the effective contribution of SSH disciplines and the involvement of SSH experts, institutions as well as the inclusion of relevant SSH expertise, in order to produce meaningful and significant effects enhancing the societal impact of the related research activities. Social innovation is recommended when the solution is at the socio-technical interface and requires social change, new social practices, social ownership or market uptake. Participation of relevant Civil Society Organisations or gaming communities would be an added value. Analysis of the possible applications of research results to other similar problems (e.g. child sexual abuse) is welcome. Coordination with successful proposals under topic HORIZON-CL2-DEMOCRACY-2022-01-04 (Evolution of political extremism and its influence on contemporary social and political dialogue) should be envisaged so as to avoid duplication and to exploit complementarities as well as opportunities for increased impact.

Improving societal resilience to disasters or crises relies on various features related to preparedness of citizens, communities, education systems, public administrations, business companies and practitioners. These concern, in particular, ways to react and informed decisions to take in case of an event. Individual, public and multi-level actions are needed in disaster risk management and they have huge implications on potentially reducing losses and increasing the operational capacity of responders, along with significant impacts on the emergency planning and management phases and its relation to continuous operations and existing safety management. In particular, the level of awareness of EU citizens of the risks in their region is an indicator for measuring progress in increasing public awareness and preparedness for disasters and in the implementation of the Union Civil Protection Mechanism legislation.

Call overview

This call aims to better understand how to best raise awareness in the population in the event of a disaster or crisis situation.

Call detail

Human actions and behaviour may strongly influence the effects and dynamics of a disaster or crisis situation and on the response, potentially modifying the vulnerability of the population. For example, inadequate design of technological systems may favour cascading consequences due to limited consideration of human performance, and insufficient planning. Linked to this, due to extreme time pressure, crisis managers are often forced to make decisions on the basis of inadequate information. The behaviour of the general public, mostly influenced by demographic factors (e.g. gender, age, income, education, risk-tolerance, social connectivity etc.) and the perception of risks, depends on the availability, form and access to information about the crisis and management of trade-offs (e.g. efficiency and thoroughness trade-offs). Social media play an important role here being a means of disinformation and misinformation.

Scope

Citizens and local communities are insufficiently involved in the co-creation of socially innovative processes to develop security solutions and thus conceptions of what citizens and local communities know and think about security could be predominantly shaped by media coverage. This might result in bias in the assessment of the seriousness and probability of different security threats. Nevertheless, social acceptance of security technology depends on understanding citizens' awareness of security problems and threats.

Comprehensive discussion that involves citizens from all parts of society directly in co-design such as through Responsible Research and Innovation and social innovation, alongside other security technology actors, would integrate public concerns beyond incident-based interpretations of security threats, thereby increasing social acceptance of security technology and subjective feelings and perceptions of personal security in daily life. Call overview

This call aims at to address both societal and technological dimensions of trafficking in human beings.

Project detail

Trafficking in human beings is a serious and organised form of crime that involves the criminal exploitation of vulnerable people, the goal of which is the economic gain. This crime is often crossborder and consistently the vast majority of its victims are women and girls, around one fourth of all victims being children. Around half of the victims are EU nationals within the EU.

Trafficking can take place for various exploitation purposes, including sexual exploitation, forced labour, servitude, removal of organs, forced criminality (e.g., pickpocketing or drug trafficking). Trafficking in human beings is a grave violation of people's fundamental rights and dignity, and is explicitly prohibited by the EU Charter of Fundamental Rights. Understanding the nature, scale and costs of the crime is key to ensuring appropriate action at the European level to prevent the phenomenon. The 2017 Communication (COM(2017) 728 final) identifies as key priorities: to address the culture of impunity via disrupting the business model of criminals and untangling the trafficking chain; to provide a better access to and realise the rights of victims; to intensify a coordinated and consolidate response within and outside the EU.

- Security practitioners and policy makers are provided with an improved and more complete intelligence picture of trafficking in human beings, such as modus operandi, both offline and online, including the whole trafficking chain, cross-border dimension, new trends, relations with other types of crime, financial flows of the related profits, etc.;
- European Police and Border Guards Authorities benefit from better, modern and validated tools (including the lawful court-proof collection of crime evidence) and training materials to tackle criminal activities related to trafficking in human beings;

- Enhanced ability of security practitioners to detect and identify organised criminal groups involved in trafficking in human beings, in collaboration with citizens or NGOs when applicable;
- Enhanced ability of security practitioners to detect victims of all forms of exploitation, taking into account consistent patterns, and identify victims at an early stage;
- Enhanced ability of security practitioners to prevent the emergence of organised crime networks related to trafficking in human beings, to disrupt the trafficking chain at an early stage, deter organised crime groups related to trafficking in human beings and respond to the threat of existing organisations, as well as their potential expansion via de use of social media;
- Improved strategies of cooperation applied by European Police and Border Guards Authorities in fighting trafficking in human beings and dismantling related criminal networks, while respecting fundamental rights such as the protection of personal data, and improved cooperation between European and origin and transit countries authorities;
- Better policy-making related to the fight against trafficking in human beings.

Horizon Europe - Cluster 3 - Public spaces are protected while respecting privacy and avoiding mass surveillance

Horizon Europe is the EU's key funding programme for research and innovation.

Call overview

This call aims to identify means to protect public spaces through enhanced interaction with local communities and increase transparency for citizens towards surveillance systems.

Expected outcome

Projects' results are expected to contribute to all of the following outcomes:

- Improved understanding by local authorities, operators and policy makers of the effect of largescale surveillance of public spaces on the behaviour of citizens and possible negative effects on local communities;
- Enhanced transparency for citizens on different forms of surveillance by Police Authorities, local authorities and private actors in public spaces, and increased awareness of applicable rights towards operators of such systems;
- Improved protection of public spaces without the need for 24/7 data collection and storage;
- Set of common standards and good practices by local authorities, operators and policy makers for internal access restriction, anonymization and data minimization allowing a proportionate use of already installed surveillance-systems (such as CCTV) in public spaces, reducing the risk of misuse of collected data and respecting fundamental rights, especially the protection of personal data.

Scope

In recent years, the number of different tools for the surveillance of public spaces has been growing at massive pace in most European cities. CCTV-systems in public spaces are the most evident examples. They have been expanded in terms of quantity (number of CCTV in public spaces, such as squares, streets or touristic sites), quality (improved solution of images, possibility of tracking and automatic pattern-recognition) and also scope (CCTV present in areas like parks, 24/7 recording as standard due to higher data storage capacities).

CCTV-systems are the most evident and visible, although by far not the only ones. Acoustic sensors, Automatic Number Plate Recognition (ANPR) and in the future possibly widespread facial recognition add to a system of sensors that cover large parts of public spaces in many European cities.

While evidence suggests that such tools can help to combat certain forms of crime an increase the perceived security of citizens, the significant expansion of areas that are monitored risks to create negative effects for the right for privacy. Scientific studies indicate that also legal forms of behaviour are adapted by persons, which are aware that they are monitored by surveillance systems. Furthermore, there is evidence that such systems are often concentrated in socially deprived districts, creating the risks of stigmatisation of its residents.

In terms of crime prevention there are indications that for many settings, sensors like CCTV are in the best case only part of a solution and they can create a tendency of reducing personnel on the ground, thus limiting the possibilities for classical policing and reducing the direct interaction between local police and public order services and the citizens. Such interaction is however key to address crime prevention and response to criminal threats in a holistic manner.

Creative Europe - Support to Ukrainian displaced people and the Ukrainian Cultural and Creative Sectors

Creative Europe is the EU's funding programme for providing support to the culture and audiovisual sectors.

Call overview

The objective of the special call is to support Ukrainian artists and cultural organisations to create and showcase their art and works in Ukraine and in Creative Europe participating countries AND to help Ukrainians displaced by the war in Ukraine or Creative Europe participating countries, have access to culture.

Objective

Culture is one of the building blocks of any nation. Cultural expression and access to culture are indispensable elements to live and help us deal with traumatic events, build individual and collective resilience and a perspective for a post-war future.

The war in Ukraine has devastating effects on the Ukrainian cultural heritage and on cultural organisations and artists that cannot operate and reach out to their national and international audience. Additionally, many Ukrainian displaced people and children fleeing the war and currently staying in other locations in Ukraine or in other Creative Europe countries will not be able to return to their prewar locations because of destruction. Those staying in other Creative Europe countries will have to interact with their new communities to facilitate their integration. Culture and the arts have proven to be an efficient tool to connect people from different background and facilitate integration.

The objective of the special call is to help the Ukrainian cultural and creative organisations, as well as artists and professionals to address the following challenges in the short and medium term:

Objective 1 – short term

- support Ukrainian artists and cultural organisations to create and showcase their art and works in Ukraine and in Creative Europe participating countries
- help Ukrainians displaced by the war, in particular children, in Ukraine or Creative Europe participating countries, have access to culture and/or facilitate their integration into their new communities through culture. In this context, adequate attention should be given to the consequences the war inflicted on mental health

Objective 2 – medium term

- prepare the post-war recovery of the Ukrainian cultural sectors through needs assessments, capacity building and investment planning
- prepare and train Ukrainian cultural heritage professionals with regard to the protection of Ukrainian cultural heritage from risks.

The achievement of these objectives, especially the post-war recovery of the Ukrainian cultural sectors should be built on Ukraine's new status as EU candidate country.

Consortium composition

Proposals must be submitted by a consortium of at least two applicants (beneficiaries; not affiliated entities), which complies with the following conditions:

- at least one organisation of the consortium is based in Ukraine and
- at least one organisation of the consortium is based in another Creative Europe participating country.

Budget

Grants will be provided to consortium of organisations implementing activities for the benefit of a wider number of stakeholders (i.e., organisations and/or individuals). It will also support activities implemented by third parties, as explained below.

Support will be given to three projects, as indicated below:

Max EUR 2 000 000 to address objective 1.a: support Ukrainian artists and cultural organisations to create and showcase their art and works. Proposals addressing this objective should demonstrate through adequate experience a good capacity to finance a large number of small projects through cascading grants, as explained in the Call Document

Max EUR 2 000 000 to address objective 1.b: help through culture Ukrainians displaced by the war. Proposals addressing this objective should demonstrate through adequate experience a good capacity to finance a large number of small projects through cascading grants, as explained in the Call Document

Max EUR 1 000 000 to address objective 2 – medium term (including both 2.a - post-war recovery of the Ukrainian cultural sectors and 2.b - prepare and train Ukrainian cultural heritage professionals)

Eligibility

In order to be eligible, the applicants (beneficiaries and affiliated entities) must

- be legal entities (public or private bodies)

- be established in one of the eligible countries, i.e.:

- Creative Europe Participating Countries:
- EU Member States (including overseas countries and territories (OCTs))
- non-EU countries: listed EEA countries and countries associated to the Creative Europe Programme or countries which are in ongoing negotiations for an association agreement and where the agreement enters into force before grant signature (list of participating countries)

Horizon Europe - New railway station concept for green and socially inclusive smart cities

Horizon Europe is the EU's key funding programme for research and innovation.

Call overview

This call aims to develop a shared methodology for transforming railway stations into socio-technical systems operating as city's greening engines and new urban hubs.

Call detail

The project stemming from this topic should develop a shared methodology for transforming existing stations or designing new ones into socio-technical systems operating as city's greening engines for the surrounding environment, and new urban hubs aggregating multiple services for the users and its citizens. In this respect, the project will integrate and contribute to the EU-Rail Multi-Annual Work Programme – Flagship Area 4 – A Sustainable and Green Rail System as well as to the European Union New EU Urban Mobility Framework.

The R&I work should contribute to:

- The achievement of a climate-neutral society,
- The implementation of the UN Sustainable Development Goals (sustainable, smart and inclusive cities, transport and infrastructure, resources management, climate mitigation and adaptation, reduction in the emissions of greenhouse gases, health, environmental protection and biodiversity regeneration, sustainable land use, and gender equality),
- Railway stations to become connectivity hubs connect for multimodal mobility services, for passengers and goods, and the rest of the urban environment,
- Railway Stations will be inclusive and foster equal access to public transport for all
- Railway stations to become the new urban vital centre, fostering collaborative and circular economy, and social services,
- Ability to exploit the potential of railway stations as installations of advanced engineering solutions for sustainable solutions (stations as: infrastructure networks, multimodal freight terminals, telecommunications nodes, energy hubs, water distribution and waste disposal, etc),

- Ability to respond to health crises, natural disasters and resilience considering the modularity aspects that would make feasible to readapt or convert spaces to different typologies according to the needs,
- Bring together station managers, infrastructure managers and railway operators, local administrations, public and private transport operators, urban and logistic planners, new mobility service /delivery providers, Union institutions, , passengers and citizens' representative bodies, NGOs, and research institutions, but also other rail and non-rail (e.g. energy supplier/operator) industry, SMEs and start-ups as needed, around a common plan targeted to the urban environment surrounding while providing an institutional framework to the model that will be created,

The adoption of a EU wide model for the new railway stations, taking into account the local ad regional contexts, that should help local and national administrations achieving the following objectives:

- Foster territorial cohesion through public transport and alternative mobility solutions
- Decarbonise mobility and urban energy sources,
- Implementation of the circular economy principles within the businesses and services operated in the station,
- Promotion of new partnerships, especially between public administrations, large industrial groups, local institutions and SMEs while integrating citizens and collaborative small-sized solutions into the overall planning and policy-making process.

Scope

The project stemming from this topic shall contribute to deliver the expected outcomes and the R&I work includes:

- The development of analytical tools that will support the methodology for evaluating the costs and benefits of broadening the original purpose and functions of a railway station in the context of urban planning and mobility (from a simple departure/arrival point to a dense node of mobility, economic and social activities) as well as smart grids and energy performance (and any relevant station transformation),
- The definition of sustainability indicators (including social, economic environmental and resiliency dimensions) guiding the methodology, taking into account the existing Sustainable Urban Mobility Indicator.
- The definition of a common European-wide framework or methodology that, while enabling a sufficient latitude to accommodate specific local conditions or prevailing opportunities, may still guarantee opportunities to scale up the "model" to applicability across the EU. The requested methodology for enhancing the performance of new/existing stations integrated in smart cities

should cover, among the other expected outcomes described above, particularly aspects related to the energy behaviour (stations as energy hubs integrated in the smart grids and, as such, improving the energy performance of the smart city), aspects related to the mobility and urban planning, for both passengers and goods, as well as aspects related to users' experience.

- The implementation of at least four (4) specific pilot "Living Labs" (in four different Member States and including one station in regional areas serving capillary lines) that will investigate how stakeholders and citizenship can fully benefit from the new station model proposed for those specific pilots:
- It is expected that the applicant will setup the living labs making use of workshops, being the
 occasion to collaborate with local partners and civil society in order to understand which
 operative options can make railway stations and their surrounding neighbourhoods becoming
 the primary driver of sustainable practices of mobility, logistics and work, and resilient
 infrastructures able to readapt when necessary,
- Methodological criteria and quantitative/qualitative deliverables are expected to stem from the four pilots, tacking the co-design and the transformation of railway stations into multi-service infrastructures,
- A final conference for each pilot showcasing the achieved results should be organised.
- Take stock of the output of the new station model proposed for those four specific pilots and integrate the results to fine-tune the proposed European-wide methodology of the new railway station.

Eligibility

To be eligible for funding, applicants must be established in one of the eligible countries, i.e.:

- the Member States of the European Union, including their outermost regions;
- the Overseas Countries and Territories (OCTs) linked to the Member States;
- eligible non-EU countries including countries associated to Horizon Europe and low- and middleincome countries.

Any legal entity, regardless of its place of establishment, including legal entities from non-associated third countries or international organisations (including international European research organisations 1) is eligible to participate (whether it is eligible for funding or not), provided that the conditions laid down in the Horizon Europe Regulation have been met, along with any other conditions laid down in the specific call topic.

A 'legal entity' means any natural or legal person created and recognised as such undernational law, EU law or international law, which has legal personality and which may, acting in its own name, exercise rights and be subject to obligations, or an entity without legal personality.
