### Horse Drawn Carriages Bill

The proposed Department of Transport **Horse Drawn Carriages Bill** is listed again on the [Government Legislation Programme - Autumn Session 2022](#) (Pg. 15) published on 14<sup>th</sup> September 2022. The purpose of the legislation is *to repeal the Dublin Carriage Acts 1853-55 and relieve An Garda Síochána of responsibility for the regulation and licensing of horse-drawn carriages in Dublin and assert the power of local authorities, including Dublin City Council.* The status is listed on the Programme as “Work is ongoing”. It is not included in the ‘Priority Legislation for Drafting and Publication this Session – Autumn 2022’ category so it is unlikely that it will progress to Draft Bill this year.

Pending publication of the Carriages legislation, periodic multi-agency compliance checks have and will continue to be carried out under Control of Horses legislation.

## ANIMAL WELFARE UNIT STAFFING

The optimum Staff Structure for the Animal Welfare Unit reporting to Senior Executive Officer and Executive Manager, Housing & Community Services is as follows:

At present 4 of the 9 posts are filled, one of these is on an Acting basis. Updates are as follows:

- Following submission made in early July 2022 formal approval was received from the Department of Housing, Local Government & Heritage on 22<sup>nd</sup> September for the posts of **Animal Welfare Inspector and Assistant Animal Welfare Inspector**. Arrangements will be made with HR Department to proceed to recruitment for these posts as soon as possible.
- We are actively seeking interest among existing personnel who may be interested and suitable for assignment as **Animal Welfare Officers (X2)**.
- A request has been submitted for assignment of an additional **administrative post** to the AWU from the new Gr. 5 panel (Interviews currently underway).

### Training

The Department of Rural & Community Development arranged a **Dog Control Service Training and Networking Day** in Tullamore on Thursday 8<sup>th</sup> September 2022. Dublin City Council Animal Welfare Unit was represented at this event. There were a number of presentations and discussions on topical dog control issues by the Department, other local authorities and dog control practitioners.
