

Royal Canal Greenway Phase 3 Project

INFORMATION LEAFLET

The Royal Canal Greenway Phase 3 (RCGP3) project is part of the Dublin City Council (DCC) core active travel network. It is funded by the National Transport Authority (NTA). It will provide high quality walking and cycling facilities along the banks of the Royal Canal for a distance of 2.1km, extending from North Strand to Phibsborough. It is a primary route in the NTA's Greater Dublin Area Cycle Network Plan. The project includes public realm enhancements, signalised pedestrian crossings and tree planting.

This leaflet provides information on the construction works planned for 2023 and the upcoming public information evenings.

2 PROPERTY SURVEYS

3 PROJECT PROGRAMME 2023

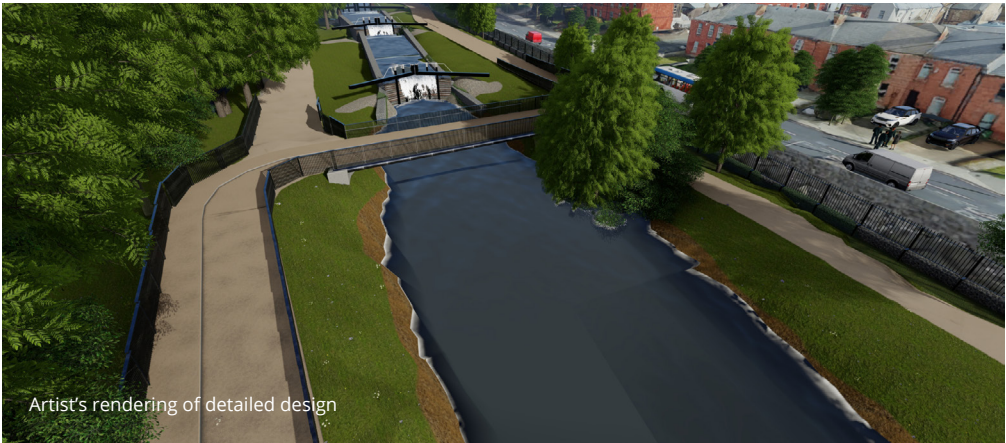
JCEL have been appointed as works contractor to the RCGP3 project. To date, temporary canal towpath closures were put in place in February 2023 to facilitate ground investigations and necessary tree felling. The towpaths have temporarily reopened to the public.

Major construction works are expected to start in April 2023 as follows:

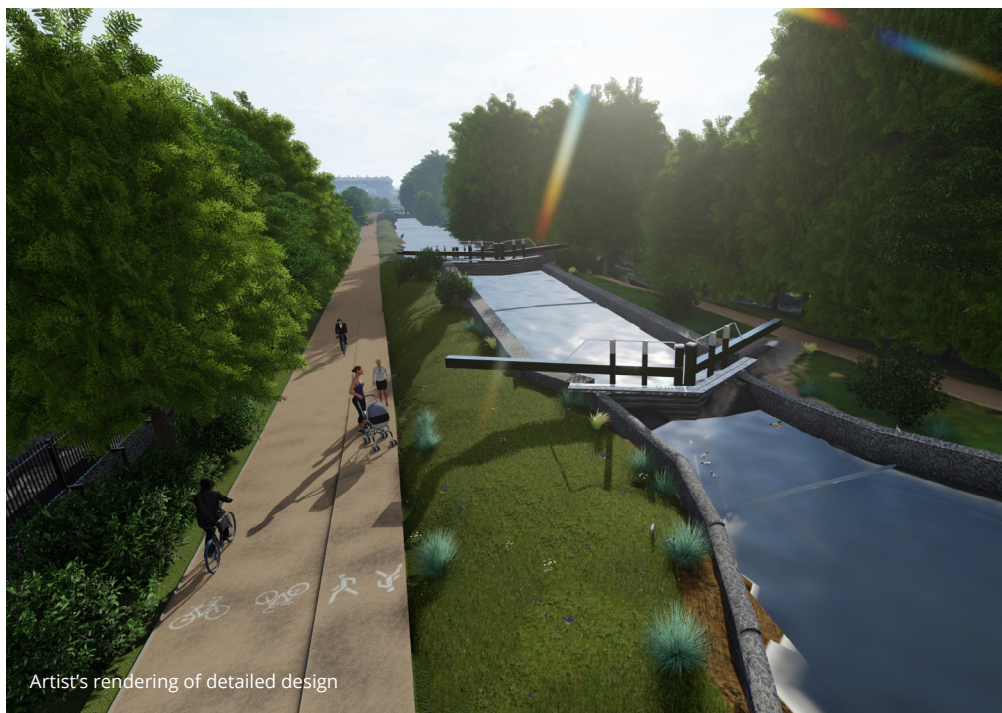
Towpath Section	Q2 2023	Q3 2023	Q4 2023
Summerhill Parade to Russell Street	Piling works to widen and strengthen canal bank	Ramp foundation construction to the east side of Russell Street	Ramp deck construction to the east side of Russell Street
Russell Street to Dorset Street	No works planned	Piling works to widen and strengthen canal bank (see note below)	Ramp foundation construction to the west side of Russell Street
Dorset Street to Phibsborough Road	Laying of pipes beneath the canal and construction of footbridge foundations	Construction of footbridge and installation of underground pipes	Construction of all works in this section

Note: Portland Place Park will be used as a works compound and access to the canal by JCEL. The park will be refurbished in consultation with the local community on completion of this project.

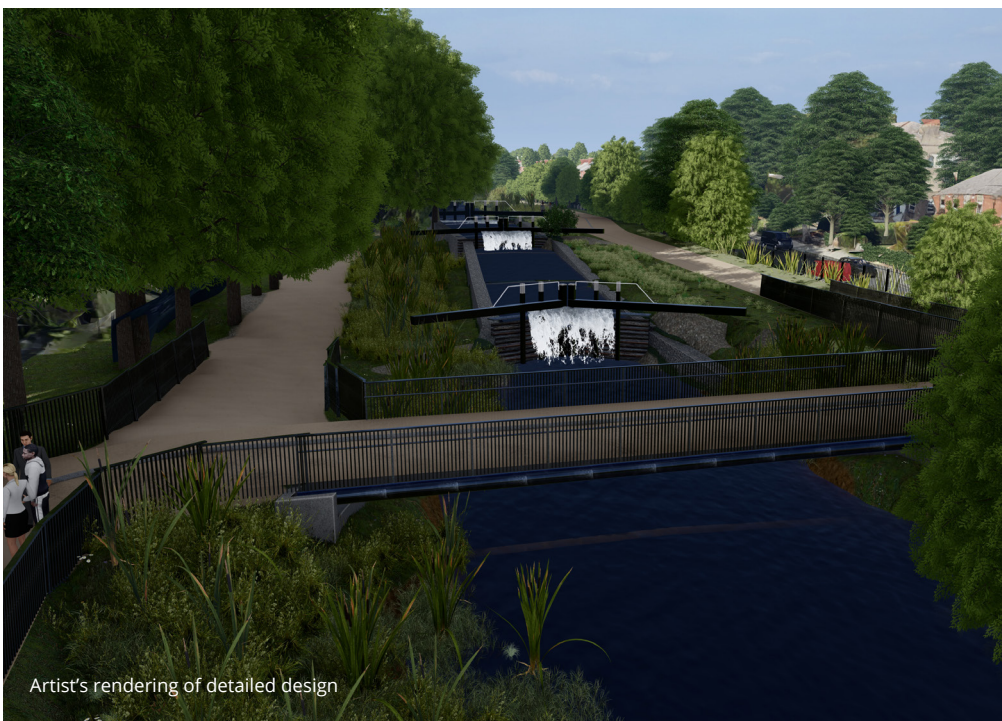
As works commence in each towpath section, they will be closed to the public until works are completed. DCC apologises in advance for any inconvenience this may cause.
