#### Set-up & Earthworks:

Site set-up complete. Bulk of earthworks complete. Administration & Welfare Building:

Work is continuing at roof level of the Administration & Welfare Building to install plant and screens as well as final works to roof lightwells which are almost complete. Water tightness test to be carried out on roof (spark test) before paving and sedum is laid.

Curtain walling installations are still continuing on all façades of the building with glazing completed. Work is continuing on the installation of brackets for timber and coloured fins along with external pressure plate covers.

Internal blockwork partition walls are completed on all floors along with 1st & 2nd fix Mechanical & Electrical installations continuing; particularly fitting of sanitary ware, showers and shower drains. Raised access floors are largely completed. Light fittings are being installed in the open plan office areas. Plasterboard bulkheads at ceiling/curtain wall junctions are substantially completed. Ceiling grids are mostly installed.

## **Multi-Storey Car Park:**

Multi-Storey Car Park external precast concrete panel installations are completed. Internal concrete works are mostly completed with floor coatings application now commenced on the top floor.

#### **Stores & Workshops:**

Central Stores internal block partitions are completed. The external canopy framing to the front of the workshops has been installed and the metal cladding is continuing.

External kerbing is completed and the base tarmac has been laid.

1st & 2nd fix Mechanical & Electrical installations are continuing for the Workshops.

Central Stores and Workshops sectional doors are now mostly installed.

The lift in the Signage Workshop has now been installed.

The super flat floor is now laid in the Central Stores ground floor.

#### Salt Barn:

The Salt Barn's Glulam frame is complete.

The roof covering is in place and the timber cladding to walls is continuing. The north elevation is completed with scaffold now being dismantled.

### **Civic Amenity Site Office:**

The Civic Amenity Site (CAS) Office construction is ongoing with external walls completed and rendered. Windows and doors have been installed. The roof is still to complete. Internal services installations are continuing.

CAS external kerbing completed and skip area concrete apron completed and base tarmac laid.

#### Other Site Works / External Works:

The permanent east side access is in use by the Contractor as the main construction access.

Works to the northern access (Junction 2 - opposite IKEA / Decathlon) are continuing with kerbing works to form the central island and entrance radii now mostly complete. Services installations completed and ducts for fibre crossings completed. Works will now take place to install bollards, gates and surfacing.

Works to complete Junction 8 (entrance to Civic Amenity Site (CAS)) is mostly completed.

Boundary wall section panel installations are completed around the CAS boundary and the depot's southern boundary. The boundary wall has been installed adjacent to the Seed Potato Company. Wall panels have been installed for the external material storage bays. The eastern boundary walls works are continuing including the Vehicle Wash area.

Works are continuing at the Waste Collection area. The ramp and waste bay walls are now completed. Waste bay floors are largely poured. The yard area is being prepared for concrete pouring.

Detailed design work for Contractor Designed elements is ongoing with regard to developing detailed designs/fabrication drawings by subcontractors and quality reviews by the Design Team for the following:
