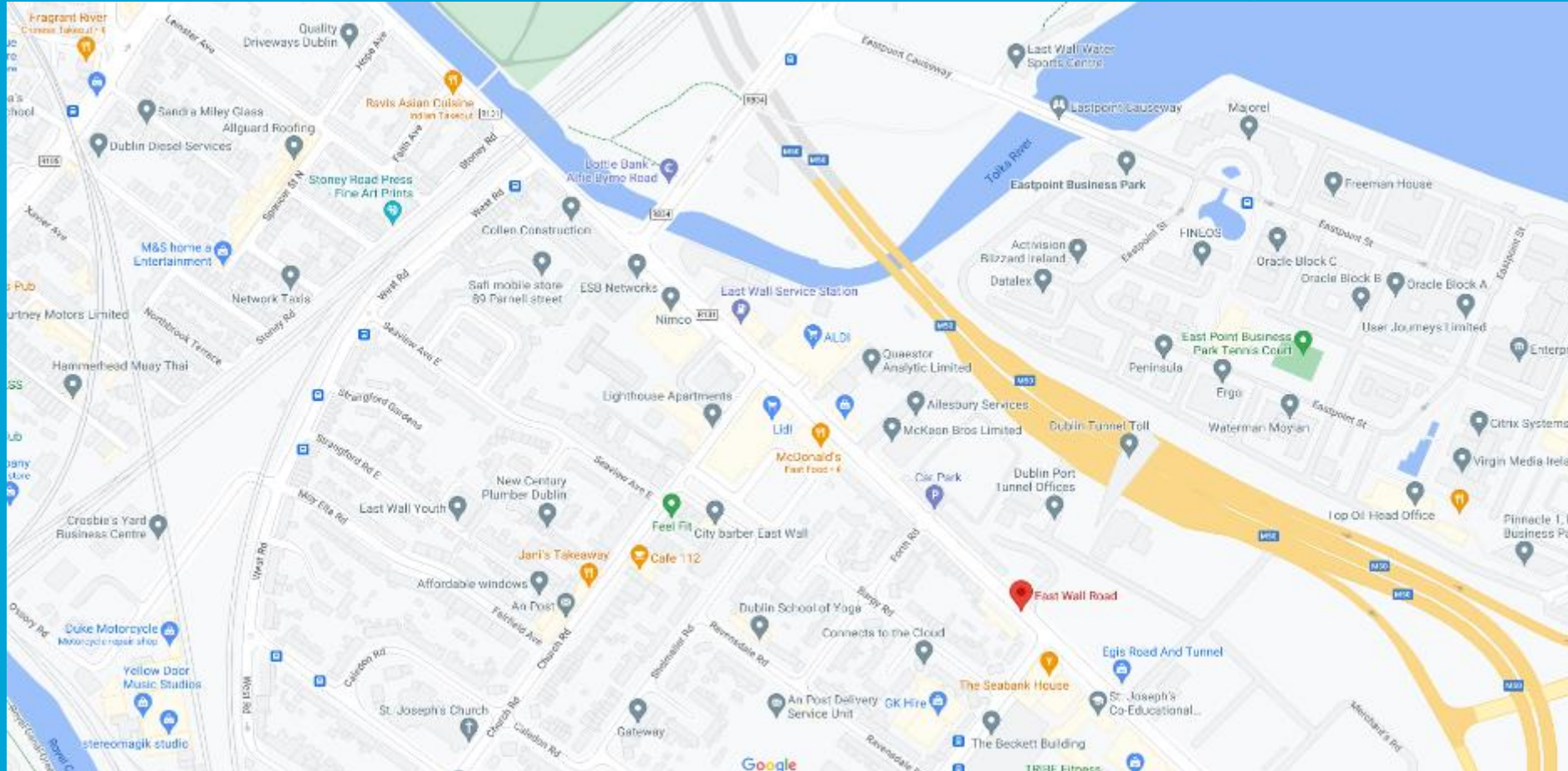

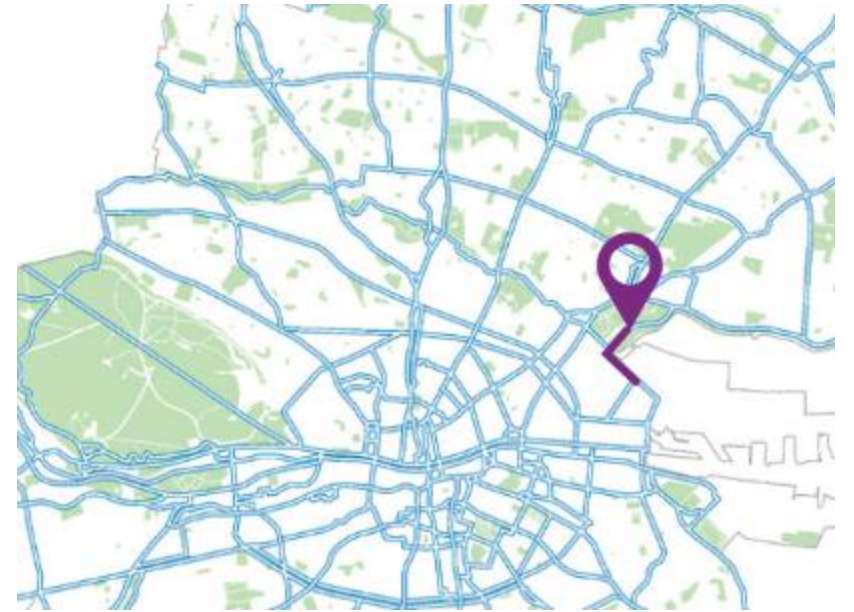

East Wall Rd/Alfie Byrne Overview

- 1 km of contraflow protected cycle lanes running from the Eastpoint Business Park to St Joseph's School
- Two New toucan crossings
- Removal of footpath parking and provision of dedicated parking bays
- Facilitation of cyclists and pedestrians commuting between Clontarf, Fairview, East Wall and south of the river
- Connection of St Joseph's School, Eastpoint Business Centre, local residents and a range of local businesses through Fairview Park and Alfie Byrne Rd to the Fairview, Clontarf and Sutton Cycleways
- Upgrade of the existing recycling facility on Alfie Byrne Road to include a dedicated set down area for vehicles
- Construction of a dedicated "School Zone" at St. Joseph's Co-ed. Primary

East Wall Rd/Alfie Byrne Update

- Tender Advertised January 2023
- Contractor formally appointed May 2023
- Mobilisation 19th June 2023
- Construction works begin 26th June 2023
- Initial work fronts will be adjacent to East Point Business Park and East Rd/St Joseph's Primary School
- Works to progress in sections along the route with access to be maintained at all times
- Works expected to run to Q2 2024

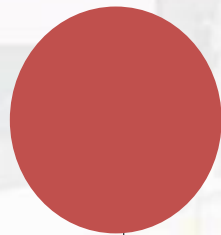
What is the NTA Cycle Design Office (CDO)

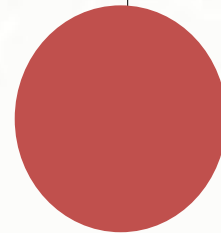

Contractor Introduction



- Circet Ireland (formerly KN Network Services) are the the largest telecommunications company in Europe and also operate transport infrastructure, public realm and rail divisions within the company.
- As a framework contractor for Dublin City Council for over 20 years we have extensive expertise in road construction, public realm, cycleway and traffic upgrade projects. We also carry similar projects for other local authorities including DLR Co Co, Fingal Co Co and South Dublin Co Co.
- Cycleway projects completed include the S2S Cycleway & Footway Project from Wooden Bridge to Causeway Road which included 2km of new segregated cycleway and all associated works (sea defence walls, watermain & service installations, pedestrian crossings, public lighting, road & footpath reconstruction). Other projects include numerous phases of the Grand Canal Cycleway for DCC, Luas to UCD & Wyattville Rd Cycleways for DLR Co Co and the 4km Grand Canal Cycleway from Chambers Bridge to Maynooth for Kildare Co Co.
- Circet carry out numerous junction and pedestrian crossing upgrades for Dublin City Council on an annual basis through the existing framework.
- Circet have also significant experience in road and traffic improvement works around schools and have just completed a Safe Routes to Schools project for FCC to improve pedestrian and cycle access to 3 schools in Ongar, Lusk and Verbana Ave.

Contractor Introduction



- East Coast Trail North project to commence in June 2023 with an estimated to run to Q2 of 2023.
- Works will involve traffic management with lane restrictions in place at various locations as the works progress.
- Circet will be liaising and coordinating the works with DCC Traffic, Gardaí, Emergency Services and other contractors in the area
- Advance notifications and project updates via letter drops will be issued to residents and businesses throughout the project
- Works in front of school, businesses, car parks, sites, etc will be coordinated directly with the affected party

The East Coast Trail North Phase 1 is part of the Dublin City Council (DCC) core active travel network. It is funded by the National Transport Authority (NTA).

It will improve walking and cycling facilities and provide safe crossings along a 1km route that extends from the entrance to the Eastpoint Business Park on Alfie Byrne Road along East Wall Road to its junction with East Road. A future phase of the project will continue the facility along East Wall Road as far as the Tom Clarke Bridge (commonly called East Link Toll bridge).

This leaflet provides information on the construction works planned this year.



Construction on this project is due to commence in June 2023. In order to deliver this complex but very worthwhile project for the city, there will be some unavoidable temporary disruption to the area. DCC, in collaboration with our contractor, will endeavour to minimise this as much as possible.

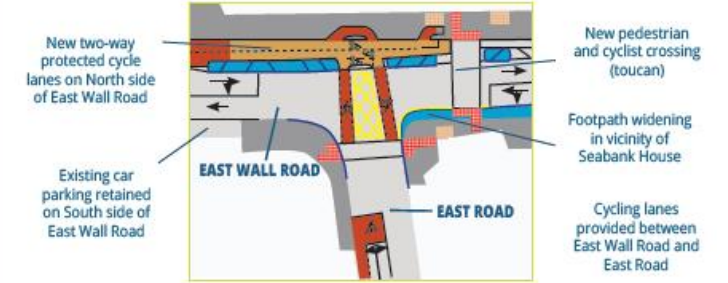
1 PROJECT OVERVIEW

The East Coast Trail North Phase 1 Project will:

- Upgrade existing pedestrian crossings and install two new ones
- Eliminate footpath parking on East Wall Road by providing dedicated parking bays
- Improve facilities for cyclists by providing a segregated two-way cycling route through the area
- Connect up with the new cycling and pedestrian facility currently under construction through Fairview Park
- Provide a "School Zone" in the vicinity of St Joseph's National School
- Upgrade the recycling facility on Alfie Byrne Road to include a set down area for vehicles
- Encourage walking and cycling in the area by providing improved facilities
- Contribute to a reduction in transport emissions in line with the objectives of the Climate Action Plan by encouraging a modal shift to active travel and public transport use

3 TEMPORARY TRAFFIC MANAGEMENT ARRANGEMENTS

The temporary traffic management arrangements during the works will maintain a minimum of two lanes of traffic through the project corridor, with a minimum of one inbound and one outbound traffic lane along East Wall Road and Alfie Byrne Road. Access to residential and commercial entrances will be facilitated at all times during the works.

Along some sections of the route, works may require reducing traffic to one lane for short periods. These works will be programmed at times when they will cause the least possible disruption. Some evening works will also be required.

In order to minimise disruption further our contractor shall regularly liaise with other contractors working in the area.
