

Dolphins Barn Area Compulsory Purchase Order 1948

Vesting Order Serial Number 2024/2

1. Whereas the land described in the **Schedule** hereto and shown on the map attached hereto which said map has been marked

"Dolphins Barn Area Compulsory Purchase Order 1948 - Map referred to in Vesting Order Serial Number 2024/2"

and sealed with the seal of the Dublin City Council (hereinafter referred to as "the local authority") is land to which the Dolphins Barn Area Compulsory Purchase Order 1948 relates, and the said order has become operative in so far as it relates to the said land;

- 2. And whereas the local authority have, at least six months prior to the date of this order, entered on and taken possession of the said land in accordance with the powers conferred upon them by the *Housing Act 1966*, s. 80, as applied by the *Local Government (No. 2) Act 1960*, s. 10 (as substituted by the *Housing Act 1966*, s. 86);
- 3. And whereas:
- (a) the several interests in the said land have not been conveyed or transferred to the local authority, (b) the local authority consider that it is urgently necessary, in connection with the purposes for which they have been authorised to acquire the land compulsorily, that the acquisition of the land should be completed, and
- (c) the local authority have made a proper offer in writing to each person having an interest in the said land who has furnished sufficient particulars of his interest to enable the local authority to make a proper offer for such interest;
- 4. Now therefore the local authority in exercise of the powers conferred upon them by the *Housing Act 1966*, s. 81, as applied by the *Local Government (No, 2) Act 1960*, s. 10, as substituted as aforesaid, hereby order that the said land shall, on 11th October, 2024 vest in the local authority in fee simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind (other than any public right of way).

Schedule

All that and those the lands containing 3813m² or thereabouts metric measure, and known as portion of plot of ground and portion of store, rear of 24, 25 and 26 Dolphin's Barn.




