
## SOUTH WEST INNER CITY ELECTORAL AREA

#### Housing

#### **Islandbridge Court**

The painting of the complex has been completed, including the community room, which was painted as part of the project.








The gates and railings throughout the complex have been freshly repainted.







The siding panels have been repainted to restore the playground's charm.



#### **Tyrone Place**

Painters are currently onsite and have begun painting the complex.

#### **Emmet Crescent**

A community clean-up day was held on the 8th of October with the assistance of DCC and the Family Resource Centre. This was followed by a very successful event to celebrate 21 years since Emmet Crescent officially opened, featuring a DJ, bingo, tea, and coffee.

Additionally, DCC and the Crime Prevention Officer from AGS have

completed a site survey to identify potential improvements around the Crescent. The report has been received, and the recommendations are currently under review.

#### **Pimlico Terrace**

Pimlico Terrace flats will receive additional stairwell cleaning by Housing Maintenance. The DCC Abandoned Vehicle Section will remove several abandoned vehicles in the Braithwaite St area.

#### **South Summer Street**

Illegally parked carriages have been removed from the South Summer St courtyard by An Garda Síochána.

#### **Meath Place**

Work will be carried out in the Meath Place flats courtyard to improve parking facilities.

#### Oisin Kelly Park

A volunteer group has completed painting and tidying work on the tarmacked pitch in Oisin Kelly Park.

#### Mary Aikenhead

All the stairwells in Mary Aikenhead are scheduled to be power washed, with chewing gum removal handled by a contractor.

#### **Robinsons Court**

A contractor has been chosen to install vehicle and pedestrian gates at Robinsons Court. Additionally, the overgrown vegetation in the area has been cleared.



#### **Basin Street**

Overgrown trees from the Basin St flat complex encroaching into The Haven will be pruned back soon. Additionally, the green area in Meath Place flats will be tidied up shortly.

#### **Developments**

An application for planning permission under Part 8 for the Basin Street Flats and

Forbes Lane Depot Site will be lodged and published in the *Irish Times* on 14th October.

A public consultation will take place on 22nd October at the F2 Centre, Herberton, Rialto, from 4:30 p.m. to 7 p.m., where plans for the Basin View site will be presented to local residents.

Representatives from the Area Office, the DCC Project Team, and Coady Architects will be available to answer any questions.

#### **Clinics**

The Basin St Clinic is held every second Wednesday at 11 a.m. in the Solas units at 26/27 Basin St. The next session will be on 9th October.

#### **Oliver Bond House**

Our design team recently visited Oliver Bond House and conducted a comprehensive survey as part of the ongoing regeneration project. All work being carried out is non-invasive, ensuring there will be no disruption to tenants during this phase. We are committed to maintaining residents' comfort and peace while progressing with these important assessments.

We are excited to announce that several new choice-based lettings have recently become available in our complex. We hope this will bring new opportunities for our community and welcome new residents. Additionally, we are exploring transfer options within the complex for those interested in relocating to a different unit.

The outdoor screens for displaying information have arrived! This new feature will significantly reduce our reliance on letter drops, streamlining communication. We expect installation to be completed within the next few weeks.

#### **Clinics**

The weekly clinic continues to run smoothly, and our collaboration with the

Try Project is also in full swing. This has been a great opportunity to reach more individuals and offer support through various initiatives.

#### School Street / Thomas Court Bawn

The next significant milestone for the redevelopment is the application for planning permission, which is anticipated to occur in spring 2025.

In the meantime, ground works will continue. All residents have been informed of these developments, and transfer applications have been sent to everyone.



#### **Weaver Park**

Following a small fire in the park and along the footpath, it was necessary to power wash the area.





#### St. Teresa's Gardens

The site at Teresa's Gardens has been officially handed over to Hegarty Demolition and John Paul Construction. The project involves the demolition of a four-story block of flats (Block 1) within the St. Teresa Gardens estate, including the removal of foundations and redundant underground services, diversion of certain existing underground utilities, site clearance, and additional site works.

Area Manager Frank Murphy and Project Estate Officer Melanie Lambert met with all involved agencies to facilitate the handover and provide the keys to the site.

An agreement has been reached to continue the services of Bidvest Noonan Security in the area, including Blocks 2 and 3, leading up to Halloween. This has proven to be highly effective in addressing issues related to anti-social behaviour in the community.










#### Housing

#### **Tristan Square**

The development is now fully occupied. The area housing manager attended a meeting of the residents with Tuath, the approved housing body managing the complex that is setting up a residents association. The local area office will support the residents to organise a Halloween party.

#### **Bluebell Waterways**

The LDA is continuing to prepare the planning application with the aim of lodging it before the end of the year. The local area office, and the LDA are continuing to engage with Bluebell Community Council and the Bluebell allotments holders.

#### **Sons of Divine Providence**

A meeting of the members with the project manager has been scheduled for Friday 18<sup>th</sup> October at 3.00 PM.

#### <u>Cherry Orchard - Site 1 of the Local</u> <u>Area Plan</u>

As stated at the briefing given in the September area committee meeting the Housing team are continuing to engage with the HSE on the land swap necessary to progress the Part 8 process for the link road. It is anticipated that the part 8 process will begin in late 2024/early 2025.

#### Site 2 of the Local Area Plan

As reported previously, work is ongoing in relation to the preparation of the technical design for the project with the public consultation now likely to take place in Quarter 4, 2024

#### Site 4 of the Local Area Plan

Planning permission has been granted for the development and the naming of the development was agreed at the September area committee meeting.

#### Rafters/Crumlin Road

DCC received Stage 2 approval for the project on the 26<sup>th</sup> September 2024. This gives project consent to progress towards the Part 8 stage. The project proposal is to provide a new social housing scheme with a mix of one, two and three bedroom homes.

#### **Labre Park**

Cluid have presented a CAS stage 2 funding application to DCC for review. This is currently being internally peer reviewed. Findings/comments will be provided to Cluid to update the application and submit to the DHLGH.

Submission to the DHLGH is expected in late October following DCC peer review. Part 8 application for Phase 1 is expected in January '25

As stated previously, Cluid and their design team are continuing to work through design options, conducting further investigations and awaiting results of the River Camac flood alleviation study

Investigations are ongoing in relation to improvement works to the exiting bays as reported last month.

#### Community

#### Halloween 2024

The South Central Area Community Team will be supporting Halloween Festival Events in Ballyfermot, Drimnagh and Bluebell.

The Ballyfermot Halloween Committee are well organised and planning a great day of activities on Thursday October 31<sup>st</sup>. Approx. 10 family friendly and free events will take place throughout the day starting with the Zombie Run in Le Fanu Park and a finale of fireworks in Cherry Orchard at 7:00pm. The vintage fire truck will be touring each event on the day, starting at the zombie run and finishing at Familibase. (Draft poster attached).

The City Council is supporting Neurovibe Tribe and D.10 ASD to host an accessible and inclusive Halloween themed space in the Ballyfermot Civic Centre on Tuesday October 31st. The space is aimed at supporting children and young people of all ages and abilities, with specific focus on supporting those with neurodiverse conditions. The Community staff have organised Halloween lantern crafts ad monster masks for the sensory events.

On Thursday 24<sup>th</sup> October at 11.00 AM in the Orchard centre Smashing Barriers, will perform a scene that will depict the Hierarchy of Disability, but with a Halloween twist. A common belief within both the non-disabled and disabled communities is the concept of a hierarchy of disability. Disability hierarchy positions certain impairments as more or less disabling than others, with the idea that some impairments are "better" or less severe than others.



The Council will also support the Bluebell Youth Project and Bluebell Residents Association with their Halloween Festival, (awaiting running order of events).

The Community staff are liaising with the local Community Gardaí, Dublin Fire Brigade, Animal Welfare and other organisations to provide safety talks in the area to target local primary schools and carry out a publicity campaign to remind children to stay safe and play safe over the Halloween period. The Community Development staff have organised

Halloween lantern crafts for the school talks.

The South East Area Community Team are supporting the Halloween event in Brickfield Park.

This year we are making a mini documentary of how the whole festival gets put together. Many thanks to local lady Amy Dodd for coming on board for this worthwhile project.

#### **Graduate Programme**

The South Central Area are delighted to welcome Oonagh O'Brien to the Community Development Team. Oonagh has now been with us for 4 weeks and is learning the ins and outs of community development. Oonagh is a Politics and Social Justice student and will be with us for 3 years.

#### **Environment**

Bulbs not Bonfires: The Council will provide local residents groups and Environmental projects with spring bulbs and encourage community planting days leading up to Halloween to promote positive activity and discourage bonfires.



#### Social Inclusion

The Ballyfermot Sports Complex will host a "Big Breakfast" in the Sports Complex on Gurteen Road on Friday Mornings, starting on Friday 11<sup>th</sup> October providing a free breakfast for their Neighbours and an open invitation to residents from the Rossaveal Sheltered housing complex.



The City Council is supporting the following events to take place during Integration and Inclusion Week which takes place from 11<sup>th</sup> – 17<sup>th</sup> November 2004

- The Ballyfermot Resource Centre opened their Community Welcome Room this month last year as a pilot scheme. The Welcome room provides a comfortable location where people can relax, feel at ease in a warm quiet space. Free tea /coffee and Wi-Fi is available and the room will be open daily initially from 4:00PM 8:00PM. The Welcome Room has been a huge success with constant footfall especially in the winter months.
- Chapelizod Tidy Towns will host a "Street Feast" event on the Plaza celebrating Chapelizod's culturally diverse community. They intend to have an open afternoon of "bring and share' dishes from different countries and music from around the world.


South Central Age Friendly Programme;

#### Ballyfermot, Cherry Orchard, Chapelizod:

The Community Team, DCC Housing, The Ballyfermot Community Civic Centre and Slainte Care are working together to upgrade the existing computers and Wi-Fi within the Ballyfermot & Chapelizod areas.

Kylemore College has offered to work with us to teach the residents on the use of the

new equipment. These will be in place in late October, early November.

#### Fr Kitt Court Animation Programme

Fr Kitt Sheltered Housing Complex animation programme will recommence from 16<sup>th</sup> September with chair yoga and a series of history talks and flower arranging workshops.



## Lord Mayors Autism Friendly Villages Initiative

On 17<sup>th</sup> September the Lord Mayor James Geoghegan invited DCC Community Development Teams to a meeting regarding Autism Friendly Villages. This involves collaborative work with community officers across the city along with local engagement that includes children and young people experiencing these conditions and their caregivers. This initiative will support ongoing and existing work regarding local needs in terms of autism awareness and support as it will be aimed at achieving the Lord Mayor's target of obtaining 11 Autism Friendly Villages/Communities i.e. one in each local area.

The initial meeting for Ballyfermot took place on Friday 4<sup>th</sup> October. With AsIAm, Ballyfermot Community Civic Centre, NeurovibeTribe and other interested organisations.

#### **Christmas Preparation**

The Community Team are working in partnership with the Ballyfermot Community Civic Centre, Liffey Partnership, Together FM, DCC Parks, Neurovibe Tribe and D.10 ASD to create a socially inclusive, affordable Christmas Market in The People's Park with two Santa Grotto's in the centre, one specific for children with special needs.

#### **Funding**

#### DCC Community Grants Fund

The Grants have been a great way to connect with the voluntary groups throughout the area and to support their initiatives. In addition to providing funding for groups our Community staff support the groups and encourage them to collaborate and play an active role in their area.

The grants are currently being processed and a report for approval by Local Area Committee will be provided for the October 2024 Area Committee Meeting.

Brendan Foster (Chair COIB), Anne Fitzgerald (Liffey Area Partnership) & Jim Curley (COIB) were present to award the Leaders in Learning recipients their 2024 bursaries.

Leaders in Learning (LIL) is a scholarship available to residents of Cherry Orchard. Funded by the Cherry Orchard Implementation Board, the LIL programme provides up to €1,500 for students studying third level and further education that can improve your future career.

Over 40 Cherry Orchard residents a year get support from the Leaders in Learning Fund to study a variety of courses including carpentry & joinery, beauty therapy, biotechnology, medicine and more.

#### **Public Domain**

#### Halloween 2024

The Public Domain Office is currently compiling a list of business and household's to forward to Waste Enforcement Section for investigation. Where Waste Enforcement suspect materials are being deliberately left out for collection for bonfires, they will initiate enforcement action.

It is an offence under Section 32 of the Waste Management Act 1996 for a person to "hold, transport, recover or dispose of waste in a manner that causes or is likely to cause environmental pollution" or to "transfer the control of waste to any person other than an appropriate person". This is a particular issue around Halloween with some businesses and household's leaving potential bonfire material accessible to passers-by.

The Public Domain Office will continue to monitor the situation and any business or household behaving in this manner will be reported to the Waste Enforcement Section for further investigation and possible prosecution, this could result in a fine of up to €5,000 or imprisonment for a term not exceeding 12 months or both. They may also be held liable to pay the costs and expenses incurred in relation to the investigations, detection and prosecution of the offence.

#### **Bonfire Materials**




From 1st October anyone can log a report of suspected Bonfire Material directly to DCC via Citizen Hub at <a href="https://citizenhub.dublincity.ie/Waste">https://citizenhub.dublincity.ie/Waste</a> or you can scan the QR code below.

Here you can report suspected Bonfire Material located on a Public Street or Laneway, Park or Green Area, Private Property or in DCC Housing Complex.

Simple log in or continue anonymously and then follow the on screen instructions. You will be asked to either drop a pin on a map or type in the address, you then select Pallets, Tyres or other. You can state if it's an immediate hazard and you can upload a photo. You will be asked to give a brief description of the amount of material you're reporting plus any additional information that you feel is relevant.






#### **Errigal Field Drimnagh**

The final phase will be the introduction of a natural play area, this final phase is open to review and subject to funding being available.


## Street Wash Programme across the Ballyfermot Drimnagh Area




#### Parking Awareness- Make Way Day



The annual Make Way Day was Friday 27<sup>th</sup> September 2024, unfortunately we continue to have issues with cars parked on footpaths, impeding pedestrian's, including those with mobility issues and young children in buggies and their parents etc.

Below is an image recently taken in Chapelizod Village, as you can see these two cars where completely blocking the pedestrian footpath, having no regard for others, forcing any pedestrians out onto the public road.





Parking Enforcement, on foot of a report from the Public Domain Office, took immediate action and Fix Penalty Notices were issued to the offending vehicles in this instance.

#### **Don't feed the Birds**

The Public Domain Office often receive reports of food being left out to feed wild birds on local greens and streets. Unfortunately, this food also attracts other less welcome visitors, such as rats. The Public Domain Office recently distributed the flyer below in the Walkinstown area due to such reports on a local green.

Depositing of food and other domestic waste in a public place is an environmental hazard and it is also an offence under the Litter Pollution Act 1997.

# Illegal Dumping, Graffiti, & miscellaneous anti-social issues in the Public Realm

The Public Domain Office continue to address the anti-social issue of Illegal dumping, graffiti & miscellaneous issues with the support of Waste Management Services, Parks Department and hired contractors. We endeavour to remove all such instances from the public realm. The Public Domain Office also engage with private land owners to remove illegal dumping or graffiti from their lands which is viewable from a public place. By engaging with private property owners, utility companies such as the ESB, Dublin Bus and Eir, to remove illegal dumping, graffiti or other issues regarding their infrastructure in the public realm.

#### <u>Abandoned Vehicle - St Agnes Church</u> <u>carpark</u>

The Public Domain Office received a complaint from St Agnes Parish Council, Crumlin, that they had been contacted by various sources stating that there was a van parked in the carpark beside the church that seems to have been abandoned. They believed the van to be a serious health and safety risk, as the windows were smashed and there was broken glass all around it. They stated that they had a real fear that the vehicle would be set alight or that children, who often play around this area, would attempt to get into the vehicle, and that they may injure themselves in the process.

As Dublin City Council lease this carpark from the Church the Public Domain Office investigated this complaint.



The Public Domain Office reported its finding to the Abandoned Vehicle Section, who in turn issued a 7 day notice on the van. The vehicle was removed before the notice period ended and subsequently a Waste Management crew cleaned up the broken glass left behind.
