

1. Whereas the land described in the **Schedule** hereto and shown on the map index no. SM-2025-0034, **attached** hereto which said map has been marked

'Map referred to in Vesting Order made under s. 17 of the *Derelict Sites Act 1990 (as amended by the Planning and Development Act 2000)* on the **13**th day of **February, 2025** by Dublin City Council'

is a derelict site within the meaning of the *Derelict Sites Act 1990 (as amended by the Planning and Development Act 2000)* (hereinafter called 'the Act');

- 2. And whereas the provisions of *s. 15* of the Act have been complied with by Dublin City Council (hereinafter called 'the Council') in relation to the said land;
- 3. And whereas no objection has been submitted to the Council under s. 16 of the Act;
- 4. Now therefore the Council in exercise of the powers conferred on them by *s. 17* of the Act, hereby order that the land described in the Schedule hereto shall, on **13**th day of **March**, **2025**, vest in the Council in fee simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind.
