### Procedure and Application Form

Dublin City Council is inviting applicants from our waiting lists who have selected Area E as their area of preference to express an interest in the above dwelling. This will be subject to Estate Management clearance. As the final offer is made to the applicant in the highest position there is no supporting documentation required as only position on your waiting list is considered.
7. All Applications will be examined on estate management grounds including rent arrears.
8. A successful applicant who refuses a Choice Based Letting will not be eligible for consideration for another Choice Based Letting Unit for a period of one year.
9. Under the choice based letting scheme only the successful candidates will be notified.
