4. Start date of CBL advertisement is 27<sup>TH</sup> JUNE 2025, End date 18<sup>TH</sup> JULY 2025 at 5pm.
5. If a number of applicants apply for the same property, the final offer will be made to the applicant with the highest position on list.
6. All applications will be examined on estate management grounds including rent arrears.
