Public Realm & Capital Programmes



An Update on Newmarket Square – A range of pedestrian improvement measures have been taking place at Newmarket since early spring. The first phase of work included removing large expanses of parking, installing a new pedestrian space on the south side of the square, expanding footpaths on the north side of the square and improving crossing points. This work was substantially completed in March.

Some outstanding works as part of this phase - to install a new drainage connection and to finish areas of tarmac with a coloured resin finish - will be completed over the coming weeks.

In addition to these civil works, all parking and loading arrangements around Newmarket have been reviewed and changes to lines and signage etc are underway. All parking in and around Newmarket will now be Pay & Display. Parking Enforcement has been active in the area since the installation of the new layout to enforce new parking and loading arrangements.

A large residential development is still underway at the west end of the square. Once this is completed later this year, footpaths, parking etc will be regularised at this end of Newmarket and along Ardee Street.

A suite of permanent street furniture including planters, seating and additional cycleparking stands will be installed in the Autumn. Planters will include small trees and shrubs and herbaceous plants. The various temporary bollards/zebra boxes etc will be removed.



The Area Office is actively working to programme new uses of the public space. The first of three Newmarket Flea Markets will take place on Sunday 20th July, marking the welcome return of outdoor markets to the area. The market operator will also be holding events in August and September.

The Heritage Office will also be holding open days of the south graveyard of the former St Luke's Church during National Heritage Week 16th to 24th August.

The ambition is to programme a diverse range of events, outdoor exhibitions and other uses of this new public space in future years.

Meath Street Public Realm Improvement Scheme – Advance works by the utility Uisce Éireann to renew underground water infrastructure on Meath Street is continuing. A revised schedule of partial road closures and service interruptions etc has been advised to businesses and residents by GMC (contractors for Uisce Éireann).

Tendering for the main public realm works contract is now underway.

The Iveagh Market – an announcement of the preferred contractor for planned emergency stabilisation and roof renewal work to the markets will be made in due course. The current expectation is to commence site work in the autumn.

Dolphins Barn Street Trees – work commenced on 9th July on street tree planting at a number of locations in Dolphin's Barn including St Anthony's Road, Haroldville Avenue and Reuben Street. The main civil works to create buildouts will be completed over the summer, with tree planting taking place later in the year when conditions allow.

Public Seating Installations – the Area Office is currently tendering for new seats and public benches for 12 locations around SWIC. It is hoped to install these features in Autumn. These seats will also contribute to wider Age Friendly initiatives by the Community Development team.

Economic Development

Smart D8 – the health and community wellbeing smart city demonstrator in Dublin 8, of which the South Central Area Office is a consortium partner, has announced three new pilot projects for 2025. These include projects to accelerate cancer screening with the use of AI, supporting remote heart health monitoring for patients living with heart failure conditions, and driving positive conversations around men's mental health through community football. Football Cooperative, a social enterprise, will be leading out on the men's mental health through community football pilot and its hoped the pilot will support greater use of under-utilised play spaces around SWIC.

Shopfront Improvement Scheme 2025 – this year's scheme is now closed. In total, 35 projects are being supported this year with small grants to assist with refurbishments. This includes 5 projects in and around Clanbrassil Street (an area which has heretofore had low takeup of the scheme).

Housing

Herberton - Clinic

Weekly clinic being held on Thursdays 10 a.m. to 12 p.m. in the F2 centre.

Robinson's Court

The newly installed vehicle and pedestrian security gate is operating with excellent efficiency, and both residents and the wider community have expressed great satisfaction with the outcome.

Oliver Bond House

The window replacement scheme is progressing well, with nearly 50% of installations now complete.

Emmet Buildings

The installation of the new MUGA (Multi-Use Games Area) football pitch has been successfully completed.



Mary Aikenhead House

Recent works have been carried out at Mary Aikenhead House, including the cleaning of garden areas. A schedule for regular maintenance has also been put in place.



Dolphin House - Clinic

A weekly clinic is held every Wednesday from 10 a.m. to 12 p.m. at the Dolphin House Community Centre.

Meanwhile Use Project

The Difference Days 'Meanwhile Use' project held its inauguration on 12th June. Despite challenging weather conditions, over 200 corporate sponsor volunteers turned out and carried out an impressive amount of work, contributing to a vibrant and positive atmosphere throughout the day.

A marquee on site hosted catering, and entertainment was provided by a local music group that included performances by children from the community. The formal launch of the project took place the following Monday evening.

The initiative transformed a previously disused plot within the Dolphin House flat complex into a beautifully landscaped space featuring tarmacked pathways, green areas, shrubs, a potter's polytunnel, community allotments, and a repurposed cargo container now serving as a *Men's Shed* unit. Additionally, a soft-pour Multi-Use Games Area (MUGA) was installed behind the community centre, further enhancing the facilities available to residents.





Tyrone Place / Emmet Crescent

The annual Family Fun Day, organised in collaboration with the Family Resource Centre, is scheduled for 17th July. Due to ongoing development works on Vincent Street West, the event will now take place on the grounds of the National School.

The breakfast which Dublin City Council host in collaboration with BeLonGTo saw 650 young people from across the country come to Dublin City Council's Civic Offices for a pre-PRIDE-parade breakfast party, which brought an opportunity for social connection and comradery before heading off to march in the 2025 Dublin PRIDE Parade escorted by An Garda Síochána, MaSamba Samba Band and DCC staff.

electrifying occasion and the Community and Social Development Team in SWIC hope participation in such will be the start of the team marking the occasion each year,

particularly looking at local events to work actively toward our work plan in meeting Goal 4 of the Dublin City Local Economic and Community Plan 2024 – 2024; Foster and nourish the City's communities to become more sustainable, thriving, safe, caring, welcoming, and inclusive. Objective 4.1; Encourage greater social inclusion, diversity and safety by working in partnership with and empowering individuals and groups across all communities.



Islandbridge Court Over the past three years, the Community and Social Development Team at Dublin City Council has been actively engaging with residents of Islandbridge Court. During this time, residents have successfully established a voluntary-led Summer Project and Youth Club and have played a key role in environmental enhancement initiatives within the complex.

Building on this progress, the team has recently met with residents to explore the formation of a formal Residents' Group. Dublin City Council will continue to support and guide local volunteers throughout this process, while encouraging ongoing active community participation and development within the complex.



Escape Room Initiative – June & July

2025 Building on the success of previous years, CORE Youth Service, Canal Communities Local Drug and Alcohol Task Force, and Canal Communities Regional Addiction Service once again opened their innovative Escape Rooms to the local community and services across Dublin City during June and July 2025.

The SWIC Community Team was pleased to support this creative and forwardthinking initiative by providing access to space within the Goldenbridge Integrated Complex.



This engaging activity invited teams of young people from across the city to Inchicore to solve a series of puzzles, riddles, and clues to 'escape' from themed rooms each one

designed around a different substance.

Through this unique, experiential-based learning format, participants were provided with non-formal drug and alcohol education that emphasised the serious risks associated with substance misuse.

Thanks to the ingenuity and dedication of the services involved, young people had the opportunity to learn in a dynamic and impactful way. Feedback from participating services has been



overwhelmingly positive, with reports indicating that some young people have significantly reduced use or in some cases, completely ceased their substance use because of their

involvement in the activity and continued youth work participation.

This initiative stands as a testament to the power of youth-led, community-supported non-formal education and their continued youth work participation.

The team linked in with both Oliver Bond Residents Group and the HSE Health Worker for Donore Ave. Pamela Carroll with a vision to support the roll out of two summer programmes in those areas.

These collaborations will see a wonderful summer projects and programmes of activities delivered to young people across the South West Inner-City Area and we hope each and every participant has a blast this summer!

Oliver Bond House Complex:

Over the past few months, the team have been busy planning and preparing for the implementation of this summer programme of activities, which will be delivered directly by the Community and Social Development team in collaboration with Oliver Bond Residents Group.

Several activities will also kindly be supported by Solas Youth Project, Liberties Community Project worker Liz Duffy, and Foróige Youth Service.

From July 14th – August 15th there will a series of 11 activities which young people from Oliver Bond House can register for - noting some activities are limited in spaces. All young people must be accompanied by a parent or guardian over the age of 18 for the direction of each activity.

This initiative is fully funded by the South Central Area Office and The Community and Social Development Team.

Lifelong Learning

The Leaders in Learning 2025 programme was launched, Funded by the COIB, the programme provides funding and support to residents of Cherry Orchard who are pursuing further and higher education.



Education

The group were informed that Cherry Orchard Childcare had been successful in their grant application for the crèche.

They are looking to open 3 new rooms for under 2s, offering 40 new places and an additional 9 staff with the project.

Community

As part of our events in Cherry Orchard for the month of June, we were delighted to host a workshop on Men's health by Nurse Ann from the Marie Keating foundation, which was followed up with a music session by the D10 Men's shed.





Slightly later than expected, we were then thrilled to welcome An Garda Síochána and the Saoirse group as part of go Purple day.



Cornamona Court

The team have been working closely with Liffey Partnership's Community Development Team and the residents of Cornamona Court in order to animate their common room.



After two consultations with residents, a list of events and activities that the residents would like to see has been compiled. Resident have also put themselves forward to help organise activities based on their individual interests. As we enter July, planning is well under way as we look to support & host local events as part of Ballyfermot/Cherry Orchard Arts festival. We will also be supporting a local summer camp throughout the month of July & August.



Both Community teams are in the process of putting together a schedule of taster activities so residents can see what these activities will look like and what running them will entail.

There has been fantastic enthusiasm from residents, and they are looking forward to the planned committee skills training so that they can get up and running. The DCC Community Team have also worked alongside Libraries in the Community to secure a collection of both children's and adult's books for the common room. It is hoped that this will aid book swaps, storytelling sessions and a book club which the residents have requested.

Healthy Age Friendly Homes

The team are working with Naomi Dixon, Local Coordinator for Healthy Age Friendly Homes to roll out information sessions in the coming months in our senior citizens complexes. The plan is to start with Claddagh Court and Fr. Le Mass Court.

Age Friendly Program

Our Sumer Age friendly Program concluded with an amazing talk from Historian Cathy Scuffil. All participants were extremely engaged, and the talk brought back many memories and stories from the audience.

The team are currently working on putting together an exciting Autumn Program and have been working on a special event with local radio station, Together FM.

Families in Emergency Accommodation – Get to know your neighbourhood day The Community

Team have organised a 'Get to know your area day' for families living in Emergency accommodation. We invited services in the area that would be useful for families to be aware of such as Familbase, The Ballyfermot Family Resource Centre and Liffey Partnership.



We have also arranged for Libraries in the community to come and sign families up for library cards and to let them know about events and services in their local branch.



Festivals

Great work is happening all across the South Central area in the many Community led festivals that are taking place with more due to happen as the summer unfolds.

The Community team would like to express how invaluable these activities are to the area and how positive it has been supporting the many services, organisations and of course the huge volunteer efforts that go into organising this array of events.

Also the Ballyfermot Cherry Orchard Arts Festival (19/07/25 – 27/07/25) which is packed with events to cater for all ages and tastes. From Wrestling to Traditional music sessions to History talks and family fun days.

Public Domain

Ballyfermot Civic Centre - Making it more Age, Disability & Hidden Disability friendly The Public Domain Office recently engaged a contractor to carry out some improvement works in and around the Ballyfermot Civic Centre to make the centre more accessible to the public. These works included:

1) The dishing of the cobbled footpaths in the carpark to facilitate full accessibility to the front entrance of the Civic Centre, the Centre is now fully accessible for those parking or accessing the centre from Drumfinn direction. The dishing of the cobbled footpath leading down to the bottle banks, also makes the bottle banks fully accessibility.





2) Installation of a new stainless-steel handrail at the steps to the front of Civic Centre, leading up to the Plaza from Ballyfermot Road. Again, improving accessibility to the centre from all directions.



3) A new pedestrian access gate beside the vehicle carpark entrance on Drumfinn Ave, with a clearly delineated pedestrian access route through the carpark to the bottle banks, and to the main entrance of the Civic Centre and Civic Centre plaza. Many members of the community including children use this route when walking to Little Bells Playschool, Mary Queen of Angels Boys Primary School, the Ballyfermot Sports Complex and to Glenaulin Park, be it for the GAA or Football etc.





1) Re lining the Civic centre carpark, including the provision of 2 additional disability parking bays for Centre visitors plus a "Hidden Disability" parking space and an "Age Friendly" parking space right beside the bottle bank area, for increased accessibility to both the centre and the bottle banks. (Please note these works are ongoing at this time and not fully completed)



The cost of these works were shared between the Ballyfermot Drimnagh Public Domain Office, with the use of Discretionary funding provided by our Elected Members, Waste Management Recycling Operations Public Domain Office and the Area Office.

I feel this initiative has greatly improve accessibility to the Civic Centre and to the public amenity of the bottle banks, while also improving the safety of members of the public who pass through the Civic Centre site daily, many of whom are young children.

I would like to thank all the elected members for their support and on this project, and Sid Daly Waste Management Services, Recycling Operations, and the Alice Corbett, Area Manager.

Animal Welfare – dead horse removal

Public Domain must sadly report that it had to arrange for the removal of the corpse of a small horse from the Development site located in between Cherry Orchard Hospital, Wheatfield Prison, and Cherry Orchard Football Club.

It was suggested locally that the horse may have died due to ingestion of Ragwort which is highly toxic to horses. However, the cause of death is ultimately unknown.



At the time of discovery, the horse remains where partially burnt. It is unknown if this was done before or after the sad passing of the horse. It has also been suggested that the horse was left unattended with no access to water and as a result died of dehydration.

This sad event highlights the importance of owner responsibility including Pasture Management by horse owners.



Horse owners need to ensure that where horses are grazing, that the pasture is well maintained and free from poisonous plants, and that the horses are eating high quality hay and have free access to water as a minimum.

Horses should not be left unattended in open fields where they could eat any number of toxic plants with dire consequences or become severely dehydrated because they have no access to water or shade.

Weeding Treatment Programme – halfway stage review

Below is a map of the Ballyfermot Drimnagh LEA highlighting the streets in the Ballyfermot Drimnagh areas and the dates that were treated on the 2nd round of treatment for 2025:

As you can see the Public Domain arranged for all streets in the Ballyfermot Drimnagh LEA to be treated on the 2nd round of this year's treatment programme. This was an additional preventative measure, normally we can only have 50% of the road network treated in any one year, hence roads usually only get treated bi-annually. This extra treatment should help reduce any major weed growth in the areas not on this year's full programme.



Anti-Dumping initiative – Free Mattress **Collection for Ballyfermot Drimnagh LEA** The Ballyfermot Drimnagh Public Domain Office is proposing a free Mattress Recycling collection initiative which recognises old mattresses as a resource that can be re-purposed for use in our Circular Economy. This initiative provides for the collection & recycling of old unwanted mattresses in August 2025. The scheme is limited to 150 mattresses and will be on a first come first served basis.

The Department of the Environment, Climate and Communications has made funding available, through the Waste **Enforcement Regional Lead Authorities** (WERLAs) to support this Anti-Dumping Initiative (ADI).

This Anti-Dumping Initiative serves to ensure that illegal dumping remains high on the agenda for communities across the Ballyfermot Drimnagh LEA and that the appropriate supports and interventions are available to combat the problem.

Illegal dumping is first and foremost a matter of individual responsibility and compliance with the law. While enforcement action is often taken by DCC enforcement teams, this Initiative facilitates a multi-facetted approach to tackling the issue.

The aim of ADI's generally is to reduce incidents of illegal dumping by providing funding for projects aimed at tackling the problem, the focus of the ADI's should be on; (i) prevention, (ii) abatement, (iii) education and (iv) enforcement.

This initiative will also looks to raise awareness of the Councils Bulky Waste Collection Service, another corporate initiative to alleviate illegal dumping. Education and awareness continue to play a key role in encouraging long-term behavioural change and it is hoped that this initiative will help inform and increase awareness of the importance of recycling and highlight that there are alternatives to illegal dumping.

Free Mattress Recycling Ballyfermot Drimnagh LEA WHY RECYCLE YOUR MATTRESS resses reduces the need for raw materials such as steel, foam, and woo hare used in their production. This helps conserve natural resources and reduces the mental impact of extracting and processing these materials. Mattresses are a Bulky Waste Item that take up a lot of space in landfill. By recycling then act significant amounts of waste from landfill, extending their lifespa ducing the need for landfill space. nproper dispotal of mattresses, such as illegal dumping or burning, lead to en ution. Regiding mattrasses helps prevent these harmful practices, reducing pollution and protecting the ecosystems Mattresses are builty items that take up a lot of space in andfill. By recycling them, we can swert's grinkcart amounts of waste from landhill, extending their lifespan and reducing the landfil space. How To Participate?
