Procedure and Application Form

1. All Applicants Must be listed for Area P. Do not apply if you do not have Area P as a preference.

or by completing the form and returning it to Housing Allocations, Block 2 Floor 1, Civic Offices, Wood Quay, Dublin 8

3. Start date of CBL advertisement is Friday 4th July @ 5pm, End date Friday 11th July 2024 @ 5pm.
4. If a number of applicants express an interest in the same property, the final offer will be made to the applicant with the highest position on the list. This will be subject to Estate Management clearance. As the final offer is made to the applicant in the highest position there is no supporting documentation required as only position on your waiting list is considered.
5. All Applications will be examined on estate management grounds including rent arrears.
6. A successful applicant who refuses a Choice Based Letting will not be eligible for consideration for another Choice Based Letting Unit for a period of one year.
7. Under the choice based letting scheme only the successful candidates will be notified.
