JUSTICE - Call for proposals for action grants to support transnational projects in the fields of e-Justice, victims' rights and procedural rights

The [Justice programme](#) is the EU's funding programme to support judicial cooperation in civil and criminal matters.

Call overview

This call aims to support transnational projects in the fields of e-Justice, victims' rights and procedural rights.

Call detail

The call for proposals aims to facilitate effective and non-discriminatory access to justice for all, and effective redress, including by electronic means (e-Justice), by promoting efficient civil, and criminal procedures, and by promoting and supporting the rights of all victims of crime as well as the procedural rights of suspects and accused persons in criminal proceedings.

This biennial call for proposals, under the Access to justice specific objective, covers two priorities:

- E-justice priority
- Victims' rights and procedural rights priority

Background

Digitalisation has the potential to improve the efficiency of justice, for example by replacing paper-based with digital communication and by allowing scarce human resources to focus on the essential functions of justice. Digitalisation can also tangibly contribute to increasing the resilience of justice systems in time of crisis. Similarly, progress on European e-Justice can support an effective European area of justice with regard to strengthening judicial cooperation and facilitating access to justice for individuals, legal practitioners and businesses.

Objectives

Facilitate effective and non-discriminatory access to justice for all, and effective redress, including by electronic means (e-Justice), by promoting efficient civil, and criminal procedures, and by promoting and supporting the rights of all victims of crime as well as the procedural rights of suspects and accused persons in criminal proceedings.

Themes and priorities

Priority 1 - e-Justice

The key objective under the e-Justice priority is to support the implementation of [Regulation 2023/2844](#).

Primary priority will be given to projects facilitating electronic cross-border interaction and communication between judicial authorities, as well as with citizens, businesses and practitioners in judicial proceedings.

Secondary priority will be given to projects aiming at joining or enhancing existing or ongoing e-Justice projects.

Finally, as tertiary priority, other e-Justice projects related to the development of relevant EU policies that are in advanced stage of development or already live on the e-Justice Portal at the moment when the call is published could also be financed.

National projects will be funded insofar as they offer a clearly demonstrated EU added value, for instance allowing to participate in EU projects, providing best practices for other EU Member States or promoting interoperability. Notwithstanding, transnational (multi-country) projects will have priority over national ones.

Activities:

Project activities under this call would in principle include analytical, conceptual, design and elaboration work, IT software development, quality assurance and related auxiliary measures necessary for the establishment of new IT systems, as well as the expansion and adaptation of existing national and transnational solutions towards addressing the objectives of the call.

Indicative budget: EUR 2 400 000

Priority 2 - Victims' rights and procedural rights

Projects to be funded under this priority should:

- contribute to the effective and coherent application of EU law in the area of the rights of victims of crime, notably in line with the priorities set up by the EU Strategy on victims' rights (2020-2025).
- contribute to the effective and coherent application of EU criminal law in the area of the rights of persons suspected or accused of crime.

In both areas (procedural rights and victims' rights), the Commission will consider proposals concerning possible future EU initiatives regarding gaps in EU legislation and policy where a further need for EU action is identified that would tie in with the existing

EU acquis/policy and its effective implementation. Projects ensuring maximum practical benefits and impact for the target groups will be assessed more favorably than theoretical projects consisting mainly of research and other analytical activities. Actions on access to information, support, protection to victims of core international crimes will also be considered. Successful projects shall ensure easy access to and wide dissemination of their results.

Activities:

The following activities can be covered:

- mutual learning, exchange of good practices, development of working and learning methods which may be transferable to other participating countries;
- exchange and provision of information and development of information and educational tools;
- capacity building for professionals, including training in victim-sensitive communication;
- facilitating cooperation between competent authorities (including where relevant national experts or agencies dealing with the aspects covered by this call) and/or legal practitioners and/or service providers (including multi-disciplinary networks at EU or international, national, regional or local levels) and/or civil society organisations / National Human Rights Institutions / Equality bodies, Ombuds Institutions and national authorities (at national and local level, where relevant, including experts with gender expertise);
- communication activities including dissemination of information about rights and activities raising awareness of the existing rules on rights at EU and national levels, relevant to the priorities of the call;
- training activities, as long as they are of ancillary nature and not the main purpose of the project;
- analytical activities, such as data collection and creation of data bases, surveys, research etc.

Indicative budget: EUR 3 000 000

Eligibility

In order to be eligible, the applicants (beneficiaries and affiliated entities) must:

- + be legal entities (public or private bodies)
- + be established in one of the eligible countries, i.e.: EU Member States (including overseas countries and territories (OCTs), excluding Denmark)

non-EU countries: countries associated to the Justice Programme or countries which are in ongoing negotiations for an association agreement and where the agreement enters into force before grant signature ([list of participating countries](#)).

Consortium composition

For priority 1 - e-Justice

Proposals must be submitted by a consortium of at least two applicants (beneficiaries; not affiliated entities), which complies with the following conditions:

minimum two independent entities from two different eligible countries

The consortium must include at least one public body, private non-profit organisation or international organisation as beneficiary (not as affiliated entity).

Proposals by single applicants or by a consortium from one eligible country are exceptionally allowed, but only if the project application clearly demonstrated potential for EU added value.

For priority 2 - Victims' rights and procedural rights

Proposals must be submitted by a consortium of at least two applicants (beneficiaries; not affiliated entities), which complies with the following conditions:

minimum two independent entities from two different eligible countries.

the consortium must include at least one public body, private non-profit organisation or international organisation as beneficiary or affiliated entity.

Project Duration

Projects should normally range between 12 and 24 months

Budget

The estimated available call budget is EUR 5 400 000.

Priority 1

Indicative budget: EUR 2 400 000

For priority 1 (e-Justice): Project budgets (requested grant amount) cannot be lower than EUR 100 000. The maximum requested grant amount is EUR 800 000 per project.

Priority 2

Indicative budget: EUR 3 000 000

For priority 2 (victims' rights and procedural rights): Project budgets (requested grant amount) cannot be lower than EUR 100 000. There is no upper limit.

For both priorities, the grant awarded may be lower than the amount requested.

The Arts Council - Partnership Funding

The purpose of Partnership Funding is to invest in and support local authorities/statutory bodies and Ealaín na Gaeltachta to sustain and develop the arts in Ireland.

Recipients of Partnership Funding must play a critical part in delivering the policy priorities of Making Great Art Work, the Arts Council's ten-year strategy.

What are the aims and objectives of Partnership Funding?

In offering Partnership Funding, the Arts Council wishes to ensure:

- The delivery of agreed Strategic Actions and outcomes as per your Framework Agreement
- The delivery of excellent art and/or excellent arts activities, events and services
- A supportive environment for the development of the arts
- Excellent professional-development opportunities for practising artists and/or arts professionals
- That more people will enjoy high-quality arts experiences, including more diverse audiences
- Increased engagement by the public with the arts – in particular, by new communities, people for whom access to the arts is difficult, and young people and children
- Standards of excellence in governance and management in the arts.

Who is eligible for the Partnership Funding programme?

Partnership Funding is open to Ealaín na Gaeltachta, local authority and statutory organisations only. Organisations can make only one submission each year for Partnership Funding.

To be eligible for application, your organisation must be a local authority or statutory organisation.

Partnership Funding is intended to support several strategic actions or strategic arts-activity costs of Ealaín na Gaeltachta, local authority and statutory organisations only.

NDA Research Promotion Scheme 2025-26

The National Disability Authority (NDA) is inviting proposals for our [Research Promotion Scheme \(RPS\)](#) 2025-26 from researchers, academic institutions, advocacy organisations, Disabled Persons Organisations, service providers or other relevant bodies

The RPS 2025-26 theme is Disability in Marginalised Groups and Communities with particular interest in proposals focused on disability issues in Traveller and/or Roma communities.

We anticipate awarding up to three grants and are open to individual grant applications for varying amounts between €15,000 and €40,000 with the total funding available not exceeding €80,000.

Applications are required to demonstrate meaningful involvement of disabled people in the research process as appropriate to the design of the study.

Interreg IVB - Northern Periphery and Arctic Programme

For 20 years, the Northern Periphery and Arctic Programme has provided a framework for regions to work together with a focus on promoting sustainable development in remote and sparsely populated communities.

The next programme will continue to do this, focusing on those themes and types of activities that are deemed to benefit most from transnational cooperation between the regions in the NPA area.

In the EU Member States, the Programme area covers Northern and Eastern Finland, Northern and Western Regions of Ireland, and Northern Sweden. Outside the EU, the Faroe Islands, Greenland, Iceland, and Northern parts of Norway belong to the Programme area.

Priorities

The NPA programme area is vast and participating territories are separated by long distances. Yet, similarities and linkages between the participating territories as well as common characteristics and shared development concerns in the NPA regions offer a strong basis for cooperation.

A more detailed description of the territorial features in the NPA can be found in [the Area Analysis](#). The Interreg NPA 2021-2027 will also seek a wider and more active engagement of young people in both the projects and the programme.

Through transnational cooperation, the Interreg NPA Programme addresses the challenges and opportunities in the programme area through 3 Priorities.

Funding / Budget

The final budget of the Interreg NPA Programme is 51,5 million euro. Between 2021-2027, the Programme will allocate 46 833 778 Euros to projects, of which 39 978 162 EUR in European funding (ERDF) will be available to partners in Member States (Finland, Ireland, Sweden) and 6 855 616 EUR for partners in the Non-EU partner countries (Norway, Iceland, Faroe Islands, Greenland). The remaining amount will cover programme administration costs, so called Technical Assistance.

The funding available for projects has been distributed as follows:

- Priority 1 Innovation capacity: 45%
- Priority 2 Climate change and resource sufficiency: 45%
- Priority 3 Cooperation opportunities: 10%

The Programme is financed through European Regional Development Fund (ERDF) and ERDF equivalent funding from the Non-EU partner countries, supplemented by match funding from projects.

Projects apply to the Programme for ERDF or ERDF equivalent co-financing and contribute to the project with public or private match funding.

How to Apply

Call overview

Projects funded by the Interreg NPA programme are invited to join efforts and submit a clustering project application that leads to better outputs and results.

Call detail

In 2017 and 2018, the NPA programme funded projects to encourage clustering activities between ongoing projects in Interreg programmes in the Arctic. Clustering activities were to take place with the objective to diversify and capitalise on outputs and results from two or more previously implemented or ongoing projects. Based on previous experiences, the Interreg Aurora and NPA programme administration want to encourage clustering activities between the two programmes through a common/coordinated call. Interreg Aurora will fund cross-border clustering projects and Interreg NPA will fund transnational clustering projects.

Expected outcomes

A clustering project is in general intended to lead to better outputs and results from the involved projects and a greater outreach for the dissemination of the results from the two programmes. Clustering projects are expected to give a higher profile to topics relevant to people living in the Arctic and contribute to the practical implementation of the EU Arctic Policy in communities. Examples of outcomes are:

- Projects collaborating to explore transferring of project outputs to other organisations, sectors and/or regions, for example disseminating result and outputs beyond their ongoing or completed project activities.
- Projects collaborating to maximize the cross-border/transnational impact of existing outputs on local level, to end users or widening the preparedness for cooperation to other beneficiaries, for example by organising collaboration initiatives that connect end users across regions.
- Projects collaborating to increase the awareness of the cross-border/transnational added value and the potential of cooperation. The establishment of a lasting network could be one such activity for example.
- Projects with complementary skill sets collaborating to focus on improving (the uptake of) project outputs.
- Projects collaborating to gain critical mass to inform decision makers.

Eligibility

Small-scale transnational clustering projects must involve partners from at least 3 NPA programme partner countries. At least one partner from an ongoing or finalized project funded by the 2021-2027 Interreg Aurora programme and at least one partner from an ongoing or finalized project financed by the 2021-2027 Northern Periphery and Arctic programme. New partner(s) could be included, provided that there are clear synergies.

The partners in a transnational clustering project need to fulfil the Interreg NPA programme requirements for eligible partners, and they are expected to be located in the NPA area.

Partnerships are recommended to include at least 2 of the 3 geographical zones of the programme area: Finland-Sweden-Norway; Ireland; Faroe Islands-Greenland-Iceland.

In addition to expectations outlined in the Interreg Regulation, Lead Partners have to meet the following criteria:

- They are a public sector organisation.
- They are based in the NPA Programme area, unless they have a national remit that covers the Programme area.

Budget

The maximum total eligible project budget is 200 000 EUR, with a financing rate of 65% for all partner countries, except for Norwegian partners with a 50% intervention rate.

Duration

12 months for project activities, excluding final reporting.

Community Foundation Ireland - Circular Economy Innovation Fund 2025

The Circular Economy Innovation Fund is designed to support innovative circular economy projects led by social enterprises, voluntary and community organisations, and small businesses with fewer than 50 employees. Since its launch in April 2021, the scheme has awarded €1.8 million to 36 projects, spanning key circular economy themes such as food waste, plastics, single-use packaging, construction, textiles, and general waste.

Following a successful 2024 call, the scheme will once again be administered in partnership with Community Foundation Ireland, a philanthropic hub that connects donors, grantees, and communities committed to positive social change. The Foundation will manage the application, evaluation, and administrative processes, and provide ongoing support to successful applicants.

For the 2025 round, €650,000 in total funding is available, with individual grants expected to range between €40,000 and €50,000.

Projects should focus on priority areas for Ireland's circular economy, including:

- **Plastics:** Redesigning products or packaging to replace non-recyclable or virgin plastic with recyclable alternatives
- **Construction and Demolition Waste:** Creating reusable construction products or enabling selective demolition for material recovery
- **Food Waste:** Implementing technical or behavioural interventions to reduce waste in production and commercial settings
- **Resources and Raw Materials:** Enhancing recovery of critical raw materials and reducing hazardous substances in products.

Horizon Europe

Horizon Europe is the EU's key funding programme for research and innovation.

Aims & Objectives

It aims to:

- strengthen the EU's scientific and technological bases and the European Research Area (ERA);
- boost Europe's innovation capacity, competitiveness and jobs;
- deliver on citizens' priorities and the Sustainable Development Goals

What does it support?

It funds actions under its three pillars and one horizontal activity:

- Pillar 1: Excellent Science aims to increase the EU's global scientific competitiveness. This pillar includes the Marie Skłodowska-Curie Actions which fund the development of excellent doctoral and postdoctoral training programmes and collaborative research projects.
- Pillar 2: Global Challenges and European Industrial Competitiveness supports research relating to societal challenges and reinforces technological and industrial capacities through its seven "clusters" or themes.
- Pillar 3: Innovative Europe aims to make Europe a frontrunner in market-creating innovation via the European Innovation Council.
- Widening Participation and Strengthening the European Research Area: This horizontal activity will increase support to EU Member States in their efforts to make the most of their national research and innovation potential.

Who can apply?

- Academia and higher education institutions
- Researchers and research centres
- Public bodies (local, regional, or national)
- Industry and private businesses
- Non-governmental organisations and nonprofits who would like to promote and facilitate engaged and ethical research into issues impacting their beneficiaries.

Clean Energy Transition Partnership

Research Ireland and the Sustainable Energy Authority of Ireland (SEAI) are participating in the Clean Energy Transition Partnership (CETP), supporting Irish researchers to develop and strengthen transnational collaborations and accelerate the energy transition towards achieving the EU's goal of becoming the first climate-neutral continent by 2050.

CETP is a European Partnership co-funded by the European Commission under Horizon Europe, enabling regional and national funders and organisations to pool resources, leverage knowledge and experience and strategically align priorities to drive a unified response to shared challenges and to meet the ambitious objectives required to transform the energy system across all its dimensions.

A joint [Strategic Research and Innovation Agenda](#) defines specific thematic challenges – also referred to as 'Transition Initiatives' (TRIs) – to be addressed under CETP, primarily through the implementation of joint transnational calls (JTCs) for research and innovation projects.

The Joint Call 2025 includes 39 funding organisations across 34 EU Member States and Associated Countries, with a total available budget ~€80 million.

More information on the CET Partnership and the Joint Call 2025, including the call text and general eligibility requirements, are available on the [CET Partnership website](#). Details specific to applicants based in Ireland requesting funding through Research Ireland can be found below.

Awarded projects will have a duration of up to 36 months. For applicants based in Ireland, Research Ireland will provide the following funding for projects:

Up to a maximum of €330,000 direct costs* per award for Irish applicants as Partner on transnational proposals.

Up to a maximum of €405,000 direct costs* per award for Irish applicants as Coordinator on transnational proposals.

*The maximum total award, including overhead contribution, will be €405,000, for a partner and €530,000 for applicants who take on the role of coordinator.

Eligibility

Only an academic partner or coordinator based in an eligible Irish Host Research body may apply for Research Ireland funding.

Applicants must meet the primary eligibility requirements outlined in [Research Ireland's Eligible Research Bodies Policy](#) and all additional call eligibility criteria as specified on this webpage and in the [Joint Call Text 2025](#).

Please note that individuals who hold a contract of employment (whole or in-part, primary or secondary) with industry or any other private sector entity, are not deemed eligible to apply to CETP through Research Ireland. Such individuals interested in the CETP Joint Call 2025 should review the necessary criteria to apply via the other participating Irish agencies.

Additional criteria (Research Ireland)

Research Ireland will only accept one pre-proposal application per individual applicant.

Applicants can apply to both Research Ireland and other participating Irish agencies with different project proposals, if eligible under each agency's own rules. An applicant is not permitted to request funding from more than one participating Irish agency for the same pre-proposal.

If two or more Ireland-based applicants are partners on the same pre-proposal planning to carry out distinct work, funding can be requested separately by each partner to different participating agencies, adhering to each agency's own rules and requirements. Please note Research Ireland will fund only one partner per proposal.

How to Apply

If applying through Research Ireland, please give a brief notification of your intent to submit a pre-proposal by email before the submission deadline to eu-cofund@researchireland.ie.

Rethink Ireland - Children's Active Play Fund

The Children's Active Play Fund is a three-year fund aimed at supporting children and young people across Ireland get active, stay healthy, and have fun.

This €1.5 million fund is created by Rethink Ireland in partnership with the Sunflower Charitable Foundation and the Department of Rural and Community Development and the Gaeltacht via the Dormant Accounts Fund.

The fund is open to charitable organisations delivering innovative projects that encourage movement, activity and social connections, making it easier and more enjoyable for young people to lead active lives.

The fund offers a package of cash grants and non-financial supports for up to eight projects to help them expand and increase their social impact.

This includes: A multi-year cash grant worth up to between €130,000 – €210,000 (per successful project).

The non-financial supports include:

- A place on Rethink Ireland's Accelerator Programme.
- Business and capacity-building supports designed in consultation with successful projects on topics such as strategic planning, impact management, communications, and fundraising.
- Access to Rethink Ireland's networks.

Eligibility

Projects must meet both Rethink Ireland's criteria and the specific criteria for the Children's Active Play Fund, as set out below:

Rethink Ireland Core Criteria

- The project must address a critical social or environmental issue.
- The project must be innovative in an Irish context.
- The project must be based on the island of Ireland and must make its main impact in the Republic of Ireland.
- The project must have potential and a desire to scale or replicate in Ireland (it may also have potential internationally, but this is not a requirement).
- The project must provide evidence that it is up and running, or has been tested at least in a minimal way.
- Applicants must come from an entity which is a registered charity.

Children's Active Play Fund Criteria

Projects must be working innovatively to enhance physical activity, mental health, and overall well-being among children living in Ireland, including one or more of the following;

- Enhance the mental and physical health, sports, physical activity and healthy lifestyles of young people using evidence-based approaches and/or community development approaches.
- Support the reduction of health inequities faced by young people and communities by increasing educational, training, cultural, recreational, leisure, social or physical activities
- Projects that inspire children and young people through activity, play and outdoor pursuits to foster healthy habits and lifestyles, connection and community building
- Projects that recognise and address the social determinants of health that **contribute to poor mental health and well-being.**

Advantageous criteria

In addition to the core criteria, projects may receive favourable consideration for the following advantageous criteria:

- Projects that prioritise addressing health and well-being disparities among underserved youth in Ireland.
- Projects that support an intergenerational 360 Health approach aimed at ensuring the moral, intellectual, physical, emotional and social welfare of all generations.
- Projects that foster coalitions, partnerships and cross-sectoral collaborations to maximise the impact of their initiatives
- Organisations that have a positive effect on Ireland's Green Transition through their activities/interventions. This criteria applies if the organisation tackles issues related to the environment and green transition, such as carbon reduction, biodiversity, sustainable agriculture, pollution and/or the just transition.

safefood: CFI Cross Border Partnerships Funding

Safefood is inviting applications for funding for its Community Food Initiatives (CFI) Cross Border Partnerships Funding.

The Community Food Initiatives programme aims to empower people in low-income communities to make healthier food choices. It funds local projects that improve access to healthy and safe food using a community development approach. Since 2010, over 65,000 people have taken part in a Community Food Initiative activity.

The Community Food Initiatives Programme 2025-28 is funded by Safefood and administered by SECAD Partnership CLG.

Safefood is an all-island implementation body set up under the British-Irish Agreement (1999) to promote awareness and knowledge of food safety and healthy eating on the island of Ireland.

CFI Cross Border Partnerships

Four cross-border partnerships will be funded focusing on low-income areas across the island of Ireland. A total of 8 organisations will be chosen with 2 organisations (one each from Ireland and Northern Ireland) working in partnership to deliver programmes over a 4-year period.

The two organisations involved in each partnership will deliver one programme per year. The two organisations need to develop and plan the programme and all its elements in partnership. The programme will be co-designed by the participating organisations and in consultation with their local communities, to address specific local needs.

The programme will involve the delivery of a small project by each partner and must include at least one joint activity between the two organisations involved in each partnership. For example, one organisation hosts an event or initiative that includes participants from the partner organisation. These projects should take a programme approach where participants are supported over a period of time.

Your organisation must have identified a partner before an application for funding is submitted. One organisation in the partnership will act as the lead partner. This organisation will be the primary point of contact between the partners and SECAD Partnership. The application will be submitted by the lead partner.

Funding

Interested organisations may apply for funding up to €2,650 (€5,300 per partnership) or the sterling equivalent per annum.

- Up to €2,000 programme funding per organisation
- Up to €650 funding for travel per organisation

The Hospital Saturday Fund Charity

The Hospital Saturday Fund was founded in 1873, at a time when poverty, overcrowding and ill-health were prevalent and little help was available for those needing costly hospital care.

The Hospital Saturday Fund has two grant categories:

1. Standard grants of up to £2,000 or €3,000
2. Large grants to up to £10,000 or €13,500 (please note this is the maximum sum that HSF will grant).

Eligibility

The Hospital Saturday Fund will consider giving grants to registered medical health charities within the United Kingdom and Republic of Ireland. The Hospital Saturday Fund will also consider giving grants to individuals within the United Kingdom and Republic of Ireland.

For medically related charities, hospitals, hospices and medical clinics:

The Hospital Saturday Fund will consider giving grants towards medical capital projects, medical care or research and in support of medical training. The Hospital Saturday Fund will also consider grants for running costs.

Mohamed bin Zayed - Species Conservation Fund

The Fund intends to be as flexible and accommodating as possible when reviewing applications, and to take into account as many different factors as is reasonable when assessing the merit of a suggested project. To support this and to try to streamline the application process, the review process is kept comparatively simple.

However, the Fund does receive many more applications for support than grants could possibly be provided, so please find below some criteria and guidelines which would be useful to bear in mind when submitting an application.

Language: Applications must be submitted in English.

Currency: Budgets must be submitted in US Dollars.

Maximum Grant: The Fund maximum grant size is \$25,000, and any application asking for more than this from the Fund will be rejected. The total budget of a project can be higher if there are other sources of funding, but the Fund will not award more than \$25,000.

Conservation status: The Fund was established to support species conservation work, and so if your project is not about an endangered species it is probably not worth your while submitting an application.

The Fund will use the IUCN Redlist (www.iucnredlist.org) as the primary guide to the conservation status of a given species, although documented variations for sub-species, distinct populations and sub-populations will be taken into account. For those species not assessed through the IUCN Redlist we welcome other methods of assessment and the submission of quantitative data to confirm a species status. Generally the Fund gives priority to those species facing a high threat of extinction (with an emphasis on Endangered and Critically Endangered species), as well as those which are listed as Data Deficient or unlisted but are suspected as highly threatened. Please ensure that the conservation status mentioned in the application is correct and cross-referenced to a website or publication. It might be of use to consult with the relevant IUCN/SSC Specialist Group if you are in doubt or would like some guidance.

Please note that applications with clearly incorrect conservation status and no justification will NOT be considered for funding.

Content: Text provided in an application should be kept concise and clear, with clearly stated quantitative goals, aims and methods. When writing an application, please bear in mind that there is only so much text which the Advisory Board and the Fund's board of directors are capable of reading. Priority will be given to those projects that support the professional development of young conservationists.

In situ conservation: Generally the Fund is primarily interested in providing support to in situ conservation work in the field (such as survey work and data gathering, direct action, recovery management, training and the like), focusing on the species in its natural habitat. However, the importance of ex situ work (genetic analysis, workshops, ex situ populations etc) is also recognised, and so a few grants may be given to projects which focus on ex situ conservation work in certain circumstances.

Core costs: The Fund will not award a grant simply to cover the core running costs of an organisation or administrative overheads, and yet does recognise that sometimes support salaries, stipends, per diems and project related living costs are a vital part of in situ conservation work, as part of a conservation project.

Species: Generally, the Fund would prefer to support projects which focus on a single species, but it also recognises that in some geographic and taxonomic circumstances it makes more sense to group a number of species.

Grant amount: The Fund will not provide a grant of more than \$25,000.

Grants for continuation: The Fund is happy to provide continuation support for a project which had previously been supported, which is now completed and for which the Fund has received all required reporting by the time of the respective submission deadline.

External review: In some cases, the Advisory Board and/or the Fund's board of directors may ask for an application to be passed on for additional review, which may add to the response time.

Online: Only applications submitted through the Fund's online, web-based system will be considered. Supporting documents can be sent as email attachments, but the application itself must be online.

ESF+ is a combination of four funds from the 2014-2020 programming period: the European Social Fund (ESF), the Fund for European Aid to the most Deprived (FEAD), the Youth Employment Initiative (YEI) and the European Programme for [Employment and Social Innovation \(EaSI\)](#).

Aims & Objectives

The European Social Fund Plus (ESF+) aims to achieve:

- high employment levels
- fair social protection
- the eradication of poverty
- a skilled and resilient workforce
- equal access to the labour market
- fair and quality working conditions
- social protection and inclusion.

ESF+ has a particular focus on:

- quality and inclusive education and training
- lifelong learning
- investment in children and young people
- access to basic services

What does it support?

ESF+ co-funds local, regional and national employment-related projects. Its funding focuses on the following priorities:

The objective of the Priorities Fund is to raise and distribute money, on behalf of the Church of Ireland, to various worthy projects within the island of Ireland.

AREAS CURRENTLY SUPPORTED BY THE FUND:

- Training – Lay and Ordained Training in the following areas:- post-ordination, clergy in-service, lay ministry, youth ministry, children's ministry, student chaplaincy.
- Christian Education Development of RE in schools, children's ministry, youth work, adult education.
- Outreach Initiatives To encourage creative and innovative projects, which reach out to the communities our parishes serve, including church plants and missional areas.

- mission and outreach rather than maintenance
- projects and programmes rather than structures

At the present time the following categories under which applications are considered are being used but it is possible that these will change in the future. This year, there is a new category, 'Innovative Ministry in a Rural Context', to encourage the Church of Ireland in the sparsely populated areas of the country, in rural or village settings.

Revenue Grants are for Arts organisations that contribute to the realisation of the priorities and goals of Dublin City Council in a strategic way, and can act as effective advocates and promoters of the arts to the public, to partners in other agencies and public bodies. A grant of €10k is guaranteed to each successful applicant.

Any increase on €10K will only apply to an application that has excellent content, with an emphasis on diversity, social inclusion and equality of opportunity. Please note that an Applicant may apply for more than one Category but will only be eligible to receive grants from two different categories to a combined maximum of €40,000. Previous Revenue grant recipients should not presume repeated levels of grant aid.

A note on diversity:

Dublin City Council through all of its programmes wants to engage with all of the residents and visitors to Dublin. We know that some may feel excluded for physical, cultural, economic, racial, gender or other reasons and as a Local Authority we want to address this exclusion and celebrate the diversity of Dublin.

As an applicant for an Arts Grant please let us know how you address diversity whether by including and encouraging diverse practitioners or participants in your programme or through engaging with diverse audiences. The main evidence for your understanding of diversity, accessibility and inclusion will be evidenced by:

- Policy documents and implementation.
- Specific marketing to diverse audiences.
- Collaboration and inclusion of diverse practitioners and Artists. Partnership with organisations that increase your knowledge and skills in the area of diversity. As diversity is a developing area for the Arts and for Arts Grants it is not expected that you would be equally proficient in all areas but that you are aware of the importance of diversity, accessibility and inclusion and are taking concrete steps to continually learn and increase your ability.

Project Grants support arts organisations and individuals to realise public presentation of new work for the Dublin City Council administrative area.

Awards are available for a minimum of €5,000.00 to a maximum of €10,000.00 for projects taking place during 2025.

The project grant may only make up a maximum of 70% of the overall budget for the project, you will be asked to provide details of the other 30% funding.

Terms & Conditions

- The public presentation, or parts thereof, of your application must take place in the Dublin City Council Administrative Area. [Click here for Map](#)
- The company, artist or team shall ensure that there is compliance with all statutory requirements and local authority bye laws including adherence to Child Protection Policy.
- Recipients of grants of €5,000 or more will have to comply with the 5 key principles of the Governance Code for Community, Voluntary and Charitable organisations. For an outline of the 5 key principles see [governancecode.ie](https://www.governancecode.ie)
- Recipients of grants of €10,000 or more will have to supply a current tax clearance certificate or tax clearance access number prior to first instalment and for subsequent payments of the Arts Grant.
- Dublin City Council is subject to provisions of the Freedom of Information Act (FOI) 1997, 2003. If you consider that any information supplied by you is either commercially sensitive or confidential in nature, this should be highlighted and the reasons for sensitivity specified. In such cases, the relevant material will, in response to an FOI request, be examined in the light of the exemptions provided for in the Acts.

Dublin City Council - Neighbourhood / Voluntary Arts Grants

The Neighbourhood Grants Scheme aims to support local arts activity within the Dublin City Council administrative area. Dublin City Council want artists and local communities to have opportunities to work closely together, including through long-term developmental projects and short-term interactions in the context of local events and festivals. Through the Neighbourhood Grant artists and communities are invited to propose projects that engage in collaborative activities benefitting local communities and neighbourhoods.

You can apply for a minimum of €2,000 up to a maximum of €10,000.

Specific groups should be identified to ensure both socially inclusive and culturally diverse interests are addressed by the grant.

Strand 1 –the Neighbourhood Grants Scheme will support the presentation of artistic work across all disciplines in the local context i.e. supporting presentation by artists at festivals, events and local venues such as plays, concerts, outdoor events, exhibitions etc

Strand 2 – In Strand 2, the Neighbourhood Grants will support arts projects or programmes that begin with residents or community groups interested in the arts or with artists interested in working with neighbourhoods or community groups. All projects must have strong collaboration between artists and participants. Both artist and participating group need to be shown to be involved in the application. Community groups can include communities of place, practice or interest.

Funding will also be available under the Voluntary Grant strand: Voluntary grants support arts programmes or projects by voluntary organisations or groups engaging professional artists that significantly advance the artistic ambition of the organisation or groups activities. Voluntary grants are suitable for organisations engaging a professional artist for a series of workshops, once off engagements or other collaborative activities.

Culture Ireland Grants

Culture Ireland operates a range of funding programmes to support and promote the presentation of Irish arts internationally. The current initiatives include a Regular grants round, the See Here scheme, Delegate Scheme and a Showcase programme.

Regular Grant Scheme

Culture Ireland offers support to Irish professional artists, arts organisations and international presenters to present work by Irish artists at significant international venues and festivals.

In supporting an event, Culture Ireland traditionally offers grant funding towards costs which relate directly to the international presentation of the event, i.e. travel and travel related costs such as transport, freight, accommodation and subsistence. In order for an application to be considered, the applicant must have an international partner or be an international presenter who will provide a fee to the artist and assist with promotion and presentation costs.

There will be four grant rounds in 2025 covering all windows of activity throughout the year. Based on feedback, we are also extending the activity timeline for each round – full details below – please check that your project is eligible prior to submission.

Showcase Scheme

The Showcase Scheme has as its primary aim, the creation of new opportunities for Irish artists to present their work on the global stage.

This aim is achieved through the support of Irish artists to participate at industry showcase events. Where possible as part of their participation. Culture Ireland facilitates artists to present their work to international delegates, including programmers and presenters.

The strategic priorities for the Showcase Scheme are:

- To ensure ongoing contact between Irish artists and key international presenters/programmers
- To increase awareness and interest by the international sector of recent and new work by Irish artists with a view to future collaboration/partnership/presentation
- To provide mentorship for artists with specific reference to presentation of their work in the international environment

- To promote high quality digital recordings/promotional materials to showcase Irish artists.

Music from Ireland is a programme, delivered in partnership with First Music Contact to showcase [Irish music internationally](#).

Culture Ireland leads Irish delegations to events such as WOMEX World Music Expo, Classical: NEXT and Folk Alliance International and partners with national resource organisations in the delivery of many of the other Showcases as listed below.

Applications to form part of the Culture Ireland delegations are usually made by open call and must be made online.

See Here Scheme

The See Here Scheme is specifically designed to support direct engagement by international promoters and programmers with Irish artists' work in Ireland a view to securing future presentation opportunities abroad.

Culture Ireland support under the See Here Scheme usually involves travel by international delegates to attend festivals where there is a programme of Irish artists being presented and meet artists in person in Ireland. Currently, given travel restrictions these engagements take place digitally and involve a combination of pre-recorded performances and live engagement.

Priority is given to attendance at events where the international delegates will see a range of work by Irish artists and to delegates connected with venues or festivals which have an interest in programming international artists.

New European Bauhaus (NEB) is a policy and funding initiative that makes green transition in built environments and beyond enjoyable, attractive and convenient for all. Even the smallest communities on the ground deserve living spaces that improve their well-being and sense of belonging. The initiative promotes solutions that are not only sustainable, but also inclusive and beautiful, while respecting the diversity of places, traditions, and cultures in Europe and beyond.

The New European Bauhaus works by:

- engaging people at a grassroots level, focusing on neighbourhoods
- providing tools and guidance
- offering tailor-made solutions for different communities
- incorporating the views of various stakeholders into the process of design and implementation
- prioritising people and social inclusion but also the economy to boost competitiveness and EU strategic autonomy.

There are two types of community membership open for you to join: Partners and Friends. Those calls of the New European Bauhaus are permanently open.

Partners are organisations (any entity except for-profit organisations and public authorities can apply) with a significant outreach capacity who are trusted members of their communities. Their core activities address one or more dimensions of the New European Bauhaus.

Friends of the New European Bauhaus are for-profits and public authorities, who are willing to provide some form of support to the projects. Cities, Regions and Businesses are ideal candidates.

All NEB community members promote the core values of the European Union: human rights: freedom, democracy, equality and rule of law. Finally, they support the priorities of the European Union.
