4. Start date of CBL advertisement is 03 OCT 2025 AND ENDS 10<sup>TH</sup> OCT 2025 at 5pm.
5. If a number of applicants apply for the same property, the final offer will be made to the applicant with the highest position on list.
6. All applications will be examined on estate management grounds including rent arrears.
