Reasons for requesting your personal information

- Your information is required in order to process your application for a Casual Trading Licence for Smithfield Horse Fair.
- Your information is collected to process requests for a Casual Trading Licence for Smithfield Horse fair. The legal basis is provided for under the Casual Trading Act 1995 and the Smithfield Horse Fair Control Bye Laws 2013.
- If your application is successful it may be necessary to share your information with the statutory bodies i.e. An Garda Síochána, Revenue Commissioners, Minister for Social Welfare.
- If the licence is granted the information supplied by you will be kept securely for a period of up to seven years.
- If you do not provide the personal data required under the Casual Trading Act 1995 and the Smithfield Horse Fair Bye laws, Dublin City Council will not be in a position to process your application.
