### **Boardwalk**

As reported by Gardaí to the last meeting, special attention is being given to incidences of public drinking, drug-taking and begging on the boardwalk. This is a particularly welcome development and a recent inspection of the boardwalk by me showed no such activity between the campshires from the Jeanie Johnston to Capel Street Bridge. The effect of the Garda operation is acknowledged and appreciated.

**Report of Assistant Commissioner Michael Feehan, Dublin Metropolitan Region**

At this second meeting of the Joint Policing Committee for 2011 I intend to concentrate on the developments in the first two months of 2011, developments regarding St. Patrick's Festival, Begging and I will briefly comment on the crime and traffic statistics for 2011.

**Crime**

For the first two months of 2011 overall Property Crime has increased. However, Burglaries and Robberies from the person have shown a decreasing trend for the last three months.

In particular during the month of February 2011 we have had a number of successful operations in identifying and bringing before the courts a number of prolific Burglars.

The initiatives across the city to target organised and armed crime are continuing. These initiatives are intelligence driven and continue to be seen locally as having an effect on the activities of persons involved in organised crime. This continues to be a priority for An Garda Síochána right across the city.

In addition to the policing operations in place I have also been rolling out Garda Youth Case Management within the D.M.R during 2010. For those of you who are not familiar with the process, Garda Youth Crime Case Management is a co-coordinated and consistent management process which places one Garda as a Case Manager for each individual young person who is charged and before the courts. The appointed Garda is responsible for leading, coordinating and managing the young person's charges.

The main objective is to assist in the co-ordination of appropriate interventions and services necessary to meet the needs of these children, with a view to engineering them out of the criminal justice system. This process is an integral part of our overall crime management structure within the D.M.R. and has resulted in very significant reductions in recidivism amongst the initial group of offenders being managed.

**Traffic**

The number of people killed on the roads for the first two months is 5, this compares to 3 deaths for 2010. I am aware of the effect each death has on the families and I have requested my Regional Traffic Chief Superintendent to carry out a review of each collision to determine if there were any common factors associated with the fatalities. In addition I have also directed each of my Chief Superintendents to re-visit their Divisional Causality Reduction Plan with a view to maximising its effectiveness.

### **Upcoming Events**

At the time of writing this report plans are in place for the policing of St. Patrick's Day Festival, Europa Cup Final and the Carling League.

Throughout the Region plans are in place to ensure that there are sufficient resources deployed in the city centre and the suburbs to avoid disturbances and anti-social behaviour for all events.

In regard to the St. Patrick's Day Parade, the Superintendents in the city have communicated with each Off Licence within the City Centre as with previous years requesting their support to keep their premises closed until 4pm. Meetings have also taken place with Dublin City Council regarding their cooperation with the policing of the event. On the day liaison officers are in place between both organisations to coordinate the removal of bottles or any other potentially harmful objects

### **Criminal Justice (Public Order) Act 2011(Begging)**

The Criminal Justice (Public Order) Act, 2011 became law on the 2nd February 2011. In summary, under this new legislation, a person who begs in an aggressive, intimidating or threatening manner will be guilty of an offence. New powers enable An Garda Síochána to direct anyone begging near ATMs, night safes, shop entrances, etc. to leave the area.

The Act creates new offences for begging when accompanied by harassment, intimidation, assault, threats to any person or the obstruction of the passage of persons or vehicles.

It also creates offences of organising and directing begging and of living off the proceeds, which carry penalties of up to five years imprisonment or a fine of €200,000 or both.

Arising from this new legislation I directed that operations were to be put in place to address the begging problem across the city. That operation has involved Gardaí directing people to desist from begging and in making arrests in appropriate cases. Significant cautions and arrests have taken place to date and reports from the community have indicated that the level of begging has reduced considerably. The operation will continue for the foreseeable future.
